Ordering shall be done after de-loading the commercial/ technical loading from bidder's final price.
22. In the course of evaluation, if more than one bidder happens to occupy L-1 status, effective L-1 will be decided by soliciting discounts from the respective L-1 bidders. In case more than one bidder happens to occupy the L-1 status even after soliciting discounts, the L-1 bidder shall be decided by a toss/draw of lots, in the presence of the respective L-1 bidder (s) or their representative(s). Ranking will be done accordingly. BHEL's decision in such situations shall be final & binding.
23. Terms & Conditions:- The terms & conditions shall be as per enclosed special conditions of the contract (copy enclosed), GCC Rev 07 which is available on www.bhelpem.com and other Terms and Conditions included in this Enquiry Letter.
24. BGs should be in favour of BHEL-PSSR in place of PEM. L1 Vendor will be required to submit BGs as per GCC Rev-07.
25. Bidders who fulfil Technical & Financial Pre-Qualification Requirement Criteria are eligible to participate in this tender. Bids of only those bidders shall be evaluated who meet the Technical as well as Financial Pre-Qualifying requirements.
26. "BHEL shall be resorting to Reverse Auction (RA) (Guidelines as available on www.bhel.com) for this tender. RA shall be conducted among all the techno-commercially qualified bidders. Price bids of all techno-commercially qualified bidders shall be opened and same shall be considered as initial bids of bidders in RA. In case any bidder(s) does not participate in online Reverse Auction, their sealed envelope price bid along with applicable loading, if any, shall be considered for ranking." Note - Vendors to note that above RA clause will supersede clause no 13 of "Instruction to Bidders" of GCC Rev 07
27. Regarding verification of PQR documents- Bidders to ensure that Third party/customer issued certificates being submitted as proof of PQR qualification should have verifiable details of document/certificate issuing authority such as name & designation of Issuing Authority and its organization contact number and e-mail Id etc. In case the same found not available, Purchaser has right to reject such document from evaluation.
28. Bidder to note that this is an Open Tender enquiry & RA participation shall be subject to following condition: - Qualifying Technical & Financial Pre-Qualification Requirement. - Techno-commercial acceptance of offer by BHEL-PEM. - Approval of bidder by End Customer: - Same shall be taken up with end customer based on the latest credentials/reference list furnished by bidder. Accordingly, bidders are requested to submit credential as per the format enclosed herewith along with their technical bid. The bidders who are not registered with BHEL-PEM may apply for registration in BHEL-PEM through Registration Portal available at www.bhelpem.com-->vendor section-->online supplier registration. All credentials and/or documents duly signed & stamped related to registration has to be uploaded on the website & submit the application for registration. One set of hard copy filled-up SRF downloaded from Online Registration Portal duly signed & stamped has to be submitted.
29. All corrigenda, addenda, amendments, time extensions, clarifications, etc. to the tender will be hosted on BHEL website (www.bhel.com), https://bhel.abcprocure.com & BHEL-PEM website (www.bhelpem.com). Bidders should regularly visit websites to keep themselves updated.
30. If bidder mentions Not Applicable / Not required / Not Quoted in BHEL price format, the same to be substantiated by the bidder. If such item is required to be supplied for system completion in future, same will be supplied free of cost.

33. Over all (%) quantity variation: The variation on overall package value due to changes in the scope shall be limited to +/-10% in place of 30% mentioned in clause no 6.0 of GCC-REV-07.

34. Insurance Policy of this project is not available. However, Deductibles / EXCESS shall be as below .

A) For Marine Cover: Rs 20,000/-

B) For Storage/ Erection and Testing Cover:

i) Other Items (BOP ITEMS):

➤ Rs 2,25,000/- or 5% of the claim amount whichever is higher for Normal Period.

➤ Rs 6,00,000/- or 5% of the claim amount whichever is higher for Testing Period.

ii) **Act of God (AOG) Perils:** 10% of the claim amount subject to minimum of testing period excess with an upper limit of Rs 5 Crores per event.

iii) **Fire / Explosion Claims:** Rs 6,00,000/- or 20% of the claim amount whichever is higher.

iv) **Third Party Liability Cover:** (a)-The policy excesses (Normal/ Testing periods) shall apply for third party liability property damage claims also.

(b) For third party liability claims arising out of Acts of God perils, the excess applicable to AOG claims shall apply.

Further, changes, if any in deductible/ excess, w.r.t actual insurance policy for 5x800 MW Yadadri project shall be informed to the bidders and any financial implication because of change in deductible/Excess shall not be absorbed by BHEL.

35. Construction Power, Construction Water & Storage Space shall be as per project SCC

36. Bidder to quote freight charges in percentage (%) of their quoted Total Ex-Works prices of supply portion.

37. GST shall be payable extra at actual as per the HSN code finalised for the items during detailed BBU.

38. In line with clause no 26 of (ITB) GCC-REV-07, this package is not divisible in nature and minimum local content requirement is 100%. Bidders at the time of tender, bidding or solicitation are required to provide the following certificate along with the part-1 bid:

(i) Provide a self-certification (in line with attached draft) giving the percentage of local content.

(ii) Provide the details of the location(s) at which the local value addition shall be made.

39. This item/Package falls under the list of items defined in Para 3 of Ministry guideline ref no.F.20/2/214-PPD(Pt.) dated.20-09-2016 (in respect of procurement of items related to public safety, health, critical security operations and equipment's, etc) & hence no relaxation of PQR for start-up/MSME vendors is envisaged for the NIT items/Package"

Bidders to contact BHEL-PEM (over phone/mail/visit-BHEL-PEM) for any clarification (technical or commercial) at least 10 days before due date of tender opening & get it clarified well before due date so that offers by the bidders may be submitted within due date & time. Depending on the pre-bid queries received, pre-bid conference shall be organized for resolution of the queries.
42. All the above terms and conditions, post-bid agreements/MoMs (during Techno- Commercial evaluation) shall automatically become a part of the Order/Contract after its finalisation.
43. Bidders to note that offers shall be submitted strictly in accordance with the requirements of tender documents. Bidders shall upload their complete offer meeting the requirements of the tender documents on e-procurement portal https://bhel.abcprocure.com . Following documents need to be uploaded: • Offer forwarding/ covering letter • Local content certificate in line with Make in India circular • Credentials as per format • Documents required for meeting Technical & Financial PQRs • Un-price bid, annexure-II (Cost of Withdrawal of Deviation) and Price bid in e-procurement portal.
