35. Bidder to quote freight charges in percentage of their quoted Total Ex-Works prices of Supply & Mandatory spares.

36. GST shall be payable extra at actual as per the HSN code finalised for the items during detailed BBU.

37. In line with clause no 26 of (ITB) GCC-REV-07, this package is not divisible in nature and minimum local content requirement is 100%. Bidders at the time of tender, bidding or solicitation are required to provide the following certificate along with the part-1 bid:

- (ii) Provide the details of the location(s) at which the local value addition shall be made.
