Vendor's scope

1. Inspection, Testing, Certification of Lifting Tackles as per Section 29 of the Factories Act- 1948 and Rule- 55A of UP Factories Rules-1950
2. Checking of conditions of various Lifting Tackles.
3. Submission certificates duly signed and stamped by Competent Person
4. Submission of detailed report for all the Lifting Tackles duly signed and witnessed by respective departments.
5. Submission of certificates duly signed and stamped by Competent Person shall be done within 45 days from the date of Work Order.

BHEL's scope

1. Arranging entry of the vendor and vendor's allied manpower for the period of testing and Certification (Vendor shall have to comply with all the applicable labour laws, safety rules etc.)
2. Facilitation of Lifting Tackles and other minor material (including measuring tape etc.) subject to availability
3. The total time period for completion of the process of the load testing shall be 1 month.
