1. Pre-Qualification Criteria

1.1 The experience of having successfully completed or currently executing (i.e. bidder should have achieved the criteria specified below even if the total contract has not been completed /closed) similar job/services during last 7 years ending on **30 April' 2020** should be either of the following:

a) Three separate work orders of average annual value not less than **₹ 1.21 Lakhs** (excl. GST).

OR

b) Two separate work orders of average annual value not less than **₹ 1.51 Lakhs** (excl. GST).

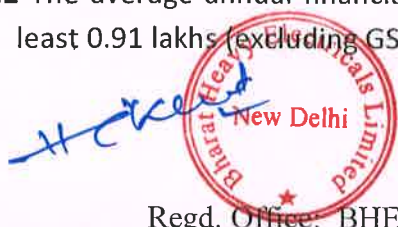

c) Single work order of average annual value not less than **₹ 2.42 Lakhs** (excl. GST).

The term 'similar jobs/services' mentioned in **Clause 1.1 (a,b & c)** shall be related/refer to 'jobs/services' of Washing/Dry-cleaning of clothes , fabrics in Hotels/Guest houses/Transit flats etc. with any Central Govt. or State Govt. or PSU or Public Limited Company or Private Limited company.

1.3 The bidder shall submit EMD amount of ₹ 12,110/-

MSEs shall be exempted from payment of EMD, provided a certificate of being MSE is enclosed by the party along with Part-I bid. Start-ups as recognized by Department of Industrial Policy & Promotion are also exempted from payment of EMD, provided a recognition certificate valid up to bid closing date is submitted. However, there is no exemption in submission of Security Deposit.

1.4 The bidders must have PAN. [Copy of PAN card duly signed and stamped to be submitted]. Bidders having GSTIN should submit a copy of their GST registration certificate duly signed and stamped along with Part-1 bid.

2. GENERAL TERMS & CONDITIONS OF TENDER:

2.1 The tender enquiry No. & due date must be legibly super scribed on the envelope.

2.2 Tenders shall be received and opened at BHEL House, Siri Fort, New Delhi on the due date and time as mentioned above in the presence of finance representative and bidders or their authorized representatives who may like to be present.

2.3 The complete tender enquiry must be signed and stamped on each page by bidder. Tenders shall be strictly in accordance with the tender specifications. Any deviation may lead to rejection of tender.

2.4 Bidders have to duly sign and stamp 'Acceptance Letter/ Deviation certificate' as provided with tender documents as Annexure. The same has to be submitted with Part-1 bid

2.5 Bidders must submit a copy of tender document duly stamped and signed on each page of tender document and mentioning 'Q' against each item of Un-price bid provided with the tender document as Annexure. Un-price bid has to be submitted with Part-1 bid.

2.6 BHEL reserves the right to protect its interest against any loss on account of availability of GST credit.

2.7 GSTIN of BHEL will be provided to the contractor along with the work order.

2.8 Any new/change in statutory levy as and when made applicable by the government shall become applicable against documentary evidence.

2.9 Applicable GST shall be recoverable from the contractor in case of LD recovery/ Penalty on account of breach of terms of contract.

- 2.10** The offers shall remain valid for 90 days' period from the date of opening of Part-I Bid & 60 days from the date of RA/Price Bid opening, whichever is later.
- 2.11** BHEL shall be under no obligation to accept the lowest or any other tender and shall be entitled to accept or reject any tender in part or full without assigning any reason whatsoever.
- 2.12** BHEL reserves the right to accept/reject any offer.
- 2.13** Rates shall remain firm for the entire duration of contract.
- 2.14** BHEL reserves the right to increase/decrease the quantity by 30% of original quantity at the same rate and terms and conditions of this contract.
- 2.15** All tools and tackles required for work shall have to be provided by the bidder at no extra cost.
- 2.16** Any damage due to mishandling by person deputed by the bidder shall have to be restored back to its original condition by the bidder at their own cost.
- 2.17** Tenders received after due date & time are liable to be rejected.
- 2.18** Tender should be submitted along with covering letter of the bidder and each page of the tender document must be stamped and duly signed by bidder. Bidder has to strictly submit the tender in accordance with the clause no. 26 of this tender i.e. **"Procedure for submission of sealed tender"**
- 2.19** Price quoted by the bidder will be firm and no escalation on account of labour, material or any other reason whatsoever will be paid to the successful bidder for execution of the above work. However, any change in taxes during the currency of contract will automatically be from the part of contract.
- 2.20** Tender submitted by a techno commercially qualified bidder shall become the property of BHEL who shall be under no obligation to return the same to the bidder. However unopened price bids and late tenders shall be returned to the bidders.
- 2.21** BHEL shall not be liable for any expenses incurred by the bidder in the preparation of the tender irrespective of whether the tender is accepted or not.
- 2.22** Bid should be free from correction, overwriting, using corrective fluid etc. Any interlineation, cutting, erasure or overwriting shall be valid only if they are attested under full signature(s) of person(s) signing the bid. All overwriting/ cutting etc. will be numbered by bid opening officials and announced during bid opening.
- 2.23** In case any typing error/other clerical error in the tender document is noticed by the bidder, the same shall be pointed out & got clarified before submission of offer, or else BHEL's interpretation shall prevail & shall be binding on the bidder(s).

2.24 Lowest prices/service charge received against Tender need not be the acceptable to BHEL and in that case BHEL would not consider the same for award of Contract. BHEL would negotiate or re-float the Tender opened if L1 price is not the lowest acceptable price to them inter-alia other reasons. In the event of the final L1 prices are not reasonable / acceptable to BHEL, BHEL also may resort retender.

2.25 Post techno-commercial evaluation of the bidders, BHEL may either opt for holding Reverse Auction or open the submitted Price Bids (Part-II Bids). For this, BHEL decision shall be final & binding

2.26 The offers of the bidders who are on the banned list and also the offers of the bidders, who engage the services of the banned firms, shall be rejected. The list of banned firms is available on BHEL website www.bhel.com.

2.27 CORRECTION OF ARITHMETIC ERRORS: Provided that the bid is substantially responsive, BHEL shall correct arithmetical errors on the following basis:

2.27.1 If there is a discrepancy between the unit price and the total price that is obtained by multiplying the unit price and quantity, the unit price shall prevail and the total price shall be corrected, unless in the opinion of the BHEL there is an obvious misplacement of the decimal point in the unit price, in which case the total price as quoted shall govern and the unit price shall be corrected.

2.27.2 If there is an error in a total corresponding to the addition or subtraction of subtotals, the subtotals shall prevail and the total shall be corrected.

2.27.3 If there is a discrepancy between words and figures, the amount in words shall prevail, unless the amount expressed in words is related to an arithmetic error, in which case the amount in figures shall prevail subject to 2.27.1 & 2.27.2 above.

2.27.4 If any bidder does not accept the correction of errors, their bids will be disqualified.

2.28 EMD: Each bidder, participating in the tender has to deposit the requisite amount of **EMD** in any of the following forms:

iv) Fixed Deposit Receipt (FDR) ISSUED BY Scheduled banks /Public Financial Institutions as defined in the Companies Act (FDR should be in the name of the contractor, a/c BHEL)

2.28.1 EMD by bidder will be forfeited, if:

- i) After opening the tender and within the offer validity period, the tenderer revokes his tender or makes any modification in his tender which is not acceptable to BHEL.
- ii) The contractor fails to deposit the required security deposit or commence the work within the period as per LOI / Contract.

iii) EMD by the tenderer shall be withheld in case any action on the tenderer is envisaged under the provisions of extant "guidelines on suspension of business dealing with suppliers/Contractors" and forfeited/released based on the action as determined under these guidelines.

2.28.2 EMD given by all unsuccessful bidders shall be refunded normally within fifteen days from award of work.

2.28.3 EMD shall not carry any interest.

2.28.4 Each tender shall be accompanied by separate envelope carrying EMD as mentioned above failing which the tender will be rejected.

2.29 Unsolicited discount received after the due date and time of Bid Submission shall not be considered for evaluation.

2.30 The tender schedule and the tender shall be deemed to form an integral part of the contract to be entered into for this work.

3. PAYMENT TERMS:

3.1) Bill (on monthly basis) complete in all respect along with all the requisite documents submitted by the contractor to BHEL will be paid within 30 days of its receipt and final acceptance of BHEL.

3.2) The 100% payment would be made on the basis of actual number of services provided by the contractor during the month.

3.3) The contractor will have to intimate the bank account number, and other details of the bank to enable BHEL to credit the payments into the account.

3.4) No interest shall be payable for delay in making the payment. The contractor shall not be entitled to any interest with respect to any money which may be due to him from BHEL.

4. EVALUATION CRITERIA:

Papers submitted in Part-I (Techno-commercial) envelop will be scrutinized first. Those who qualified in Part-I bid shall be eligible to perform in Part II bid. The date of opening of Part-II (Price Bid) shall be informed later on. There will not be item-wise evaluation. The L1 bidder will be decided on the basis of overall L1 of the price bid, excluding GST (Annexure-B). In the event of more than one bidder having identical lowest amount or there is a tie amongst the bidders, the respective bidders would be asked to submit their revised rates. If it is again a tie, lottery/toss method shall be adopted for deciding L1.

BHEL may finalize the contract by conducting **Reverse Auction (RA)**, that shall be conducted with minimum three for Techno-Commercially qualified/acceptable bidders post evaluation of Part-1 bids submitted before/on due date / time of submission. Start price shall be lower of estimate or L1 of e-bid/sealed envelope price bid. Removal of H1 only if, there are more than four Techno-Commercially qualified bidders. No H1 removal if H1 happens to be MSE or qualifying PPP-MII, order-2017. In case of multiple H1s, all H1 bidders (excluding MSEs and bidders qualifying PPP-MII order 2017) shall be removed. If minimum three bidders remain in fray, there shall be no H1 removal.

5. VALDITY OF CONTRACT:

5.1 This contract will be valid initially for two years from the date of award of work. However, BHEL reserves the right to terminate the contract at any time in-between without assigning any reason, for which the supplier will not have any claim whatsoever. The rate contract may be further extended on mutual agreement basis.

6. TAXES & DUTIES:

6.1 To enable BHEL to avail GST Input tax credit, contractor shall submit GST compliant Tax invoice (if applicable) containing all the particulars as stipulated under Invoice Rules of GST Law. Payment shall be made to the contractor only after submission of GST compliant Tax invoice (if applicable). The successful bidder shall raise GST compliant invoice (if applicable) affixing GSTIN of BHEL's unit availing the services.

6.2 Payment to the contractor will be subjected to TDS as per rules in force from time to time. The Tax Deduction at Source (TDS) shall be done as per the provisions of Income Tax Act & GST (if applicable), as amended from time to time and a certificate to this effect shall be provided to the contractor by BHEL.

7. SECURITY DEPOSIT:

7.1) Security Deposit means the security provided by the Contractor towards fulfilment of any obligations in terms of the provisions of the contract. The total amount of Security Deposit will be 5% of the total contract value. Upon acceptance of tender, the successful bidder must submit the security deposit in any of the following forms:

- i) Cash (as permissible under the extant Income Tax Act)
- ii) Local cheque of Scheduled Banks (subject to realization)/ Pay Order/ Demand Draft/ Electronic Fund Transfer in favour of BHEL
- iii) Bank Guarantee from Scheduled Banks/ Public Financial Institutions as defined in the Companies Act. *{Copy of proper prescribed format of BG will be provided by BHEL along with Work Order/LOI and it will be verified verbatim on receipt with original document}.*
- iv) Fixed Deposit Receipt issued by Scheduled Banks/ Public Financial Institutions as defined in the Companies Act (FDR should be in the name of the Contractor, a/c BHEL)
- v) Securities available from Indian Post offices such as National Savings Certificates, Kisan Vikas Patras etc. (held in the name of Contractor furnishing the security and duly endorsed/ hypothecated/ pledged, as applicable, in favour of BHEL)

7.2) The security deposit shall not carry any interest.

7.3) EMD of successful bidder shall be converted into security deposit.

7.4) The validity of Bank Guarantees towards Security Deposit shall be initially up to the completion period as stipulated in the Letter of Intent/ Award + 6 months, and the same shall be kept valid by proper renewal till the acceptance of Final Bills of the Contractor, by BHEL.

7.5) BHEL reserves the right of forfeiture of Security Deposit in addition to other claims and penalties in the event of the Contractor's failure to fulfill any of the contractual obligations or in the event of termination of contract as per terms and conditions of contract. BHEL reserves the right to set off the Security Deposit against any claims of other contracts with BHEL.

8. RETURN OF SECURITY DEPOSIT:

Security Deposit shall be refunded/ Bank Guarantee(s) released to the Contractor upon fulfilment of all contractual/ statutory obligations of the contract, after deducting all expenses / other amounts due to BHEL under the contract / other contracts entered into with them by BHEL.

9. BANK GUARANTEES:

- 9.3) It is the responsibility of the bidder to get the Bank Guarantees revalidated /extended for the required period, as per the advice of BHEL. BHEL shall not be liable for issue of any reminders regarding expiry of the Bank Guarantees.
- 9.4) In case the Bank Guarantees are not extended before the expiry date, BHEL reserves the right to invoke the same by informing the concerned Bank in writing, without any advance notice/communication to the concerned bidder.
- 9.5) Bidders to note that any corrections to Bank Guarantees shall be done by the issuing Bank, only through an amendment in an appropriate non-judicial stamp paper.
- 9.6) The Original Bank Guarantee shall be sent directly by the Bank to BHEL under Registered Post (Acknowledgement Due), addressed to the LOI/LOA issuing department.

10. REJECTION OF TENDER

- 10.1) BHEL reserve the right to cancel the tender or reject the lowest or any tender or accept any tender in full or in part without assigning any reasons whatsoever at any stage.
- 10.2) BHEL reserves the right to accept or reject any of the bid / all bids with or without deviation or cancel / withdraw the invitation for bid without assigning any reason whatsoever and in such case bidder shall have no claim arising out of such action by BHEL. The acceptance of tender will rest with BHEL which does not bind itself to accept the lowest tender or any tender.
- 10.3) Conditional tenders, unsolicited tenders, tenders which are incomplete or not in the form specified or defective or have been materially altered or not in accordance with the tender conditions, specifications etc., are liable to be rejected.
- 10.4) Tenders are liable to be rejected in case of unsatisfactory performance of the tenderer with BHEL, or tenderer under suspension (hold/banning /delisted) by any Unit / Region / Division of BHEL or tenderers who do not comply with the latest guidelines of Ministry/Commissions of Govt. of India.
- 10.5) If a bidder who is a proprietor expires after the submission of his tender or after the acceptance of his tender, BHEL may at their discretion, cancel such tender. If a partner of a firm expires after the submission of tender or after the acceptance of the tender, BHEL may then cancel such tender at their discretion, unless the firm retains its character.

- 10.7) If the tenderer deliberately gives wrong information in his tender, BHEL reserves the right to reject such tender at any stage or to cancel the contract if awarded and forfeit the Earnest Money/Security Deposit/any other money due.
- 10.8) Canvassing in any form in connection with the tenders submitted by the Tenderer shall make his offer liable to rejection.

23.2 LD/PENALTY FOR DELAY & QUALITY:

23.2.1 The successful bidder shall collect the clothes from the individual seats in our office on the last working day of the week and return the same after proper washing / dry cleaning on first working day of the week. 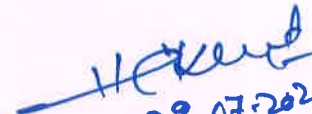
