1. COMMERCIAL TERMS AND CONDITIONS

- 1.1 Price:** Price should be quoted for supply of material in full quantity.
- 1.2 Price variation clause:** Price offered should remain firm till the supply of material.
- 1.3 Validity:** Your offer should be valid for a period of 90 days from the date of opening of the Techno-Commercial Bid.
- 1.4 Completion Required:** Completion of all test within **8 Weeks** from the date of issue of PO/ handling over the site whichever is later. All required manpower, tools & tackles/ instruments are in bidder's scope. BHEL shall only provide free power supply.
- 1.5 Work Place:** At BHEL, EMRP, MIDC, Andheri (E), Mumbai-400 093.
- 1.6 L D Clause:** LD @ 0.5%per week shall be deducted from the bill subject to maximum of 10 % of the basic price, if the job is not completed within the stipulated period (**8 Weeks**) mutually agreed by BHEL official & vendor.
- 1.7 Packing & Forwarding:** Vendor's Scope.
- 1.8 Payment Terms:** Payment Terms is 90 Days after successful completion & submission of Test Reports.
- Payment will be made through e-payment only. Vendor shall submit bank details if not submitted earlier.
- 1.9 Transportation:** Vendor's Scope.
- 1.10 Taxes & Duties:** The quoted price shall be exclusive of GST as may be applicable on date of submission of offer. However if any new taxes & duties are introduced or any variation occurred in existing rate of GST subsequent to bid submission and during the currency of the execution of the order including its extension if any, the same shall be reimbursed at actual against documentary evidence to be submitted by the vendor. In case the delivery schedule is extended for the reasons attributable to the Vendor, no such variation shall be admissible.
- Successful vendor has to file their GST return by the statutory date. In case, any purchase of BHEL is not appearing in the return of the vendor and/or if any loss incurred by BHEL due to non-compliance / delay in compliance by the vendor as per GST Act, BHEL reserves the right to recover the money including penalty if any or retain payment of the vendor till all compliances are made.
- 1.11 Transit Insurance:** By vendor.

- 1.12 Inspection:** Material will be inspected at BHEL works.
- 1.13 Non-Disclosure Agreement:** All drawings and technical documents relating to the product or its manufacture submitted by one party to the other, prior or subsequent to the formation of contract, shall remain property of the submitting party. Drawing, technical documents or other technical information received by one party, shall not without the consent of the other party, be used for any other purpose than that, for which they were provided, such technical information shall not without the consent of the submitting party, otherwise be used or copied, reproduced, transmitted or communicated to a third party. Patterns supplied by BHEL will remain BHEL's property which shall be returned by the bidder on demand to BHEL. Bidder shall in no way share or use such intellectual property of BHEL to promote his own business with others. BHEL reserves the right to claim damages from the bidder, or take appropriate penal action as deemed fit against the bidder, for any infringement of the provisions contained herein.
- 1.14 Risk Purchase:** If the material is not supplied/services not provided within the agreed delivery period, BHEL reserves the right to cancel the order and purchase the material / hire the services from alternate source(s) at the Risk and Cost of the Seller. In such an event, it shall be obligatory on the part of seller to make good any loss suffered by the purchaser.
- 1.15 Force Majeure:** The supplier shall not be considered in default if delay occurs due to causes beyond their control such as Acts of God, Natural Calamities, Frost, Fire, flood, Civil War, Civil Commotion, Riot, Government Restrictions.

Only those causes that have duration of more than seven days shall be considered cause of force majeure. Notification to this effect duly certifies by local chamber of commerce/statutory authorities with supporting documents shall be given by the supplier to BHEL by registered letter/courier service without loss of time.

In the event of delay due to such causes the delivery schedule shall be extended for a length of time equal to the period of Force Majeure or at the option of BHEL the order may be cancelled. Such cancellation would be without any liability whatsoever on the part of BHEL.

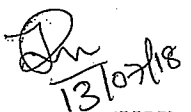
In the event of such cancellation the supplier shall refund any amount advanced or paid to the supplier by BHEL and deliver back any material issued to him by BHEL and release facilities, if any provided by BHEL.

2 PROCEDURE FOR SUBMISSION OF TENDER

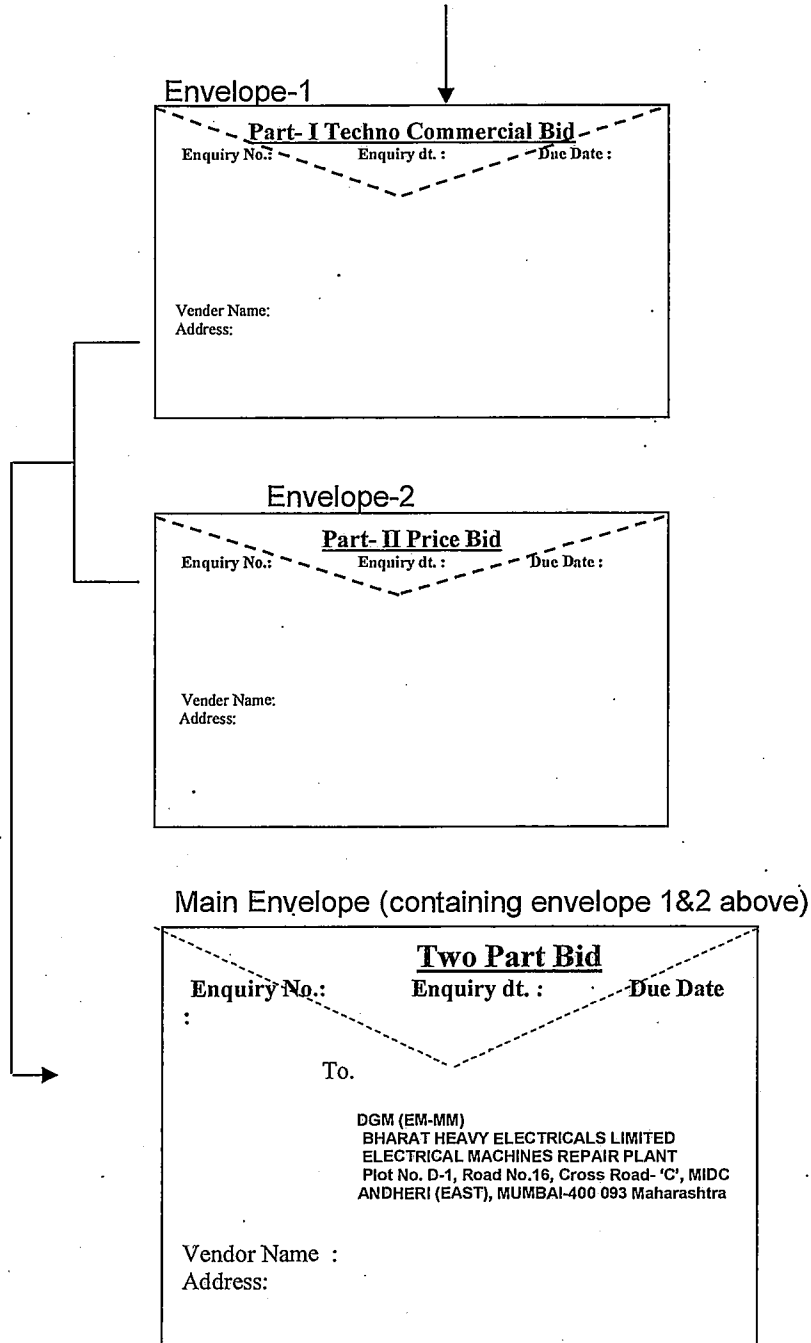
- 2.1 Bidder shall submit the offer in two bid system in two different sealed covers.
- 2.1.1 Part 'A': Techno-Commercial Bid
- 2.1.2 Part 'B': Price Bid
- 2.2 Tender No., date and due date of opening should be written on both the covers.
- 2.3 These two covers shall then be placed in a large cover and sealed. The large cover should also have Tender no., Date and Due Date. This should be dropped in the tender box placed at the entrance of our works before due date and time.
- 2.4 Part 'A' - Techno Commercial Bid: Techno Commercial Bid shall contain technical and commercial offer as per NIT Proforma, indicating acceptance of NIT terms, as per Annexure-I. Acceptance of all technical and commercial terms and conditions given in the format Annexure I. (No Deviation certificate and deviation Proforma), duly filled in signed as required. Blank price-bid proforma indicating only rates of taxes and duties indifferently applicable without rate / price of material may be enclosed with the techno-commercial bid Part A.
- 2.5 Any deviation in the above mentioned terms and conditions or conditional offer may render the offer invalid and shall be liable to be rejected, and price bid of such bidders shall not be opened. Price bid of only those bidders shall be opened whose Techno-Commercial offer is found suitable and acceptable.
- 2.6 Part 'B': Price Bid Part B should contain only the price duly filled in Price Bid Proforma Annexure II, without any terms and conditions. Any terms and conditions, if mentioned in the price bid, shall be ignored and not considered.

- 3.1 BHEL reserves the right to reject the offer and or award the work in full or part without assigning any reason.
- 3.2 Tender should be free from over writing and erasers, additions if any must be attested.
- 3.3 Purchase Order will be subject to general conditions of purchase prevailing in Bharat Heavy Electricals Limited.
- 3.4 Any dispute arising out of this shall be referred to the sole arbitration of Unit Head, BHEL, EMRP, Mumbai OR any other officer nominated by him and his award shall be final and binding on the parties. The venue of the arbitration in all cases shall be Mumbai.
