22. BGs should be in favour of BHEL-PSSR in place of PEM. L1 Vendor will be required to submit BGs as per GCC Rev-07.
23. Bidders who fulfil Technical & Financial Pre-Qualification Requirement Criteria are eligible to participate in this tender. Bids of only those bidders shall be evaluated who meet the Technical as well as Financial Pre-Qualifying requirements.
24. Bidder to note that this is an Open Tender enquiry & Price bid (Part-II) opening/RA participation shall be subject to following condition:
- a) Qualifying Technical & Financial Pre-Qualification Requirement.
 - b) Techno-commercial acceptance of offer by BHEL-PEM.
 - c) Approval of bidder by End Customer:- Same shall be taken up with end customer based on the latest credentials/reference list furnished by bidder. Accordingly, bidders are requested to submit credential as per the format enclosed herewith along with their technical bid.

Bidders to ensure that Third party/customer issued certificates being submitted as proof of PQR qualification should have verifiable details of document/certificate issuing authority such as name & designation of Issuing Authority and its organisation contact number and email Id etc. In case the same found not available, Purchaser has right to reject such document from evaluation.

29. In case of joint bidding, bidders to furnish scope matrix which should be clearly defined between them along with the offer for the complete scope.
30. Over all (%) quantity variation: The variation on overall package value due to changes in the scope shall be limited to +/-10% in place of 30% mentioned in clause no 6.0 of GCC-REV-07.
31. This item/package/system falls under the list of items defined in para 03 of Ministry of Finance guidelines dated 20.09.2016(procurement of items related to public safety, health, critical security operations and equipments, etc.) & hence criteria of prior experience/turnover shall be same for all the bidders including start-up/MSME.

32. Deductibles/ Excess: Following Deductibles/ EXCESS may be considered.

For Marine Cover: 0.25% of consignment value subject to minimum of Rs 20,000/-

B) For Storage /Erection and Testing Cover:

(i) Other Items (BOP ITEMS):

Rs 2,25,000/- or 5% of the claim amount whichever is higher for Normal Period.

Rs 6,00,000/- or 5% of the claim amount whichever is higher for Testing Period.

(ii) Act of God (AOG) Perils: 10% of the claim amount subject to minimum of testing period excess with an upper limit of Rs 5 Crores per event.

(iii) Fire / Explosion Claims: Rs 6,00,000/- or 20% of the claim amount whichever is higher for Testing period.

Terrorism Cover: Deductible applicable will be as per Indian Terrorism Pool.

Extended Maintenance Cover/ Defect Liability Cover: As applicable for testing period excess.

Third Party Liability Cover:

I. The policy excesses (Normal/ Testing periods) as per SCE shall apply for third party liability property damage claims also.

II. For third party liability claims arising out of Acts of God perils, the excess applicable to AOG claims shall apply.

33. Construction Power, Construction water and Storage at site: As per project SCC

34. In the course of evaluation, if more than one bidder happens to occupy L1 status, effective L-1 will be decided by soliciting discounts from the respective L-1 bidders.

In case more than one bidder happens to occupy the L-1 status even after soliciting discounts, the L-1 bidder shall be decided by a toss/draw of lots, in the presence of the respective L-1 bidder(s) or their representative(s).

Ranking will be done accordingly. BHEL's decision in such situations shall be final and binding.

35. Bidders to quote freight charges in percentage of their quoted Total Ex-works Prices.

36. GST shall be payable extra at actual as per the HSN code finalised for the items during detailed BBU.

37. In line with clause no 26 of (ITB) GCC-REV-07, this package is not divisible in nature and minimum local content requirement is 50%. Local supplier at the time of tender, bidding or solicitation shall be required to provide the following certificate (preferably as per draft enclosed) along with the part-1 bid:

(i) Self-certification (in attached format) that the item offered meets the minimum local content.

(ii) Provide the details of the location(s) at which the local value addition shall be made.

38. Bidders may visit site/ work area and study the job content, facilities available, availability of materials, prevailing site conditions including law & order situation etc. before quoting for this tender. They may also consult this office before submitting their offers, for any clarifications regarding scope of work, facilities available at sites or on terms and conditions. No additional claim shall be entertained by BHEL in future, on account of non-acquaintance of above.

39. All the above terms and conditions, post-bid agreements/MoMs (during Techno- Commercial evaluation) shall automatically become a part of the Order/Contract after its finalisation.
