Scope of work is as follows:

Cutting and turning of sintered Ceramic Components as per our drawing supplied (drawing enclosed) Drawing No.4 987 01 04014/00

1. The machined item should not have any chipping, cracks or any other damage.
2. The item should be as per mentioned dimensions and within the tolerances given.
3. The items are to be packed suitably to ensure that there is no damage to the items after turning & during transport.
4. The items will be measured and checked at BHEL premises. Payments will not be made for items that are rejected for dimensional and other defects attributable to bad workmanship.
5. BHEL will issue the sintered item for machining activity for which Security deposit of 5% of the order value to be paid by the contractor before start of the work.

Terms and Conditions

1. The contractor should have experience in machining of fired ceramic components in the previous 05 years from the date of NIT. Evidence in form of order copy /completion certificate of the job contract to be enclosed along with the offer.
