Or for Trader/Dealer/Agent etc.
- a. Authorization letter from their principal is mandatory
- b. In case of foreign principal: An agency agreement deed copy is required.

1. Scope of Supply: Automatic dispensing unit with motor unit, TFT touchscreen for performing titrating, display of digital output, automatically refill without changing the reading, perform a zero reset and switch off the instrument etc.
2. Purpose: For Digital Titration using EDTA & Zinc Sulphate Solution. Digital burette must be able to perform using motor control & pouring of chemical is to be performed by touchscreen using stylus. Instrument should be able to digital titration reading digitally and store at least 20 results in memory.
