Scope of activities in Load testing – EOT & Mobile Cranes

Vendor's scope

1. Checking of dia. Of wire rope
2. Checking of condition of hook – main & auxiliary, and wire rope
3. Checking of limit switch and overall condition of the crane
4. Checking of performance of crane during load test
5. Submission of load test certificates duly signed and stamped
6. Submission of detailed report for all the cranes duly signed and witnessed by respective shop (and transport) maintenance in-charge.

BHEL's scope

1. Arranging entry of the vendor and vendor's allied manpower for the period of load-testing (Vendor shall have to comply with all the applicable labour laws, safety rules etc.)
2. Arrangement of load for load testing (Including transportation if required)
3. Facilitation of cranes and other minor material (including measuring tape etc.) subject to availability

The total time period for completion of the process of the load testing shall be 1 month. The cranes shall be made available to the vendor as per their availability; vendor is to keep the testing schedule flexible for this reason.
