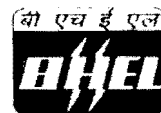

And if the repair or maintenance is been done by BHEL, then expenditure cost and additional amount of Rs. 500/- for each such repair/maintenance work will be recovered from monthly bill or from Security Deposit of the contractor.



TECHNICAL SPECIFICATION OF RO WATER MACHINES:

1 Eight RO machines have been installed in BHEL PEM, Sector-16A, Film City, Noida. These comprise of pump motors, adapters/transformers, membranes, filters, additional filters, SS frame, pipes, unions and joints, valves, sensors, electrical cables & plugs, HPR and LPR switches, solenoid valves etc covering WHO (World Health Organization) approved standards. The RO machines need to be maintained/repared for failed components and kept always in workable condition to provide the best quality of RO water as WHO standards (IS10500:1991 specifications).

2. BILL OF QUANTITIES: (50 LPH RO Machines – Total quantity of 08 No.s)

Tentative BOQ for items which are required to make the system always functional is mentioned in the table here. Bidder to note that BOQ enclosed is indicative and may vary to some extent. Bidder should visit the site to survey the machines before bid submission. Bidder will have to provide each and every item to make the RO machines always in working condition.

1.0 SCOPE OF WORK:

- 1.1 The party will provide comprehensive AMC for eight (8) nos. of RO water plants and comprehensive AMC for pre- sedimentation spun filters installed before each RO water plants for two years in BHEL PEM premise. RO water from these eight (8) RO machines is being presently used by a total of 700 persons approximately in office hours for drinking purpose only.
- 1.2 The quality of produced water should be of WHO standards.
- 1.3 Party will get tested the TDS of produced RO water on weekly basis and will maintain the record counter signed by BHEL authorized person. The TDS measured value must not be more than 200 mg/l (i.e.200 ppm).
- 1.4 Party representative/skilled worker (s) must inspect the machine twice in a week remove the abnormality, if any, in machine or produced RO water.
- 1.5 Party will provide all the necessary consumables/ spares including membrane, all types of filters including additional installed pre sedimentation (spun) filters, carbon filters, HP pump, HPR/ LPR switches, adapter, 'T' union, candle, pipe lines, check valves, housing, electrical cables, flow regulators, storage tank sensors and other spares if any, at their expense. No labour/transportation charges, consumables/ spares for eight (8) RO units and eight (8) additional installed pre sedimentation filters will be provided/ reimbursed by BHEL.
- 1.6 All types of maintenance will be the responsibility of contractor of the eight (8) RO water machines.
- 1.8 The party must visit and inspect/survey the eight (8) RO machines and quality of raw water before submitting the tender and price format which include all the expenditure.
- 1.9 To maintain the quality of water as per WHO standard, if the contractor installs or advises to install additional equipment, expenditure will be borne by the contractor.
- 1.10 The components installed/replaced shall be shown as a proof to BHEL authority before changing or replacement by carrying out maintenance activities.

2.0 BHEL's SCOPE OF WORK:

- 2.1 Water quality will be checked twice by BHEL in a year.
- 2.2 BHEL will provide space, electricity, supply of raw water, storage tank & water cooler for its equipment.

3.0 TIME OF WORK:

- 3.1 Party must be ready to provide the services within three (3) hours after the receipt of complain / order (the abnormality of machines may be reported at any point of time). Bidder must have valid e-mail ID and existing phone no. / Mobile no. for receiving complaints and abnormality about RO machines.
- 3.2 The work will be done on BHEL working days. The party representative will attend the work twice a week or on at the discretion of BHEL on the day of any abnormality reported in RO water/ RO machine, whichever comes first. On the holidays repair/maintenance work can be done by taking prior approval.

4.0 PENALTY:

4.1 On complain/ abnormality lodging against RO machines, if the party does not respond within the stipulated time of three (3) hours, Rs. 200/- per hour for delay shall be recovered from the monthly bill or from the Security Deposit of the contractor. And if the repair or maintenance is been done by BHEL, then expenditure cost and additional amount of Rs. 500/- for each such repair/maintenance work will be recovered from monthly bill or from Security Deposit of the contractor.

5.0 PAYMENT TERMS:

5.1 The Contractor shall submit the bill(s) in conformation with the Log book at the end of every month, which shall be certified by BHEL's representative and payment will be made within 30 days after submission of the bill subject to the condition that the bill is in proper order. Payment will be made through e-payment (through electronic fund transfer (EFT) / RTGS) only after deducting taxes (like Work contract tax, TDS, sale taxes, service taxes, etc.). **Details of your bank account for the same shall be submitted by you.** Also, no interest shall be paid due to delay in making the payment. Service Tax should be shown separately in the rates quoted. The same will be paid / remitted in accordance with the provisions of Reverse Tax Mechanism of Service Tax as applicable.

1. BID SUBMISSION

Bids shall be submitted latest by **10:00 AM** on or before the due date in two parts as follows:

PART-1: TECHNO-COMMERCIAL BID

This part shall contain the following:

a) Complete tender including Technical Specification & other scope of work, Commercial terms & conditions and General terms & conditions in all respects duly signed & stamped on each and every page by the authorized signatory of the bidder as a token of acceptance of all the terms and conditions of tender. **Please submit techno-commercial offer (Original + 1 copies).**

b) **Unpriced copy** of the price bid with all amounts/figures/ percentages wherever quoted in the price bid being replaced with the word 'Quoted' or 'Q'.

c) Supporting document/ information to be submitted against each point of 'PQR' and Documents to be enclosed with bid / Eligibility Criteria:

e) Copy of PAN Card, VAT/Sales tax registration/Service tax registration duly signed and stamped by the bidder.

f) **EMD** is which is Rs. 5,374/- for this tender.

PART -2: PRICE BID

2) BID OPENING

PART- I (Techno-Commercial Bids) will be opened at **11:00 AM** on the due date in the presence of bidders who may like to be present. Date and time of opening of Part - II (Price Bids) shall be communicated separately.

- 3) The bid shall remain valid for a period of 90 days from the date of opening of part-I offers. No revision of prices shall be entertained after bids have been opened. Bidder shall not be entitled during this period to revoke or vary the content of bid or any terms thereof. In case of any unsolicited variation subsequent to bid opening, the bid shall be treated as "Rejected".
- 4) No revision of prices shall be entertained after bids have been opened.
- 5) Prices shall remain firm without any variation till completion of contract.
- 6) Illustrative leaflets giving technical details of items offered should be enclosed, wherever necessary.
- 7) BHEL shall be under no obligation to accept the lowest or any other bid and shall have the right to accept or reject any bid in part or in full without assigning any reason whatsoever.
- 8) Late tenders will be rejected.

9) RISK PURCHASE:

Purchaser will have the option to terminate the contract and purchase from elsewhere at the risk and cost of the Vendor, either the whole or part of the goods which the Vendor has failed to deliver or despatch within the stipulated delivery period or if the same were not available, the best and the nearest available substitute thereof. The Vendor would be liable to compensate the Purchaser for any loss which the Purchaser may sustain by reason of such risk purchase, in addition to Liquidated Damages (Penalty Clause) at the rate mentioned above.

10) PRICE DISCREPENCY:

- a) If, in the price structure quoted for the required goods/services/works, there is discrepancy between the unit price and the total price (which is obtained by multiplying the unit price the quantity), the unit price shall prevail and the total price will be corrected accordingly, unless in the opinion of the purchaser there is an obvious misplacement of the decimal point in the unit price., in which case the total price as quoted shall govern and the unit price will be corrected accordingly.
 - b) If there is an error in a total corresponding to the addition or subtraction of subtotals, the subtotals shall prevail and the total shall be corrected; and
 - c) If there is a discrepancy between words and figures, the amount in words shall prevail, unless the amount expressed in the words is related to an arithmetic error, in which case the amount in figures shall prevail subject of (a) and (b) above.
 - d) If there is such discrepancy in an offer, the same shall be conveyed to the bidder with target date up to which the bidder has to send his acceptance on the above lines and if the bidder does not agree to the decision of the purchaser, the bid is liable to be ignored.
 - e) Taxes and duties if not specified clearly as extra shall be considered as include in the basis price and, therefore, shall not be reimbursed separately.
- 11) BHEL shall be under no obligation to accept the lowest or any other bid and shall have the right to accept or reject any bid in part or in full without assigning any reason whatsoever. BHEL also reserves the right to reject any or all quotations without assigning any reason whatsoever. Quotation of the parties which have been black-listed / debarred / banned by PSUs / kept on hold by any office of Delhi-based Divisions of BHEL during the last three years will be rejected. Late tenders will be rejected.

12) SECURITY DEPOSIT

The successful bidder shall be required to furnish a Security Deposit of 5% of of total value of contract, excluding taxes. 50% of Security Deposit amount, including EMD, will have to be furnished through demand draft / banker's

cheque in favour of BHEL payable at New Delhi or by cash in BHEL PS-PEM office Finance Dept. before start of the contract and balance 50% will be recovered from the bills. The Security Deposit shall not carry any interest and will be refunded to the contractor on successful completion of the contract and settlement of recovery of dues, if any, to BHEL/PEM to cover the due performance of Order.

Contract and to fulfil the guarantee conditions stipulated in the Order/Contract.

- 13) **QUALITY:** All Systems/goods/services supplied/rendered shall be brand new and conform to the contract technical specifications and/or be strictly in accordance with approved samples/drawings. Where there is no specifications, sample or drawings, Systems/goods/services shall be of the best quality.
- 14) **CHANGE OF ORDER :** No changes to this order/contract are permitted unless authorised in writing and signed by competent authority of this office.
- 15) **LOCATION & CONSIGNEE :** Complete Systems/goods/Services will be consigned/delivered to DH (PEM-HR/GAX), PPEI Building, HRDI&ESI Complex, Plot No. 25, Sector 16A, NOIDA – 201 301, who will co-ordinate the activities of AMC services.
- 16) **TAX DEDUCTION AT SOURCE:**
Tax shall be deducted at source from the running bills as per applicable Income Tax Rules and other statutory requirements.
- 17) **TERMINATION OF CONTRACT:**
If at any time during the currency of contract, the contractor defaults in performance of the work with due diligence and continues to do so or commit any default in complying any of the tender terms and conditions even after the notice (in writing) is given to him, BHEL may, without prejudice to any other, has right to remedy which shall have accrued or shall accrue thereafter to BHEL, to terminate the contract.
- 18) **DEVIATION:** The Contractor must comply with the tender specification and all terms and conditions of contract. No deviation shall normally be entertained. Deviation if any, should be given as per the format attached at Annexure-V by mentioning the related/affected clause number etc.
- 19) **ARBITRATION**
In the event of any dispute or difference arising out of the execution of the Order/Contract or the respective rights and liabilities of the parties or in relation to interpretation of any provision between BHEL & Service Provider in any manner touching upon the Order/Contract, such dispute or difference shall (except as to any matters, the decision of which is specifically provided for therein) be referred to the arbitration of the person appointed by the competent authority of BHEL.

Subject to as aforesaid, the provisions of Arbitration and Conciliation Act, 1996 (India) or statutory modifications or re-enactments thereof and the rules made thereunder and for the time being in force shall apply to the arbitration proceedings under this clause. The venue of arbitration shall be at Noida.
- 20) **LAWS GOVERNING THE CONTRACT**
The Order/Contract shall be executed and governed by the laws of India and the courts of India alone shall have jurisdiction in respect of any matter arising under or in connection with the Order/Contract. Extant regulations of Govt. of India will be applicable. Law of land will supersede any condition given in tender enquiry, in case of any contradiction.
- 21) **RESOLUTION OF DISPUTES**
- The purchaser and the supplier shall make every effort to resolve any disagreement or dispute, arising between them under or in connection with the contract, amicably by direct negotiation.
 - Dispute if any, arising out of or in respect of the contract(s) to which these conditions are applicable, is subject to the jurisdiction of the Delhi courts only.

22) STATUTORY VARIATION:

- i) If the rates for taxes and duties in respect of the quoted materials and/ or services assumed by the Seller/ Contractor are less than the tariff prevailing at the time of tendering, Seller/ Contractor will be responsible for such under quotations. However, if the rates assumed are higher than the correct rates prevailing at the time of tendering, the difference will be to the credit of the Purchaser.
- ii) Statutory Variations in Service Tax only on self-manufactured items/ services rendered by vendor himself on the rates prevailing at the time of delivery/ completion in comparison to the date of offer, will be to the account of the Purchaser.
