BHEL-Electronics Division is intending to take bikes on hire basis for the usage of CISF for a period of **two years** wef 01.02.2018(tentative). The details are as given below:

No of bikes to be hired – 02 (two) Specifications of Bikes - Suzuki Slingshot 125 CC bikes (Motor Cycles) or equivalent models of 2013 or later make. The terms and condition:- The monthly rental amount shall be credited to the vendor through NEFT on submission of bill/invoice after the completion of each calendar month. BHEL/EDN will submit the original ID/Address proof & photocopy of the driving license of the rider. The bike shall be picked up by the authorized representative of BHEL from the office of the vendor and the same will be returned back, in as is where condition after the completion of contract period. The estimated value of the contract is around 1.81 lakhs for two years period. Qualifying Criteria:

- 1. The vendor should be registered for providing the required services.
- 2. Should have minimum two years of experience in proving the service of renting bikes.
- 3. Should have office in Bangalore
- 4. Should have average turn over of Rs 54432/- for the last three years ending 31.03.2017.

The vendor would take care of all wear and tear, maintenance and servicing costs, and the cost of comprehensive Insurance of the vehicle. The vendor shall replace another bike until the bike gets serviced. The vendor shall provide one helmet per bike to our rider. M/s. BHEL/EDN shall reimburse for any fines/penalties due to the riders fault.

M/S BHEL-EDN can terminate the contract by giving one month notice.
