1. SCOPE OF WORK OF THE CONTRACTOR SHALL BE AS FOLLOWING:

- a. The contractor shall be responsible for "In House Shell Erection of WAG-9H Locomotives at FBM, BHEL Jhansi". If bidder desires sample/ typical drawing of WAG-9H Locomotive Shell Erection can be provided for reference only, however the contractor shall execute the job as per the specific drawing provided by the Fabrication Deptt., BHEL, Jhansi. . Actual wt. in the job may vary by +/- 30 %.
- b. The scope of work includes Assembly of Shell Erection (i.e. Erection and Mounting of superstructures like -Side Wall, Cabin, Roof, Stool, Ducts & Other miscellaneous Items **over Under Frame**) as per Assembly Drawing No.IBO31-00273 provided by BHEL Jhansi. The scope of work also includes assembly, fitting, welding, NDT Testing, shot blast, painting and getting the jobs cleared by QC (BHEL) and Customer/RDSO as per BHEL Quality Plan.
- c. Electricity, compressed air, cutting gases, tools, consumables, like electrodes, grinding wheels etc., available with BHEL shall be provided by BHEL free of cost. In stages, machining operation shall be in BHEL's scope. Vendor has to arrange for tooling which are not available with BHEL. Machines/equipment such as welding machines, grinding machines, painting gun etc. shall be arranged by contractor. Labour engaged by the contractor should be qualified to complete the assigned work in time.
- d. EOT crane shall be provided by BHEL free of cost; however, assistance in operation of the same shall be the responsibility of contractor. In contingency, in order to meet the job requirement, any additional resources if required shall be arranged by the contractor at their own cost.
- e. BHEL-QC and Customer / RDSO shall do inspection at various stages and contractor shall maintain proper record. Inspection/clearance by BHEL-QC and Customer/ RDSO shall be the responsibility of the contractor. In addition, the Contractor shall attend to any rework/ modifications, as and when suggested by BHEL-QC / BHEL Engg./ Customer/ RDSO.
- f. The Contractor shall be responsible for complying with all the applicable statutory acts & laws.
- g. Contractor may be required to work in three-shifts. Contractor shall appoint qualified supervisors for A/B/C Shifts for coordination with various departments of BHEL, Jhansi. 4. **Delivery Period:** One-week advance notice/ letter of intent (LOI) shall be given to the Contractor(s) for starting the work. Delivery requirement for the execution of work will be intimated in notice/ LOI at the time of loading work on contractor.
5. **LD Clause:** For late completion of work, BHEL standard LD clause shall be applicable which is 0.5% per week or part thereof, subject to maximum 10% of contract value.
6. **Reverse Auction:** BHEL reserves the right to conduct Reverse Auction (RA). The bidder shall give an undertaking conveying their agreement to participate in RA.
7. **Termination of contract:** Based on the time to time performance of the contractor, if the same is under par than that required by BHEL, Then BHEL will have the right to terminate the contract after giving due information of the same to the contractor at least 2 weeks in advance.
8. **Distribution of Work:** Order may be split into two (L1 and L2) bidders in the ratio of 60:40. The evaluation of the Tender will be carried out as follows:

CONTRACTOR'S OBLIGATIONS

- 6) **Discipline:** The Contractor shall be responsible for the discipline of his own employees deployed under the contract. In case of any loss to the BHEL Jhansi on account of indiscipline of employee then such loss shall be assessed and recovered from the running bills of the contractor or from the security deposit.
- 7) The contractor, on advice of authorized BHEL official, shall immediately remove any person employed by him, who may in the opinion of such authorized BHEL official is involved in misconduct. Such person shall not be re-employed by the contractor without prior permission.
- 8) Contractor will keep watch on his employees and he will be liable for any pilferage / loss to BHEL due to acts of omission and commission by his employees. Similarly, liability for any compensation to outsiders on account of any act of omission and commission by the employees deployed by the contractor shall lie exclusively with him.

- 9) Contractor to ensure compliance of the instructions contained in safety guidelines issued by Safety Deptt (HSE) of BHEL, Jhansi (Same can be downloaded from BHEL Jhansi website. The contractor has to ensure that all precautions are taken for safety of his employees and equipment's.

In case any worker leaves the job or fresh worker is deployed then also providing helmets, shoes, tools and tackles, accident insurance etc. to the fresh worker shall be in contractor scope and no extra amount shall be payable to this account by BHEL.

- 12) **Bus Pass:** Contractor may apply for providing bus pass facility to his workmen. BHEL will consider such applications based on merits and availability of seats. Contractor would be responsible for depositing bus pass charges and penalties (if applied) of his/her workmen/staff etc. BHEL would have the right to deduct/recover the same in case of default by the contractor/supplier.

- 14) Tools, tackles and materials: Contractor shall provide to his employees all tools, tackles, material, equipment's as specified in contract and maintain the same to carry out the job under the contract at his risk and cost. BHEL shall not have any liability for these tools, tackles, equipment's or material.

B) Towards statutory liability

1 SECURITY DEPOSIT:-

1) Modes of deposit:

The balance amount to make up the required Security Deposit of 5% of the contract value may be accepted in the following forms:

- (i) Cash (as permissible under the extant Income Tax Act)
- (ii) Local cheques of Scheduled Banks (subject to realization)/ Pay Order/ Demand Draft/ Electronic Fund Transfer in favour of BHEL
- (iii) Bank Guarantee from Scheduled Banks/ Public Financial Institutions as defined in the Companies Act. The Bank Guarantee format should have the approval of BHEL
- (iv) Fixed Deposit Receipt issued by Scheduled Banks/ Public Financial Institutions as defined in the Companies Act (FDR should be in the name of the Contractor, a/c BHEL)

2) Collection of Security:

At least 50% of the required Security Deposit, including the EMD, should be collected before start of the work. Balance of the Security Deposit can be collected by deducting 10% of the gross amount progressively from each of the running bills of the Contractor till the total amount of the required Security Deposit is collected.

- Completion of work and certification of payment of minimum wages to contract employees from contracting department.
 - Certificate of compliance of labour laws from Contracting Deptt and verified by HR department.
 - Certificate of payment of Bonus by Contracting Deptt and verified by HR department
 - No-dues certificate regarding service tax payment, and any other dues liable to be remitted by contractor under financial laws, to Finance department.
 - In case of non-satisfactory performance of the contract, BHEL shall have a right of forfeiting the security deposit. In case of any dispute decision of concerned Head of the Department will be final.

13 **RISK & COST:-**

If the Contractor fails to perform/execute the work within time or fail to perform as per the specification prescribed in tender or acted in violation to prescribed terms and conditions, BHEL-Jhansi shall be entitled to terminate the Contract and take recourse to alternate source to get the work done at the risk and cost of the Contractor. In such case Contractor shall make good the loss to BHEL. BHEL shall be entitled to recover the difference in cost, if any incurred by BHEL due to getting the work done from alternate source. However, in such case Contractor shall not be entitled for any gain.

14 **SETTLEMENT OF DISPUTE/JURISDICTION/ARBITRATION ETC:-**

BHEL Reserve the following rights to evaluate the bid as per BHEL policy and Govt. guidelines including CVC / Vigilance guidelines by the tender committee duly constituted by BHEL Management. The decision of BHEL, Jhansi Management or Tender committee duly approved by competent authority shall be final and binding to bidder.

**SUB: GUIDELINES FOR DEALING WITH “DISCREPANCY IN WORDS & FIGURES-
QUOTED IN PRICE BID / REVERSE AUCTION”**

In case of non-conformities/errors/discrepancies are observed between the quoted prices in figures and that in words, following guidelines shall be followed:

- a. If, in the price structure quoted for the required goods/ services/ works, there is discrepancy between the unit price and the total price (which is obtained by multiplying unit price by quantity), the unit price shall prevail and the total price corrected accordingly. Unless in the opinion of the purchaser there is an obvious misplacement of the decimal point in the unit price, in which case the total price quoted shall govern and the unit price corrected accordingly.
- b. If there is an error in a total corresponding to the addition or subtraction of subtotals, the subtotals shall prevail and the total shall be corrected and
- c. If there is a discrepancy between words and figures, the amount in words shall prevail unless the amount expressed in words is related to an arithmetic error, in which case the amount in figures shall prevail subject of (a) and (b) above.
- d. If there is such discrepancy in an offer the same shall be conveyed to the bidder with target date up to which the bidder has to send his acceptance of the above lines and if the bidder does not agree to the decision of the purchaser, bid is liable to be ignored.
