1. BID SUBMISSION:

Bid shall be submitted latest by 11.00 A.M. on or before 3rd, October, 2019" at BHEL Dispensary, BHEL House, Siri Fort New Delhi -110049. Bidders must submit their bids as per instructions in the NIT i.e. bids shall be strictly in accordance with the tender specifications.

Your most competitive / minimum Government Hospital rates are invited for the medicines / products as per attached medicines lists in the format enclosed.

The bid document is required to be submitted in a sealed envelope addressed to Dr. (Mrs.) Kiran Wadhawan, AGM (Medical), BHEL Dispensary, BHEL House, Siri Fort New Delhi 110049, superscribing "Bids against Enquiry No. AA:Med:Asiad-2:2019 dated 16.09.2019, Due date of Opening 3rd, October2019"

Price quoted should be inclusive of packing, forwarding, freight and insurance.

2. QUATATION validity

The offer submitted by the bidder shall be kept valid for acceptance for a period of three months from the date of opening of Bids.

The rates of Medicines shall remain fixed for the complete duration of Contract i.e., One year from the date of award of Contract. The Contract validity may be extended for another year as per necessity at that time.

All bids should also contain **Acceptance to Tender Terms and Conditions** as per **Annexure B**, duly stamped and signed by Authorized Representative of the bidder.

3. TAXES & DUTIES

All taxes & duties should be indicated as a percentage as well as the amount and should be indicated **separately and clearly in the price bid**, otherwise it will be presumed that the rates quoted are inclusive of all taxes and duties.

Any subsequent changes in taxes & duties shall be applicable to either side subject to production of proof.

Medicines exempted from tax by Government should be clearly stated.

4. BID OPENING:

Tender will be opened by the Tender Committee at 11.30 A.M. on 3rd, October, 2019" at BHEL Dispensary, BHEL House, Siri Fort New Delhi -110049 in the presence of Authorized Representatives of the bidders, who may like to be present. Bidders shall note that if the date of tender opening given in the tender document is declared an off/ holiday by BHEL, then the next working day shall be considered as the last date of submission & opening of bids up to the time specified.

5. Evaluation of Bids:

The evaluation of bids shall be on the delivered cost (i.e., total cost to BHEL.) If There is a rates discrepancy between words and figures, the amount in words will prevail for calculation of price.

6. DELIVERY & LD CLAUSE

The medicines will be supplied at various BHEL Dispensaries at Delhi within a period of four weeks from the issue of Purchase Order by BHEL.

In case of failure in supply by the bidder as per purchase order schedule, a penalty @ half % per week or part thereof for undelivered portion shall be deducted subject to a maximum of 10% of order value. However, in case of stock out situation for more than 4 weeks the same shall be procured from alternative source and difference in price shall be recovered from vendors.

6. PAYMENT TERMS:

100% Payment will be made within sixty days from the date of receipt and acceptance of consignment of medicines by BHEL Dispensary. The payment will be made through ECS for which bidder should give requisite ECS Mandate Form with details of bank address, Account No. etc.& a copy of the cancelled Cheque.

7. GENERAL TERMS & CONDITIONS OF TENDER:

Envelope should clearly state "BHEL Medicine Tender enquiry due on 3rd, October, , 2019"

- i.Please mention address and phone No. of local / Delhi based authorized supplier.
- ii. The offer submitted by the bidder shall be kept valid for acceptance for a period of three months from the date of opening of Bids.
- iii. The rates of Medicines shall remain fixed for the complete duration of Contract (i.e., One Year from the date of award of contract). Any change in Govt. taxes/duties/DPCO will be binding on either side. In the event of reduction of prices, (as per new drug policy to be introduced by Govt. of India where in prices of certain drugs may be slashed down) the benefit should be passed on to BHEL.

- iv.Kindly enclose latest Minimum Govt, Hospital Rate List of manufacturer at the time of supply of Medicines if available.
- v.Self attested Lab Batch test reports shall be supplied along with Consignment of medicines.
- vi.BHEL reserves right to randomly select any drug sample from the batch and get it analyzed from a recognized laboratory at BHEL cost. In case of any discrepancy, appropriate action will be taken.
- vii. Order will normally be placed in four phases i.e. after every three months or as required. Supply of Noida Dispensary to be made at Asiad Dispensary in separate container and bills.
- viii. Medicines should preferably be marked with "BHEL Supply".
- ix. Separate Four copies of Pre-Receipted Bills for each dispensary should be sent with the consignment.
- x.Date of Expiry of medicines supplied should not be less than one year from the date of supply.
- xi. Please submit your Company's latest Turnover, if not submitted earlier.
- xii. Standard pre-printed terms & conditions of the bidders shall not be considered valid.
- xiii. Any loss or damage to the consignment during handling, transportation, storage till such time the same is accepted by BHEL Dispensary, shall be to the account of the supplier.
