Vendors must fill up Annexure– II in confirmation to above Minimum Qualifying Requirements and quality requirement.

ESSENTIAL INSTRUCTIONS

- All un-registered vendors shall be approved by BHEL, if found suitable, on the basis of data furnished by them in Supplier Registration Form (SRF) Foreign Vendors or Indigenous Vendors. Vendor (s) shall not be considered for ordering if not approved by BHEL.**

10. SELECTION OF TEST: SAMPLES

9.2 Analysis for Al shall also be carried out and value reported in the test certificate

9.3 Small deviations in the chemical composition may be permitted after obtaining prior permission from BHEL, if the required properties are not impaired.

10.1 The mechanical properties testing shall be done on transverse samples according to DIN 17155.

10.2 Each plate shall be tested individually for mechanical properties. However for thin plates (< 3 mm), tests shall be carried out on each melt basis.

10.3 One hot tensile test at 300 deg. centigrade shall be carried out on 30 tonnes melt (lot) or smaller quantity. The 0.2% proof stress value obtained shall be reported in test certificates.

10.4 Impact testing (ISO V) shall be carried out for plates with thickness > 5 mm.

10.5 Chemical analysis shall be carried out as per melt basis.

11. TESTING OF REDUCTION IN AREA (Z15) (Z15)

* AS PER QUALITY CLASS Z15 OF SEL 096.

The reduction in area shall be tested on 3 SAMPLES in transverse direction for plates with thickness 15 to 150 mm. A mean value of Min 15% is to be achieved. However individual value can go upto 10%. The testing is to be carried out per lot basis. A lot shall consist of 4-rolled plates of same thickness and same heat.

Failure on the part of seller to inform dispatch particulars will make him liable to pay for any transit damages / losses suffered by the Purchaser.
- b) If Quoted Prices are inclusive of transit insurance, no weightage shall be given while evaluating the bids for Cost of Insurance, being in BHEL Scope.

18. RISK PURCHASE.

In case of abnormal delays (beyond the maximum late delivery period as per Penalty clause) in supplies / defective supplies or non-fulfillment of any other terms and

conditions given in Purchase Order, BHEL may cancel the Purchase Order in full or part thereof, and may also make the purchase of such material from elsewhere / alternative source at the risk and cost of the supplier. BHEL will take all reasonable steps to get the material from alternate source at optimum cost. If bidder does not agree to the above Risk Purchase Clause, BHEL reserves the right to reject the offer. - e) Riots, commotions, strike unless restricted to the employees of supplier.
- f) Acts of terrorism.
- g) Other unforeseeable circumstances beyond the control of the parties and which the affected party cannot avoid even by using its best efforts.
- h) Cancellation of contract by customer.
- i) Change in law/ government. Regulation making the performance impossible.
