Vendors must fill up Annexure– III in confirmation to above Minimum Qualifying Requirements and quality requirement.

ESSENTIAL INSTRUCTIONS

1. **Only those bids will be opened which have been submitted with requisite EMD.**
2. **All un-registered vendors shall be approved by BHEL, if found suitable, on the basis of data furnished by them in Supplier Registration Form (SRF) Foreign Vendors or Indigenous Vendors. Vendor (s) shall not be considered for ordering if not approved by BHEL.**
3. **BHEL team may visit the vendor (s) works for verification of capability and capacity claimed in tender documents/offer (s).**

3. SUBMISSION OF TENDER.
