Vendors must fill up Annexure– III in confirmation to Minimum Qualifying Requirements and quality requirement.

ESSENTIAL INSTRUCTIONS

1. Only those bids will be opened which have been submitted with requisite EMD.
2. All un-registered vendors shall be approved by BHEL, if found suitable, on the basis of data furnished by them in Supplier Registration Form (SRF) Foreign Vendors or Indigenous Vendors. Vendor (s) shall not be considered for ordering if not approved by BHEL.
3. BHEL team may visit the vendor (s) works for verification of capability and capacity claimed in tender documents/offer (s).
4. The tender document must comprise of three envelopes:
 - i) Envelope I : Pre- Qualifying Requirement & Supplier Registration Form.
 - ii) Envelope II : Techno -Commercial Bid.

- a) The quotation should preferably be from the principal bidder. However tender specific authorized registered dealer / agent can also submit the bid on their behalf, failing which the quotation is liable to be ignored. BHEL prefers to deal directly with the principal manufacturers.

- b) An agent cannot quote on behalf of more than one principal in the same Tender Enquiry.

3. SUBMISSION OF TENDER.

- a) Bid / Quotation must be enclosed in sealed cover on which tender enquiry number and the due date MUST BE written and be invariably sent under REGISTERED POST / SPEED POST / COURIER / Dropped in the Tender Box: addressed as follows:-

- b) In case of Three / Two Part Bid, technical bid containing technical offer, duly signed and un-priced copy of the Price Bid should be kept in one envelope. - e) The bids of the bidders who are on the banned list and also the bids of the bidders, who engage the services of the banned firms, shall be rejected. 10. PAYMENT TERMS.

11. TAXES & DUTIES.

- c) Please quote our provisional GST registration number in all invoices raised for supply of goods and services under GST regime and also ensure filing of timely return and payment of tax and compliance of other applicable provisions on supplier under GST regime.
- d) No GST will be reimbursed to unregistered or composite dealer. In the event, any GST is quoted by composite dealer, the same shall be added to the cost of supply in evaluating the bid.

- e) Since, input credit of GST will be available to BHEL-Haridwar only after correct filing of return and payment of applicable GST by supplier, reimbursement of GST shall be made by BHEL-Haridwar on matching of vendor inputs at GST portal, ensuring availability of input credit to BHEL Haridwar. Payment of GST will be made to vendor after matching of input credit and vendor to ensure submission of their invoices along with consent to accept payment of tax after such matching in all cases where bills are submitted directly to BHEL-Haridwar or through bank or under LC or through any other mode.
- f) In the event of any disallowance of input credit or applicability of interest or any other financial liability arises on BHEL-Haridwar due to any default of supplier under GST, such implication shall be to supplier's account.
- g) In the event of any change in the status of the vendor after the submission of the bid but before the supply, GST applicable at the time of supply or in the bid, based on the registration status of the vendor, whichever is lower shall be payable.

3. Foreign vendor must quote inspection charges separately in their offer. For indigenous vendor there will be loading of 0.2% of their quoted basic rates as inspection charges.

SPECIFICATION FOR INCONEL 625 CASTING

1. Scope

This specification includes the manufacture, inspection and supply of alloy IN625 casting of dimensions as per drawing conforming in general to ASTM standard A494/A494M-14 (CW6MC).

2. Melting Process

The IN625 material shall be produced by electric arc furnace (EAF) followed by secondary Argon Oxygen Decarburisation (AOD) refinement melting route. Any other suitable melting process shall be used only after approval of purchaser.

3. Chemical Requirements

The chemical analysis shall be made from a representative sample taken during the pouring of the master heat. The chemical composition shall comply with the requirements given in table below:

4. Heat Treatment

The material shall be heated to 1175°C minimum, held for sufficient time to heat castings to temperature, quench in water or rapid cooled by other means. Refer table 2 of ASTM A494).

5. Mechanical Properties

Tensile test (at room temperature) shall be carried out in accordance with test method ASTM E8. Test results shall conform to the following specified requirements:

0.2% Yield Stress: $\geq 275\text{N/mm}^2$

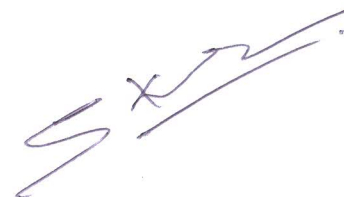
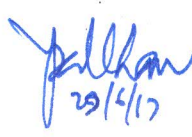

6. Non-Destructive Examination

Each casting shall be inspected by Liquid penetrant examination and Radiography.

100% Liquid penetrant examination as per ASTM E165 and acceptance as per ASME B16.34 Appendix. II or 100% Liquid penetrant examination as per ASTM V and acceptance as per ASME

100% Radiographic examination shall be performed as per ASTM E94. The acceptance shall be as per ASTM E446/186/280.

7. Repair by Welding

Repairs, if any, shall be made in accordance with ASME Section 8 Division 1 Appendix-7. The composition of deposited weld metal shall be similar to that of the castings. On repair welding, the casting shall be subjected to post weld heat treatment at 1175 °C.

Weld repairs shall be considered major in case the depth of the cavity exceeds 20% of the actual wall thickness or 25mm (whichever is smaller), or when the extent of the cavity exceeds 65cm². All other weld repairs shall be considered minor. Major and minor weld repair shall be subjected to the same quality standards as used to inspect the castings. Repair procedure shall be recorded and reported.

8. Quality

The castings shall not be peened, plugged, or impregnated to stop leaks.

Internal chills and chaplets may be used in the manufacture of castings. However, the chills, chaplets and affected cast material must be completely removed.

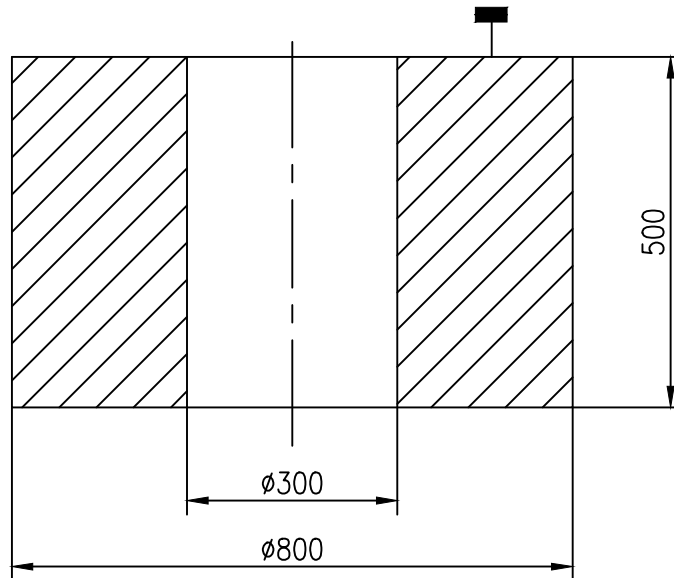

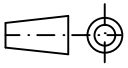
