Vendors must fill up Annexure– III in confirmation to above Minimum Qualifying Requirements and quality requirement.

ESSENTIAL INSTRUCTIONS

1. Only those bids will be opened which have been submitted with requisite EMD.
2. All un-registered vendors shall be approved by BHEL, if found suitable, on the basis of data furnished by them in Supplier Registration Form (SRF) Foreign Vendors or Indigenous Vendors. Vendor (s) shall not be considered for ordering if not approved by BHEL.
3. BHEL team may visit the vendor (s) works for verification of capability and capacity claimed in tender documents/offer (s).
4. The tender document must comprise of three envelopes:
 - i) Envelope I : Pre- Qualifying Requirement & Supplier Registration Form.

- b) An agent cannot quote on behalf of more than one principal in the same Tender Enquiry.

3. SUBMISSION OF TENDER.

- a) Bid / Quotation must be enclosed in sealed cover on which tender enquiry number and the due date MUST BE written and be invariably sent under REGISTERED POST / SPEED POST / COURIER / Dropped in the Tender Box: addressed as follows:-

- b) In case of Three / Two Part Bid, technical bid containing technical offer, duly signed and un-priced copy of the Price Bid should be kept in one envelope. 10. PAYMENT TERMS.

11. TAXES & DUTIES.

- c) Please quote our provisional GST registration number in all invoices raised for supply of goods and services under GST regime and also ensure filing of timely return and payment of tax and compliance of other applicable provisions on supplier under GST regime.
- d) No GST will be reimbursed to unregistered or composite dealer. In the event, any GST is quoted by composite dealer, the same shall be added to the cost of supply in evaluating the bid.

- e) Since, input credit of GST will be available to BHEL-Haridwar only after correct filing of return and payment of applicable GST by supplier, reimbursement of GST shall be made by BHEL-Haridwar on matching of vendor inputs at GST portal, ensuring availability of input credit to BHEL Haridwar. Payment of GST will be made to vendor after matching of input credit and vendor to ensure submission of their invoices along with consent to accept payment of tax after such matching in all cases where bills are submitted directly to BHEL-Haridwar or through bank or under LC or through any other mode.
- f) In the event of any disallowance of input credit or applicability of interest or any other financial liability arises on BHEL-Haridwar due to any default of supplier under GST, such implication shall be to supplier's account.
- g) In the event of any change in the status of the vendor after the submission of the bid but before the supply, GST applicable at the time of supply or in the bid, based on the registration status of the vendor, whichever is lower shall be payable.

MATERIAL SPECIFICATION FOR ALLOY 617M FORGINGS

1.0 GENERAL:

This specification governs the quality of **ALLOY 617M** forgings.

2.0 APPLICATION:

For small forgings of turbine

3.0 COMPLIANCE WITH NATIONAL/INTERNATIONAL STANDARDS

Based on VdTUV Data Sheet 485, ASME SB-564 (non-destructive examinations).

4.0 CONDITION OF DELIVERY

Heat-treated and machined condition as per the ordering drawing.

5.0 DIMENSION AND TOLERANCES

Forgings shall be supplied to the dimensions and tolerances as per the ordering drawing.

6.0 MANUFACTURING

6.1 GENERAL REQUIREMENTS

The manufacturer shall submit a flow chart of the manufacturing sequence for the forging.

6.2 MELTING PROCESS

Alloy 617M shall be produced by using vacuum induction melting (VIM) followed by vacuum arc re-melting (VAR) or electro slag refining (ESR). Any other suitable melting and re-melting processes shall be used only after approval from the purchaser.

6.3 FORGING PROCESS

Overall forging ratio (ratio of reduction) shall be greater than 3. The forging ratio employed shall be included in the test certificates. There shall be sufficient ingot discard to ensure elimination of shrinkage cavities and segregation. A record of ingot weight and discard percentages shall be provided for information purpose. Forgings shall be manufactured as close as practicable to finish shape and size.

6.4 HEAT TREATMENT

The material shall be supplied in solution annealed condition with heat treatment suitable to provide grain size as per clause 7.2.4. The minimum heat treatment temperature shall be 1100°C.

Before starting the quality heat treatment, the manufacturer shall submit sketch with the dimensions for heat treatment for information. The heat treatment temperature and time shall be recorded and the records shall be made available to the inspection agency.

6.5 MACHINING

The surface condition shall meet the requirements of various non-destructive examinations.

7.0 PROPERTIES AND TESTS

7.1 CHEMICAL COMPOSITION: Heat Analysis in weight%

The material shall conform to the chemical composition (in weight %) limits specified in Table-1. The chemical analysis shall be carried out as per ASTM E-350 or equivalent method.

7.2 MECHANICAL PROPERTIES

7.2.1 Tangential or Radial Specimens:

The manufacturer shall test tangential or radial test specimens taken from forgings after heat treatment. The location of tensile specimens (distance from the heat treatment surface shall be minimum 40mm) shall be indicated. The following properties shall be achieved at room temperature:

0.2% Yields strength: $\geq 300 \text{ N/mm}^2$

Tensile strength: $\geq 650 \text{ N/mm}^2$

% Elongation ($L = 5.65\sqrt{A}$) $\geq 30\%$

% Reduction in Area shall be noted for information purpose.

Additionally, tensile test shall be carried out at 720°C and results to be submitted for information purpose.

7.2.2 Retest

When mechanical test results do not meet the requirements, retesting can be carried out for the test for which results are not satisfactory. Two retests shall be performed for each unsatisfactory result obtained with specimens taken close to the region from where earlier defective specimens were taken and failing which the part will be rejected.

7.2.3 Re-heat-treatment

The forgings rejected on the basis of unsatisfactory results for one or more mechanical tests may be re-heat-treated, the condition for which shall be described in the test report. All the mechanical tests with the same number of tests specified for the original forging shall be repeated. No more than two re-heat treatment shall be allowed.

7.2.4 Grain Size

Grain size distribution in the forging shall be within the ASTM grain size nos. 2-5. Isolated grain size coarser than ASTM 2 can be accepted but grain size coarser than ASTM 0 is not acceptable.

7.3 NON DESTRUCTIVE EXAMINATION

7.3.1 Surface Examination – Surface Defects

Forgings shall be visually examined. Their surface shall be plain, uniform and free from wrinkles, overlaps, tears, cracks and any other injurious defects. After cutting to as-delivered dimensions, the edges shall be visually examined. There shall be no cleavage or lamination.

If the above mentioned examinations detect defects in the forgings, they cannot be accepted as it is, and the requirements of section 7.3.4 and 11.0 of this specification shall apply.

7.3.2 Liquid Penetrant Inspection

Each forging shall be subjected to 100 % liquid penetrant inspection. The test procedure and acceptance shall be as per supplementary requirements stated in ASME SB-564.

7.3.3 ULTRASONIC EXAMINATION

Each forging shall be subjected to 100% ultrasonic examination by longitudinal wave technique. The test procedure shall be as per supplementary requirement stated in ASME SB-564 except that the flat – bottomed reference hole of 4 mm diameter shall be the acceptance criteria for radial. The examination shall be axially on both the sides and circumferentially. Indication observed if any, in the axial shall be reported for information. The examination shall also be carried out with bottomed reference hole of 1.5 mm diameter and indications, if any, shall be reported for information.

7.3.4 Removal of Unacceptable Areas

Small surface defects may be removed by grinding or chipping provided the thickness remains locally within the part tolerances. The supplier may propose removing larger defects by the same method. In this case, the supplier shall present a report to the purchaser giving a detailed description of the detected defects (location, size, seriousness). This proposal shall be accepted only if the purchaser judges the remaining thickness to be sufficient with the safety coefficients applied to the equipment design taken into account. No weld repairs are acceptable.

7.4 DIMENSIONS & TOLERANCES

Dimensions and tolerances shall be as per purchase order / ordering drawing.

8.0 MARKING

The supplier shall mark each forging with identification number. This is to be punched on the front face of the forging (as marked in the respective drawing), at reference clock position 12 and is to be bordered with oil paint. This shall be confirmed with authorized work inspector's stamp next to the identification number.

9.0 DOCUMENTATION:

The supplier shall furnish 4 copies of test certificates unless and otherwise stated on the order. The test certificates shall bear the following information:

- b) Mechanical test results (all individual values & test piece locations are to be indicated).
- c) Ultrasonic examination results (type of instrument, test probe, adjustment and test sensitivity are to be mentioned).
- d) Dimensional data sheet about the dimensional inspection.

10.0 CLEARANCE FOR DELIVERY:

The entire results of test performed are deciding factors for the clearance of the delivery. The purchaser shall evaluate the total results with respect to intended operational requirements for the forging and judge accordingly the permissibility of deviations (if any) of the properties of the piece required.

The clearance does not relieve the manufacturer from the responsibility for hidden impermissible defects, which may be found later on.

11.0 DEVIATIONS:

Deviations from this Purchase Specification (if any), which may arise during manufacturing, shall be submitted to the purchaser in writing giving full details of the deviations. Acceptance of concession request will be at the sole discretion of the purchaser.

12.0 PACKING & DISPATCH:

Before dispatch, the forging shall be suitably packed to prevent corrosion and damage during transit.

Each forging shall be coated with oil, covered with polythene sheets and waterproof paper and then packed in a sea-worthy export wooden crate. Shipment of forgings shall be done after conducting all tests as mentioned above in the presence of purchaser's authorized representative and after all the test reports are scrutinized by the purchaser and accepted.

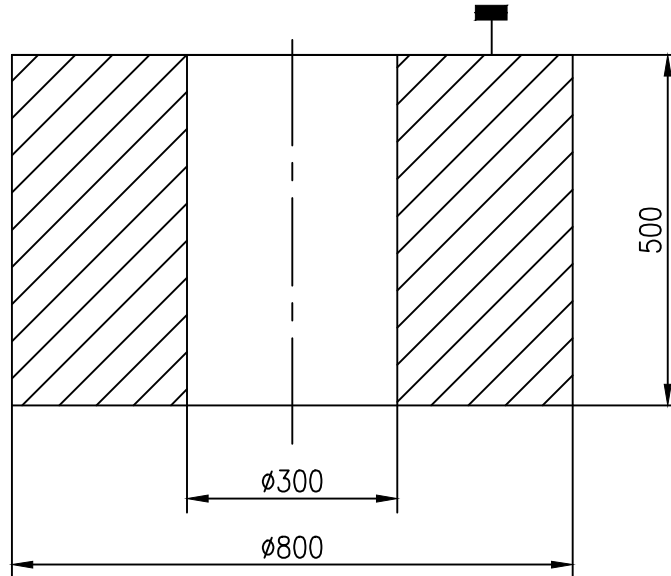

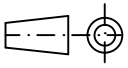

Integrity Pact Format

INTEGRITY PACT

Between

Bharat Heavy Electricals Ltd. (BHEL), a company registered under the Companies Act 1956 and having its registered office at "BHEL House", Siri Fort, New Delhi – 110049 (India) hereinafter referred to as "The Principal", which expression unless repugnant to the context or meaning hereof shall include its successors or assigns of the ONE PART

and

_____. (description of the party along with address), hereinafter referred to as "The Bidder/ Contractor" which expression unless repugnant to the context or meaning hereof shall include its successors or assigns of the OTHER PART

Preamble

The Principal intends to award, under laid-down organizational procedures, contract/s for

_____. The Principal values full compliance with all relevant laws of the land, rules and regulations, and the principles of economic use of resources, and of fairness and transparency in its relations with its Bidder(s)/ Contractor(s).

In order to achieve these goals, the Principal will appoint Independent External Monitor(s), who will monitor the tender process and the execution of the contract for compliance with the principles mentioned above.

Section 1 – Commitments of the Principal

1.1 The Principal commits itself to take all measures necessary to prevent corruption and to observe the following principles:-

1.1.1 No employee of the Principal, personally or through family members, will in connection with the tender for, or the execution of a contract, demand, take a promise for or accept, for self or third person, any material or immaterial benefit which the person is not legally entitled to.

1.1.2 The Principal will, during the tender process treat all Bidder(s) with equity and reason. The Principal will in particular, before and during the tender process, provide to all Bidder(s) the same information and will not provide to any Bidder(s) confidential / additional information through which the Bidder(s) could obtain an advantage in relation to the tender process or the contract execution.

1.1.3 The Principal will exclude from the process all known prejudiced persons.

1.2 If the Principal obtains information on the conduct of any of its employees which is a penal offence under the Indian Penal Code 1860 and Prevention of Corruption Act 1988 or any other statutory penal enactment, or if there be a substantive suspicion in this regard, the Principal will inform its Vigilance Office and in addition can initiate disciplinary actions.

Section 2 – Commitments of the Bidder(s)/ Contractor(s)

2.1 The Bidder(s)/ Contractor(s) commit himself to take all measures necessary to prevent corruption. He commits himself to observe the following principles during his participation in the tender process and during the contract execution.

2.1.1 The Bidder(s)/ Contractor(s) will not, directly or through any other person or firm, offer, promise or give to the Principal or to any of the Principal's employees involved

in the tender process or the execution of the contract or to any third person any material, immaterial or any other benefit which he / she is not legally entitled to, in order to obtain in exchange any advantage of any kind whatsoever during the tender process or during the execution of the contract.

- 2.1.2 The Bidder(s)/ Contractor(s) will not enter with other Bidder(s) into any illegal or undisclosed agreement or understanding, whether formal or informal. This applies in particular to prices, specifications, certifications, subsidiary contracts, submission or non-submission of bids or any other actions to restrict competitiveness or to introduce cartelization in the bidding process.
- 2.1.3 The Bidder(s)/ Contractor(s) will not commit any penal offence under the relevant IPC/ PC Act; further the Bidder(s)/ Contractor(s) will not use improperly, for purposes of competition or personal gain, or pass on to others, any information or document provided by the Principal as part of the business relationship, regarding plans, technical proposals and business details, including information contained or transmitted electronically.
- 2.1.4 The Bidder(s)/ Contractor(s) will, when presenting his bid, disclose any and all payments he has made, and is committed to or intends to make to agents, brokers or any other intermediaries in connection with the award of the contract.
- 2.2 The Bidder(s)/ Contractor(s) will not instigate third persons to commit offences outlined above or be an accessory to such offences.

Section 3 – Disqualification from tender process and exclusion from future contracts

If the Bidder(s)/ Contractor(s), before award or during execution has committed a transgression through a violation of Section 2 above, or acts in any other manner such as to put his reliability or credibility in question, the Principal is entitled to disqualify the Bidder(s)/ Contractor(s) from the tender process or take action as per the separate "Guidelines on Banning of Business dealings with Suppliers/ Contractors", framed by the Principal.

Section 4 – Compensation for Damages

- 4.1 If the Principal has disqualified the Bidder from the tender process prior to the award according to Section 3, the Principal is entitled to demand and recover the damages equivalent Earnest Money Deposit/Bid Security.
- 4.2 If the Principal has terminated the contract according to Section 3, or if the Principal is entitled to terminate the contract according to section 3, the Principal shall be entitled to demand and recover from the Contractor liquidated damages equivalent to 5% of the contract value or the amount equivalent to Security Deposit/Performance Bank Guarantee, whichever is higher.

Section 5 – Previous Transgression

- 5.1 The Bidder declares that no previous transgressions occurred in the last 3 years with any other company in any country conforming to the anti-corruption approach or with any other Public Sector Enterprise in India that could justify his exclusion from the tender process.
- 5.2 If the Bidder makes incorrect statement on this subject, he can be disqualified from the tender process or the contract, if already awarded, can be terminated for such reason.

Section 6 – Equal treatment of all Bidders/ Contractors/ Sub-contractors

- 6.1 The Bidder(s)/ Contractor(s) undertake(s) to obtain from all subcontractors a commitment consistent with this Integrity Pact and report Compliance to the Principal. This commitment shall be taken only from those sub-contractors whose contract value is more than 20 % of Bidder's/ Contractor's contract value with the Principal. The Bidder(s)/ Contractor(s) shall continue to remain responsible for any default by his Sub-contractor(s).
- 6.2 The Principal will enter into agreements with identical conditions as this one with all Bidders and Contractors.
- 6.3 The Principal will disqualify from the tender process all bidders who do not sign this pact or violate its provisions.

Section 7 – Criminal Charges against violating Bidders/ Contractors /Sub-contractors

If the Principal obtains knowledge of conduct of a Bidder, Contractor or Subcontractor, or of an employee or a representative or an associate of a Bidder, Contractor or Subcontractor which constitutes corruption, or if the Principal has substantive suspicion in this regard, the Principal will inform the Vigilance Office.

Section 8 –Independent External Monitor(s)

- 8.1 The Principal appoints competent and credible Independent External Monitor for this Pact. The task of the Monitor is to review independently and objectively, whether and to what extent the parties comply with the obligations under this agreement.

- 8.2 The Monitor is not subject to instructions by the representatives of the parties and performs his functions neutrally and independently. He reports to the CMD, BHEL.
- 8.3 The Bidder(s)/ Contractor(s) accepts that the Monitor has the right to access without restriction to all contract documentation of the Principal including that provided by the Bidder(s)/ Contractor(s). The Bidder(s)/ Contractor(s) will grant the monitor, upon his request and demonstration of a valid interest, unrestricted and unconditional access to his contract documentation. The same is applicable to Sub-contractor(s). The Monitor is under contractual obligation to treat the information and documents of the Bidder(s)/ Contractor(s) / Sub-contractor(s) with confidentiality.
- 8.4 The Principal will provide to the Monitor sufficient information about all meetings among the parties related to the contract provided such meetings could have an impact on the contractual relations between the Principal and the Contractor. The parties offer to the Monitor the option to participate in such meetings.
- 8.5 As soon as the Monitor notices, or believes to notice, a violation of this agreement, he will so inform the Management of the Principal and request the Management to discontinue or take corrective action, or heal the situation, or to take other relevant action. The Monitor can in this regard submit non-binding recommendations. Beyond this, the Monitor has no right to demand from the parties that they act in a specific manner, refrain from action or tolerate action.
- 8.6 The Monitor will submit a written report to the CMD, BHEL within 8 to 10 weeks from the date of reference or intimation to him by the Principal and, should the occasion arise, submit proposals for correcting problematic situations.
- 8.7 The CMD, BHEL shall decide the compensation to be paid to the Monitor and its terms and conditions.
- 8.8 If the Monitor has reported to the CMD, BHEL, a substantiated suspicion of an offence under relevant IPC / PC Act, and the CMD, BHEL has not, within reasonable time, taken visible action to proceed against such offence or reported it to the Vigilance Office, the

Monitor may also transmit this information directly to the Central Vigilance Commissioner, Government of India.

8.9 The number of Independent External Monitor(s) shall be decided by the CMD, BHEL.

8.10 The word 'Monitor' would include both singular and plural.

Section 9 – Pact Duration

9.1 This Pact begins and shall be binding on and from the submission of bid(s) by bidder(s). It expires for the Contractor 12 months after the last payment under the respective contract and for all other Bidders 6 months after the contract has been awarded.

9.2 If any claim is made / lodged during this time, the same shall be binding and continue to be valid despite the lapse of this pact as specified as above, unless it is discharged/ determined by the CMD, BHEL.

Section 10 – Other Provisions

10.1 This agreement is subject to Indian Laws and jurisdiction shall be registered office of the Principal, i.e. New Delhi.

10.2 Changes and supplements as well as termination notices need to be made in writing. Side agreements have not been made.

10.3 If the Contractor is a partnership or a consortium, this agreement must be signed by all partners or consortium members.

10.4 Should one or several provisions of this agreement turn out to be invalid, the remainder of this agreement remains valid. In this case, the parties will strive to come to an agreement to their original intentions.

10.5 Only those bidders/ contractors who have entered into this agreement with the Principal would be competent to participate in the bidding. In other words, entering into this agreement would be a preliminary qualification.
