DEFINITION

Registered Vendors - Are those who are registered with BHEL, Haridwar for procurement of Tool Steel Plates/Flats as per Grade T90MN6WCR2-A.

Un-registered Vendors - Are those who are not registered with BHEL, Haridwar for procurement of Tool Steel Plates/Flats as per Grade T90MN6WCR2-A.

Vendors must fill up Annexure– III in confirmation to above Minimum Qualifying Requirements and quality requirement.

ESSENTIAL INSTRUCTIONS

1. All un-registered vendors shall be approved by BHEL, if found suitable, on the basis of data furnished by them in Supplier Registration Form (SRF) Foreign Vendors or Indigenous Vendors. Vendor (s) shall not be considered for ordering if not approved by BHEL.
2. BHEL team may visit the vendor (s) works for verification of capability and capacity claimed in tender documents/offer (s).
3. The tender document must comprise of three envelopes:
 - i) Envelope I : Pre- Qualifying Requirement & Supplier Registration Form.
 - ii) Envelope II : Techno -Commercial Bid.
 - iii) Envelope III : Price Bid.
4. The tenders shall be submitted in three parts
 - i. Part I - Techno -Commercial Bid,
