**1. EXPERIENCE:**

The vendor shall be a regular manufacturer of Plug in Brush Holders and plug-in-brush holder housings suitable for Carbon brushes of minimum cross-section 10cm<sup>2</sup> to transfer electric current from static to rotating part and vice versa.

- a) In support of above, Vendor shall furnish their standard product catalogue and their experience list (Not older than 10 years on the date of enquiry) in following format to BHEL:

- b) Vendor must furnish at least two unpriced Purchase Orders and corresponding test certificates from the above list. The test certificates must be accepted by Customer or certified by third party inspection agency. The above certificates should contain information like Spring materials, housing materials, chemical analysis, Mechanical properties, Dimensional report, Brush pressure, Insulation Resistance, Current rating etc.
- c) The Vendor shall furnish a sample Manufacturing, Inspection and Test Plan (MITP) of the plug in Brush Holders and Plug in Brush Holder Housings manufactured by them.

**2. MANUFACTURING FACILITIES:**

The vendor should have manufacturing facilities like Casting, Machining, etc. for Plug in Brush Holders and Plug in Brush Holder Housing used in Electrical Machines. Details of facilities to be furnished. If the vendor plans to outsource any activity particulars of the same along with details of the sub-vendor/laboratory are to be furnished to BHEL.

**3. TESTING FACILITIES:**

The vendor should have facilities for carrying out the tests as mentioned in the respective drawing of Brush holders and provide details (including make and model) of test equipment available at their works. The testing facilities should be duly calibrated against national or international measurement standards. If the vendor plans to outsource any activity, particulars of the same along with details of the sub-vendor/laboratory are to be furnished to BHEL.

4. Vendor shall confirm to meet all the technical and dimensional requirements of Drg.31430501015 and 31430501084. Vendor also confirm that both the items (Plug-in Brush Holder and Plug-in Brush holder Housing) are compatible to each other regarding assy, current rating.
5. Vendor shall confirm to meet the current transfer requirement of 125 Amperes and 125\*5=625 Amperes@ 600V DC for continuous operation for brush holder and plug-in brush holder housing respectively.
