- b. Balance sheet and Profit & Loss Account & ITR of last 3 years (FY 16-17, 17-18 & 18-19).
- c. For manufacturer: Capabilities with respect to personnel, equipment and manufacturing Facilities.
Or for Trader/Dealer/Agent etc.
 - a. Authorization letter from their principal is mandatory
 - b. In case of foreign principal: An agency agreement deed copy is required.

5. Test certificate required along with each lot of supply.
