4	The Contract period of the work is 12 months and maintenance period of the work is 03 months.
5	All the terms & conditions of the contract with respect to Taxes & Duties are subject to the new taxation laws introduced from time to time (e.g., GST). The terms & conditions will be modified in accordance with the provisions of new laws (e.g., GST)
6	All the materials are in the agency scope only (Coconut brushes, dusters, bleaching powder, stools arrangement at tanks etc). Consumption of materials shall as specified in the schedule items, materials usage shall be attested by the quarters residents wh
7	Cleaning of Over Head Tanks Shall be done two times in a year
8	No payment shall be made to contractor if any rejected / imperfect / damaged materials is used in the works.
9	During execution of work, photographs shall be taken before and after completion of the work by providing unique number on the tanks and same may be submitted at the time of processing of bills.
10	In addition to regular manpower deployed in the work, the contractor, at his own cost, has to deploy one authorised person for effective supervision of work. if the contractor is unable to provide the same, a penalty of Rs. 1000/- per day shall be deducte
11	The progress of work shall be reviewed every three months and in the event of non-achievement of the milestones as mentioned in the agreement, penalty of 2% shall be imposed on the executed within three months of the commencement for that billing period.
12	Contractor during the work and till the completion of the maintenance period shall have to rectify all the defects to the satisfaction of engineer-in-charge. All the expenditure incurred towards rectification shall be born by the contractor only.
13	Water and Power charges shall be recovered as per Company rules.
