1. QUOTATION: Each tender should be sent in sealed covered with tenderer's distinctive seal and super scribed with correct tender No. Item of supply and due date of opening.

Tenders should be free from CORRECTIONS AND ERASURES: Corrections if any, must be attested. All amounts shall be indicated both in words shall prevail.

- 2. TERMS OF PAYMENT: Payment will be made only after receipt of LR acknowledgement.
- 3. LIQUIDATED DAMAGES: It is clearly among the parties to the contract that time is the essence of the contract. Therefore the delivery of the goods specified, in the purchase order should be made within the time limit prescribed. Where the seller supplies or dispatches the goods beyond the delivery period specified, the purchaser will have no obligation to accept the goods if accepted liquidated damages, at the rate of ½% of the value of goods delayed for each week of delay or part thereof subject to a maximum of 10% of the order value will be levied without prejudice to any other relief or compensation due to the purchaser under any other condition of this contract.

This shall also include Transit Insurance of all the items. Work shall commence immediately after order placement without any delay.
- 2) A certificate will be issued to the transporter at the time of dispatch stating that "These PCs are not for sale and are being sent to sister unit HPVP Visakhapatnam, on free of cost basis, for their official use on nonreturnable basis".
- 3) The packing requirement are as follows
  - i. CPU and Monitor of each PC to be packed in separate cardboard boxes with bubble sheet wrapping and thermocole packing.
  - ii. Keyboards, mouses and cables of the PCs are to be packed in separate cardboard boxes.
- 4) The bidder shall ensure enough availability of labour / staff at packing, loading and unloading points.
- 5) There should not be any damage during transit. If any such damage is found, insurance shall be claimed and the due amount shall be paid to BHEL. Bills shall not be cleared until any such due amount because of transit damage is paid by the bidder.
