1 Manufacturing Capability

Manufacturer of applicable type of lighting fixtures as per BHEL-PEM sub-vendor list (Refer Note 3 below)

2 Lighting System Design Capability

Availability of customer approved lighting system design drawings for power plant/ process plant/ refinery/ industry/ sub-station/ other public installations. The drawings should not be more than (5) years old from the date of application for registration or date of techno-commercial bid opening (as applicable) for establishing continuity in business.

Notes:

1. In case vendor is able to meet criteria at Sl. No: 1 only and not Sl. No: 2 above (or vice-versa), vendor may furnish MOU on non-judicial stamp paper of Rs. 100 /- with any other party meeting the criteria at Sl. No: 2 (or 1) above. Bidder to indicate the scope matrix clearly defining their respective roles including design vetting, manufacturing of critical component, supervision of E&C etc. and shall be submitted as part of MOU.
2. Bidder to note that the arrangement of bidding (i.e. MOU on non-judicial stamp paper) once offered to BHEL as a part of bidding documents cannot be changed till the execution of the project.
3. For Cases of registration, BHEL-PEM sub-vendor list of applicable type of lighting fixtures may be obtained from BHEL-PEM. For cases of bidding, sub-vendor list is included in the technical specification.

General Points of PQR:

1. Consideration of offer shall be subject to customer's approval of bidders, if applicable.
2. Bidder to submit all supporting documents in English. If documents submitted by bidder are in language other than English, a self-attested English translated document should also be submitted.
3. Any other project specific requirement shall be as per Annexure – I and bidder shall submit relevant supporting documents.
4. Notwithstanding anything stated above, BHEL reserves the right to assess the capabilities and capacity of the bidder/ collaborators to perform the contract, should the circumstances warrant such assessment in the overall interest of BHEL.
5. After satisfactory fulfilment of all the above criteria/ requirement, offer shall be considered for further evaluation as per NIT and all other terms of the tender.
