2	For Enq SI no 1(a), bidder must be an existing approved vendor of BHEL Piping Centre, Chennai for SW fittings or EIL approved for SW fittings or Forgings.  In case bidder is not qualifying this requirement, bidders quote will not be considered for Enq SI No 1(a).	In case of BHEL Piping Centre approved vendor, vendor code shall be indicated. In case of EIL approved vendor, EIL approval letter shall be submitted.	
3	Current Experience details (within the <b>past 3 years</b> )- Supplier to provide proof of supply and successful execution of orders of SW fittings. Supply experience post to Part I bid opening date will not be considered.  <b>Note</b> : For Startups, experience details within the past 4 years shall be considered. 4	Firm should have made annual turnover of at least <b>Rs. 2 lakhs</b> for anyone of last 3 audited Financial Year (FY 2017-18, 2016-17 or 2015-16). In case of foreign bidder, financial turnover shall be an equivalent of Rs. 2 lakhs in their regional currency.  For foreign bidder, exchange rate as on the date of Part I opening will be considered for arriving at equivalent turnover in INR.  <b>Note</b> : For indigenous Startups or MSE vendors, financial turnover criterion is relaxed to Rs. 1 lakh.	1. Note-

2. Bidders proposing to avail MSE/Startup relaxation as indicated in points no 3 and 4 above shall submit applicable documentary proof along with Pre-Qualification bid. In case the required documents are not submitted by the bidder, no relaxation will be provided.
  - a. For Startups - Certificate of Recognition by Department of Industrial Policy & Promotion.
  - b. For MSE - UAM No (notarized copy of UAM) for MSE registration along with latest CA certificate.
3. Notwithstanding anything stated above, BHEL reserves the right to assess the capabilities and capacity of the bidder to perform the contract in the overall interest of BHEL.
4. In case any information regarding any of the PQR conditions is suppressed/ altered / modified in order to participate in the tender, legal action as per extant guidelines shall be taken against the firm.
