### **1.3 Schedule C**

It consists of details of tools & tackles provided by BHEL either on higher basis or on free of cost basis which are mentioned in price bid.

**2.0** The work to be carried out under the contract shall, except as otherwise provided in tender conditions, include all labour, materials, tools, plant, equipment, and transport which may be required in preparation of and for full & entire execution and completion of the Works. The descriptions given in the Schedule of Quantities shall, unless otherwise stated, be held to include waste on materials, carriage and cartage, carrying in return of empties, hoisting, setting, fitting and fixing in position and all other labours necessary in and for the full and entire execution and completion as aforesaid in accordance with good practice and recognized principles as laid down in Technical Specification & elsewhere in Tender Specification.

**3.0** The price bid should not contain any condition. Conditional price Bids shall be summarily rejected.

**4.0** The bidder should not leave any column blank in Price Schedules.

**5.0** Price Quoted shall include all taxes, & duties except **GST**.

**6.0** Unless otherwise specified in the items involving cement, reinforcement steel or structural steel, these items shall be issued free of cost by BHEL.

1	Cleaning of dust, dirt , cobweb, loosely adhering foreign particles including scrapping of scale etc. i/c all tools and tackels from structural steel members by scrubbing with wire brush or with any other suitable mechanical means such as hand grinder etc., applying one or more coats of suitable primer primer of approved brand and manufacture, followed by two or more coats of suitable paint of approved brand and manufacture of required colour to give an even shade on structural steel members at height upto the 8 mtr to the entire satisfaction of the engineer-in-charge. Note -

- a) The payment for scraping and painting shall be made on the basis of actual surface area painted for all structural members like column, purlins, runner , rain water gutter etc. except the trusses.  
b) For scraping and painting of structural steel trusses, the elevational area shall be paid once only for painting of trusses completely (i.e. On both faces of the trusses).
- The contractor shall bring all the required tools & plants and labourers to carry out the work.
- All the Safety Rules for working at height must be followed including use of required PPEs such as safety helmets, safety belt etc.
- The contractor shall engage only those workers in the work who are appropriately insured as per the statutory requirements .
- All the workmen engaged must be medically fit for working at height .Certificate to this effect obtained from a registered medical practitioner having a minimum of MBBS degree shall be submitted by the contractor to the department.
- Wherever required, proper electric shut down permission shall be obtained in writing from authorised official of the user department and also ensured proper shut down before work.
- Rate shall be inclusive of all taxes/duties/royalties, if applicable but excluding GST.
