PREAMBLE OF PRICE BID

1.0 This Price Bid consists of Three Schedule:

1.1 Schedule A

Schedule A consists of One Annexure:

Total price of the package combining Annexure I to be quoted by the bidders which shall form the basis for comparison for deciding lowest bid. For further processing and award, total quoted amount by the L1 (lowest) bidder for the package shall be used for deriving individual item rate by BHEL based on % (percentage) weightage specified at Annexure-I of Price Schedule.

1.2 Schedule B

It consists of details of free issue materials by BHEL.

1.3 Schedule C

It consists of details of tools & tackles provided by BHEL either on higher basis or on free of cost basis which are mentioned in price bid.

2.0 The work to be carried out under the contract shall, except as otherwise provided in tender conditions, include all labour, materials, tools, plant, equipment, and transport which may be required in preparation of and for full & entire execution and completion of the Works. The descriptions given in the Schedule of Quantities shall, unless otherwise stated, be held to include waste on materials, carriage and cartage, carrying in return of empties, hoisting, setting, fitting and fixing in position and all other labours necessary in and for the full and entire execution and completion as aforesaid in accordance with good practice and recognized principles as laid down in Technical Specification & elsewhere in Tender Specification.

3.0 The price bid should not contain any condition. Conditional price Bids shall be summarily rejected.

4.0 The bidder should not leave any column blank in Price Schedules.

5.0 Price Quoted shall include all taxes, & duties except **GST**.

6.0 Unless otherwise specified in the items involving cement, reinforcement steel or structural steel, these items shall be issued free of cost by BHEL.

1	Providing and running water tanker of capacity 4000 litres or more mounted on truck/tractor on hire basis for supply of water to various locations within factory area. Hiring may, if required, extend for 3 shifts per day (Each shift of 8 working hours). The rate will be inclusive of all the expenses like hire charges of tanker mounted on truck/tractor, diesel, oil, grease etc. and also its repair and necessary manpower required, like one driver and one male majdoors associated with each tanker and including lifting diesel pump , delivery pipe as per the requirement up to height of 15m or more of Annex/Other building/blocks/Shops etc.(Only water with water points will be provided by the department free of cost for filling the water tanker)	452.00	per no. of truck (with tanker) per shift	100.00

Note:

- 1 The above items shall be governed by the special conditions attached herewith.
- 2 The helper engaged in this work should be covered under PF & ESI. Since, the vehicles shall be engaged on hire basis by the contractors, the driver shall be covered under comprehensive workmen compensation act. The tenderer/Contractors has to take special care of this point before quoting the rates.
- 3 The contractor shall ensure that throughout the contract period and time extension provided thereof the drivers that are deployed in the work are medically fit and holder of valid driving licence to operate these machines/vehicles. The vehicles engaged in the work shall have all valid RTO papers such as registration, insurance valid fitness certificate etc.
- 4 If required, the work shall be done in two/three shifts per day. For working in 2nd and 3rd shifts, nothing extra over and above the quoted rate shall be payable by BHEL.
- 5 The requirement of water tanker mounted on truck. If urgency so demands, more than one water tanker mounted on truck shall be deployed as per instruction of engineer-in-charge.
- 6 The make of the truck shall be of the year 2010 or later.
- 7 The above work is for Twelve months wherein no price variation clause (PVC) is applicable. The contractor is advised to take note of the above before quoting his rates.
- 8 Contractor shall ensure payment of minimum wages prescribed by BHEL (which is inclusive of statutory minimum wages of MP govt. and additional wages of BHEL) as applicable from time to time (vide Annexure- "X" attached herewith) in the presence of authorized representative of BHEL and maintain proper records of their timely disbursement. These records need to be preserved for a period of at least Three years and should be made available even after the contract is over for any verification by the statutory authorities/BHEL authorities.
- 9 Services of water tanker shall be provided to any location/area purposes as required as per direction of engineer-in-charge.

SPECIAL CONDITION

Hiring of water tanker mounted on truck/tractor including manpower and lifting diesel pump inside factory area.

- 1 The water tanker of capacity 4000 litre or more mounted on truck/tractor of with tanker and diesal pump capable of lifting water of height of 15m or more shall be provided for supply of water in different areas within BHEL factory premises during the shift timings as directed by the Engineer-in-charge.
- 2 The vehicle shall be maintained in good safe working condition and made available without fail for ensuring regular water supply depending on the need and directions given by the Engineer-in-charge.
- 3 All the safety requirements and security formalities shall be followed by the contractor and the driver of tractor should have valid driving licence. The relevant documents pertaining to the vehicle shall have to be submitted in FCX divison.
- 4 Mechanical minor repairs such as puncture, changing of wheels, cleaning of the tanker etc. as necessary will be got done by the contractor at his own cost.
- 5 For item nos.1, rate quoted shall include hire charges of vehicle, consumables, repair and maintenance of vehicle, deployment of driver and one additional labour for starting of the pump and filling water in different water tanks at all locations within the factory premises.
- 6 The consumables required for the pump provided in the tanker (not the departmental tanker) will be to the account of contractor. The contractor shall maintain a log book to record detail of trips as directed by Engineer-in-charge.
- 7 In case contractor fails to provide vehicle or fails to give a replacement Vehicle during the break down period, BHEL reserves the right to engage any tanker and the extra expenses, if any, shall be recoverable from the contractor. The decision of the Engineer-in-charge shall be final and binding on the contractor.
- 8 The general conditions of contract prevailing in BHEL for various civil works shall be applicable for the contract.
- 9 Bill shall be submitted by contractor on monthly basis.
- 10 In case of emergency, the hired vehicle shall have to run on Sundays, Night shifts and holidays also.
- 11 Lunch/Dinner timings of the contractor's workmen shall be suitably adjusted in case tanker is to be run during specified lunch/dinner breaks.
- 12 The contractor is supposed to have understood the scope and nature of work involved in all respects prior to quoting his rate and no claim will be entertained subsequent to opening of tender.
- 13 Vehicle No. should specifically be mentioned and it shall not be used for any other purpose other than water supply during Hire period.
- 14 In case of absence of helper stipulated wage payable along with PF/ESI shall be deducted from the amount payable for that day.
- 15 In case of non deployment of vehicle in case of which work assigned suffers, a penal amount of 1.25 times of the awarded daily rate payable shall be deducted.
- 16 In case of break down of vehicle for more than four hours, alternative arrangement shall be done by agency. If agency fails to deploy within stipulated period, penal amount as indicated in clause 15 shall be deducted.
