NOTES: -

- i) Evaluation of L1 bidder shall be based on **TOTAL PRICE (Rs.) (Sl. No.1+ Sl. No. 2)** mentioned above.
- ii) Bidders should quote only the Total price both in figures & words in the specified place. These rates & amount will be derived from the Total amount quoted and weightage factor assigned against respective items indicated in column J.
- iii) Bidder to note that this is a LUMP SUM Turn-Key Order.
- iv) The rate and amount are inclusive of all applicable taxes, except for the GST. For details of taxes, clause no. 13.0 of the SCC will be applicable.
- v) Bidder to note that manpower requirement may vary as per actual work requirement during O&M period based on the site requirement. If additional man power is required, bidder to augment the same for both Commissioning (including completion of balance jobs) and Operation and Maintenance services. In such case, additional cost shall be paid as per agreed contract rate for the additional manpower deployed and the no. of shifts.
- vi) In the event of any short deployment of manpower from minimum required manpower as envisaged in the contract specification, BHEL shall reserve the right to make proportionate deduction from Bidder's invoice as per contract.
- vii) BHEL reserves the right to extend the O&M works on monthly basis, and if required the DM plant will be operated for 3 shifts. Bidder shall be paid pro-rata based on the price quoted against Sl. No. 1.0 as per the actual days for which the 3rd shift is operated. Bidders to note that 30 days will be considered for one month duration for all calculations.
- viii) Bidder to note that boarding, lodging and travel (both to and fro from Headquarters to project site as well as local travel) are to be borne by bidder and to be included in the quoted prices.
- ix) Bidder shall also submit unpriced copy of the Price-Bid Format indicating "*Quoted*" along with the technical offer.
- x) LOI shall be issued by BHEL PE&SD and Work order shall be placed by our project site i.e. BHEL-PSER, Namrup.
- xi) Payment for O&M shall be done on monthly basis (refer GCC & SCC for detail). However, for Commissioning work as per Sl.No.02 of price bid format shall be paid at the end of completion of Commissioning work as certified by BHEL site engineer.
