- 1) The rates of different items for the entire scope of work shall be derived as per **BOQ Cum Rate schedule (Annexure-II) of TCC**.
- 2) The derived item rate will remain firm throughout the Contract period.
- 3) Bidder's quoted price above shall be complete in all respect for the full scope defined in specification and in accordance with all terms & conditions of tender.
- 4) Contractor shall fully understand description and Specifications of items mentioned in BOQ.
- 5) Conditional price bids with any deviation / clarification etc. are liable to be rejected. No cutting / erasing / over writing shall be done.
- 6) Quantities mentioned in rate schedules are approximate only and liable for variation on either side depending upon site / design requirement. The tentative contract value (CV) of entire scope of work shall be calculated as per finally quoted / accepted rates & the Quantities indicated in BOQ cum Rate Schedule.
- 7) Contractor's total quoted price as per rate schedule will be taken as tentative only. The contractor undertakes to execute actual quantities as per advice of BHEL Engineer and accordingly the final contract price shall be worked out on the basis of quantities actually executed at site and payments will also be regulated for the same.
- 8) In case of any mis-match in rate and amount on price discrepancy, the same will be dealt as per clause no. 1.4 of GCC.
- 9) Rates quoted shall be inclusive of taxes as per relevant clauses in Technical Conditions of Contract.
