<u>SPECIFICATION FOR QUALIFICATION FOR PROCUREMENT OF RUBBER LINIG SYSTEM FOR WET BALL MILLS</u> Part-A 1.0 GENERAL: This specification is intended to evaluate the Qualified Bidders technically and commercially for procurement of complete set of wear resistant rubber lining system (SBR based rubber) for Wet Ball Mill of diameter 3950 mm X length 7490 mm. Set of liner shall include shell liner, Feed end head liners, discharge end head liners along with necessary hardware for fixing arrangement. The Bidder shall refer to the Technical Specification Document No.BA89005 for technical details . 2.0 QUALIFYING REQUIREMENTS 2.1 The bidder shall be Original Equipment Manufacturer. The Bidder should be manufacturing these items at their principal works. 2.2 The bidder should have manufactured and supplied wear resistant rubber lining system for a wet grinding mill application used in either Flue Gas Desulfurization plant or any other application and should have successfully achieved a wear life of minimum 8000 hrs. (without repair or reversal of liners) with typical lime stone with properties as given in Annexure I in at least minimum two different sites prior to date of techno-commercial bid opening. The Award to be given by the Arbitration shall be a speaking award and in English language. All questions, disputes, differences arising under, out of or in connection with this contract shall be exclusive jurisdiction of Sangareddy/Hyderabad Courts, Telangana. 5.0 INSTALLATION AND COMMISSIONING: 5.1 Operation and maintenance manual to be included in all supplies. 5.2 The bidder shall express their willingness to assist BHEL during erection and commissioning, problem solving and training of end-users personnel at their Power Stations. However, if the foreign principal desires to avail the services of an Indian Agent, then the foreign principal should ensure the compliance to regulatory guidelines, which requires mandatory submission of an agency agreement. 6.2 It shall be incumbent on the Indian Agent and the Foreign principal to adhere to the relevant guidelines of Government of India, issued from time to time. 6.3 The agency agreement should specify the precise relationship between the foreign OEM / foreign principal and their Indian agent and their mutual interest in the business. All services to be rendered by agent/ associate, whether of general nature or in relation to the particular contract, must be clearly stated by the foreign supplier/ Indian agent. Any payment, which the agent or associate receives in India or abroad from the OEM, whether as commission or as a general retainer fee should be brought on record in the Agreement and be made explicit in order to ensure compliance to laws of the country. 6.4 Any agency commission to be paid by BHEL to the Indian agent shall be in Indian currency only. 6.5 Tax deduction at source is applicable to the agency commission paid to the Indian agent as per the prevailing rules. 6.6 In the absence of any agency agreement, BHEL shall not deal with any Indian agent (authorized representatives / associate / consultant, or by whatever name called) and shall deal directly with the foreign principal only for all correspondence and business purposes. 6.7 Registered agents will file an authenticated Photostat copy duly attested by a Notary Public/Original certificate of the Principal confirming the agency agreement and giving the status being enjoyed by the agent and the commission/ remuneration/ salary/ retainer ship being paid by the principal to the agent before the placement of order by BHEL. 6.8 Wherever the Indian representatives have communicated on behalf of their principals and the foreign parties have stated that they are not paying any commission to the Indian agents, and the Indian representative is working on the basis of salary or as retainer, a written declaration to this effect should be submitted by the party (i.e. Principal) before finalizing the order. 6.9 Tenderers of Foreign nationality shall furnish the following details in their offers: 6.9.1 The Bidder(s)/ Contractor(s) of foreign origin shall disclose the name and address of the agents/ representatives in India if any and the extent of authorization and authority given to commit the Principals.
