

**Sub: Open tender for providing Cable TV services at BHEL office at Siri Fort, New Delhi-110049**

BHEL intends to enter into two years' rate contract for providing Cable TV on monthly rental basis at BHEL office at Siri Fort, Khelgaon, New Delhi - 110049. In this regard, we are inviting sealed bid in two parts for the subject work.

**1. PRE-QUALIFYING REQUIREMENTS FOR THE BIDDERS:**

**1.1** The service provider must be Delhi based, self-attested copy of address proof must be submitted along with the bid.

**1.2** The service provider has to accept the list of minimum channels included in Annexure B (Diamond Pack) as well as Annexure C (Normal Pack). The signed and stamped copy of Annexure B and Annexure C shall be treated as the acceptance by the service provider.

**1.3** The bidder must have experience of providing cable TV services since the last 3 years ending on 31<sup>st</sup> Oct 2019. A copy of documentary evidence in this regard for similar nature of work being currently executing /executed is to be submitted.

**Note:(i) 'Similar jobs/ services' mentioned in clause 1.3 (above shall be related / refers to 'job / services of Cable TV in Office Premises / Hotels/ Guest House/ Transit Flats etc., out of which at least one should be from central Govt./ State Govt./ PSUs/ Public Limited Company / Private Limited Company.**

**1.4** Self-attested copy of PAN.

**1.5** EMD of ₹ 2796/- (without GST) strictly in accordance with clause No.2.9 of this NIT. MSEs shall be exempted from payments of earnest money provided, if certificate of MSE is enclosed by the MSE party along with the Part-I bid. However, there is no exemption of security deposit submission. The details regarding MSEs are as per tender clause 15.

**Vendors who have already deposited EMD for the tender AA:GAX:19:CT:01 dated 10.10.2019 are not need to deposit the EMD for this tender.**

**2. GENERAL TERMS & CONDITIONS OF TENDER:**

**2.1** The tender enquiry no. & due date must be legibly super scribed on the envelope.

**2.2** Tenders shall be received and opened at BHEL House, Siri Fort, New Delhi on the due date and time as mentioned above in the presence of finance representative and bidders or their authorized representatives who may like to be present.

**2.3** Tenders shall be strictly in accordance with the tender specifications. Any deviation may lead to rejection of tender.



**2.4** The offers shall remain valid for 90 days' period from the due date of submission of tenders.

**2.5** BHEL shall be under no obligation to accept the lowest or any other tender and shall be entitled to accept or reject any tender in part or full without assigning any reason whatsoever.

**2.6** Tenders received after due date & time are liable to be rejected.

**2.7** Tender should be submitted along with covering letter of the tenderer and each page of the tender document must be stamped and duly signed by tenderer.

**2.8** Price quoted by the tenderers will be firm and no escalation on account of labour, material or any other reason whatsoever will be paid to the successful tenderer for execution of the above work. However, any change in taxes during the currency of contract will automatically be from the part of contract.

**2.9 EMD:** Each bidder, participating in the tender has to deposit an **EMD of ₹ 2796.00/-** in any of the following forms:

a) Cash deposit as permissible under the extant Income Tax Act (before tender opening);

b) Electronic Fund Transfer credited in BHEL account (before tender opening);

c) Banker's cheque /Pay order/Demand draft, in favour of BHEL (along with offer), payable at New Delhi.

d) Fixed Deposit Receipt (FDR) ISSUED BY Scheduled banks /Public Financial Institutions as defined in the Companies Act (FDR should be in the name of the contractor, a/c BHEL)

**2.9.1** EMD by bidder will be forfeited, if:

i) After opening the tender and within the offer validity period, the tenderer revokes his tender or makes any modification in his tender which is not acceptable to BHEL.

ii) The contractor fails to deposit the required security deposit or commence the work within the period as per LOI/Contract.

iii) EMD by the tenderer shall be withheld in case any action on the tenderer is envisaged under the provisions of extant "guidelines on suspension of business dealing with suppliers/Contractors" and forfeited/released based on the action as determined under these guidelines.

**2.9.2** EMD given by all unsuccessful tenderers shall be refunded normally within fifteen days from award of work.

**2.9.3** EMD shall not carry any interest.

**2.9.4** Each tender shall be accompanied by separate envelope carrying EMD as mentioned above failing which the tender will be rejected.

**2.10** The bidder along with its associate /collaborators /sub-contractors/sub-vendors /consultants /service providers shall strictly adhere to BHEL fraud prevention policy displayed on BHEL web site:<http://bhel.com> and shall immediately bring to the notice of BHEL Management about any fraud or suspected fraud as soon as it comes to their notice.

**3.0 EVALUATION CRITERIA:** Evaluation of the tender will be done on overall cost to company. The L1 bidder will be decided on the basis of S. No. 5 of Annexure-A5. In the event of more than one bidder having identical lowest amount in aforesaid S.No-5 and there is a tie amongst the bidders, the respective bidders would be asked to submit their revised rates. This process would continue till the distinct L1 rate is arrived

#### **4.0 SCOPE OF WORK:**

**4.1** The service provider will quote for Diamond Pack (as per Annexure-B) & Normal Pack (as per Annexure-C).

**4.2** The service provider has to provide the services for list of channels included in the Annexure B as well as Annexure C. No payment shall be made by BHEL for showing any extra channel/channels other than the list as per the above Annexures.

**4.3** No channel/s shall be excluded from the list of channels as per the Annexure B as well as Annexure C. Means these are the minimum no. of channels which service providers has to serve

**4.4** The CATV network shall be maintained up to the STB by the service provider and maintenance of proper signal strength shall be their responsibility. No extra charges shall be paid for supply and installation of amplifier, attenuators, splitters, socket, connectors etc. required for providing the CATV signals of required strength.

**4.5** Rates should not be more than the existing TRAI tariff. The rates shall remain firm during the validity of the contract. However, if the rates are reduced by TRAI, then the benefit shall be passed by the service provider to BHEL.

**4.6** The complaints regarding deficiency in service shall be attended and resolved within 24 hours from the time of lodgement of complaint over telephone. Otherwise,

penalty of the amount equal to 2 times of the per day cost (on pro rate basis) of the cable connection shall be deducted for each complaint per day and part thereof. This penalty shall be deducted from the subsequent bill(s). The maximum amount of penalty shall be 10% of the contract value.

**4.7** Set Top Boxes shall be provided by BHEL.

**4.8** Vendor has to quote the price of compatible STBs as per Annexure-A.6. this will not be evaluated at the time of price bid opening. If the need arises for the same, then it will be purchased separately by BHEL by L1 vendor.

**4.9** Supply and the laying of cable wire inside BHEL house shall be in the scope of BHEL.

**4.10** If the services are found to be unsatisfactory, then the contract may be terminated after giving one-month notice.

**4.11** Work order will be placed on the lowest bidder for the complete scope of work.

#### **5.0 VALDITY OF CONTRACT:-**

This contract will be valid initially for two years from the date of award of work. However, BHEL reserves the right to terminate the contract at any time in-between without assigning any reason, for which the service provider will not have any claim whatsoever. The rate contract may be further extended on mutual agreement basis.

#### **6.0 PAYMENT TERMS:**

- i) Bill (on monthly basis) complete in all respect along with all the requisite documents submitted by the service provider(s) to BHEL fortnightly will be paid within 30 days of its receipt and final acceptance of BHEL.
- ii) The 100% payment would be made on the basis of actual number of services or items provided by the service provider(s).
- iii) The service provider(s) will have to intimate the bank account number, and other details of the bank to enable BHEL to credit the payments into the account.
- iv) No interest shall be payable for delay in making the payment. The service provider(s) shall not be entitled to any interest with respect to any money which may be due to him from BHEL.
- v) The contractor has to submit their GST registration certificate to BHEL Corporate Office, Siri Fort, New Delhi within 30 days from the acceptance of work order as per GST rules
- vi) Penalty will be levied by BHEL as per clause No-4.6 of this tender enquiry.

vii) As per company policy, no advance will be given to bidders.

viii) The monthly bill will be prepared and payment will be made as per services covered under the list of channels as per Annexure B (Diamond Pack) & C (Normal Pack) and it will be released on submission of GST compliant invoice through NEFT.

#### **7.0 TAXES & DUTIES:**

- (i) Contractor shall submit GST compliant invoice containing all the particulars as stipulated under Invoice Rules of GST Law. Payment shall be made to the contractor only after submission of GST compliant invoice. The successful service provider(s) shall raise GST compliant invoice affixing GSTIN of BHEL's unit availing the services.
- (ii) BHEL reserves the right to protect its interest against any loss on account of availability of GST credit, wherever such GST ITC is available as per GST Law provisions.
- (iii) GSTIN of BHEL will be provided to the service provider(s) along with the work order.
- (iv) Any new/change in statutory levy as and when made applicable by the Government shall become applicable against documentary evidence.
- (v) Payment to the service provider(s) will be subjected to TDS as per rules in force from time to time. The Tax Deduction at Source (TDS) shall be done as per the provisions of Income Tax Act & GST, as amended from time to time and a certificate to this effect shall be provided to the service provider(s) by BHEL.
- (vi) Applicable GST shall also be recoverable from the service provider(s) in case of LD recovery/penalty on account of breach of terms of contract.

#### **8.0 SECURITY DEPOSIT:**

**8.1.1.1** Security Deposit means the security provided by the Contractor towards fulfilment of any obligations in terms of the provisions of the contract. The total amount of Security Deposit will be 5% of the total contract value. Upon acceptance of tender, the successful bidder must submit the security deposit in any of the following forms:

- i) Cash (as permissible under the extant Income Tax Act)
- ii) Local cheque of Scheduled Banks (subject to realization)/ Pay Order/ Demand Draft/ Electronic Fund Transfer in favour of BHEL
- iii) Bank Guarantee from Scheduled Banks/ Public Financial Institutions as defined in the Companies Act. *{Copy of proper prescribed format of BG will be provided by BHEL along with Work Order/LOI and it will be verified verbatim on receipt with original document}.*

- iv) Fixed Deposit Receipt issued by Scheduled Banks/ Public Financial Institutions as defined in the Companies Act (FDR should be in the name of the Contractor, a/c BHEL)
- v) Securities available from Indian Post offices such as National Savings Certificates, Kisan Vikas Patras etc. (held in the name of Contractor furnishing the security and duly endorsed/ hypothecated/ pledged, as applicable, in favour of BHEL)

**8.2** The security deposit shall not carry any interest.

**8.3** EMD of successful bidder shall be converted into security deposit.

**8.4** The validity of Bank Guarantees towards Security Deposit shall be initially up to the completion period as stipulated in the Letter of Intent/ Award + 6 months, and the same shall be kept valid by proper renewal till the acceptance of Final Bills of the Contractor, by BHEL.

**8.5** BHEL reserves the right of forfeiture of Security Deposit in addition to other claims and penalties in the event of the Contractor's failure to fulfill any of the contractual obligations or in the event of termination of contract as per terms and conditions of contract. BHEL reserves the right to set off the Security Deposit against any claims of other contracts with BHEL.

**9.0 RETURN OF SECURITY DEPOSIT:** Security Deposit shall be refunded/ Bank Guarantee(s) released to the Contractor upon fulfilment of all contractual/ statutory obligations or after expiry of the guarantee period the contract, after deducting all expenses / other amounts due to BHEL under the contract / other contracts entered into with them by BHEL.

**10.0 BANK GUARANTEES:**

Wherever Bank Guarantees are to be furnished/submitted by the contractor, the following shall be complied with:

- i) Bank Guarantees shall be from Scheduled Banks / Public Financial Institutions as defined in the Companies Act.
- ii) The Bank Guarantees shall be as per prescribed formats.
- iii) It is the responsibility of the bidder to get the Bank Guarantees revalidated/extended for the required period, as per the advice of BHEL. BHEL shall not be liable for issue of any reminders regarding expiry of the Bank Guarantees.
- iv) In case the Bank Guarantees are not extended before the expiry date, BHEL reserves the right to invoke the same by informing the concerned Bank in writing, without any advance notice/communication to the concerned bidder.
- v) Bidders to note that any corrections to Bank Guarantees shall be done by the issuing Bank, only through an amendment in an appropriate non-judicial stamp paper.

vi) The Original Bank Guarantee shall be sent directly by the Bank to BHEL under Registered Post (Acknowledgement Due), addressed to the LOI/LOA issuing department.

#### **11.0 REJECTION OF TENDER**

- i. BHEL reserve the right to cancel the tender or reject the lowest or any tender or accept any tender in full or in part without assigning any reasons whatsoever at any stage.
- ii. BHEL reserves the right to accept or reject any of the bid / all bids with or without deviation or cancel / withdraw the invitation for bid without assigning any reason whatsoever and in such case bidder shall have no claim arising out of such action by BHEL. The acceptance of tender will rest with BHEL which does not bind itself to accept the lowest tender or any tender.
- iii. Conditional tenders, unsolicited tenders, tenders which are incomplete or not in the form specified or defective or have been materially altered or not in accordance with the tender conditions, specifications etc., are liable to be rejected.
- iv. Tenders are liable to be rejected in case of unsatisfactory performance of the tenderer with BHEL, or tenderer under suspension (hold/banning /delisted) by any Unit / Region / Division of BHEL or tenderers who do not comply with the latest guidelines of Ministry/Commissions of Govt. of India.
- v. If a bidder who is a proprietor expires after the submission of his tender or after the acceptance of his tender, BHEL may at their discretion, cancel such tender. If a partner of a firm expires after the submission of tender or after the acceptance of the tender, BHEL may then cancel such tender at their discretion, unless the firm retains its character.
- vi. BHEL will not be bound by any Power of Attorney granted by changes in the composition of the firm made subsequent to the execution of the contract. They may, however, recognise such power of Attorney and changes after obtaining proper legal advice, the cost of which will be chargeable to the contractor concerned.
- vii. If the tenderer deliberately gives wrong information in his tender, BHEL reserves the right to reject such tender at any stage or to cancel the contract if awarded and forfeit the Earnest Money/Security Deposit/any other money due.
- viii. Canvassing in any form in connection with the tenders submitted by the Tenderer shall make his offer liable to rejection.
- ix. In case the Proprietor, Partner or Director of the Company/Firm submitting the Tender, has any relative or relation employed in BHEL, the authority inviting the Tender shall be informed of the fact as per specified format, along with the Offer. Failing to do so, BHEL may, at its sole discretion, reject the tender or cancel the contract and forfeit the Earnest Money/Security Deposit.



12.0 "The offers of the bidders who are under suspension as also the offers of the bidders, who engage the services of the banned firms, shall be rejected. The list of banned firms is available on BHEL website [www.bhel.com](http://www.bhel.com).

13.0 Integrity commitment, performance of the contract and punitive action thereof:  
**COMMITMENT BY BHEL:** BHEL commits to take all measures necessary to prevent corruption in connection with the tender process and execution of the contract. BHEL will during the tender process treat all Bidder(s) in a transparent and fair manner, and with equity.

**COMMITMENT BY BIDDER/ SUPPLIER/ CONTRACTOR:** The bidder/ supplier/ contractor commit to take all measures to prevent corruption and will not directly or indirectly influence any decision or benefit which he is not legally entitled to nor will act or omit in any manner which tantamount to an offence punishable under any provision of the Indian Penal Code, 1860 or any other law in force in India.

The bidder/ supplier/ contractor will, when presenting his bid, disclose any and all payments he has made, and is committed to or intends to make to agents, brokers or any other intermediaries in connection with the award of the contract and shall adhere to relevant guidelines issued from time to time by Govt. of India/ BHEL.

The bidder/ supplier/ contractor will perform/ execute the contract as per the contract terms & conditions and will not default without any reasonable cause, which causes loss of business/ money/ reputation, to BHEL.

If any bidder/ supplier/ contractor during pre-tendering/ tendering/ post tendering/ award/ execution/ post-execution stage indulges in mal-practices, cheating, bribery, fraud or and other misconduct or formation of cartel so as to influence the bidding process or influence the price or acts or omits in any manner which tantamount to an offence punishable under any provision of the Indian Penal Code, 1860 or any other law in force in India, then, action may be taken against such bidder/ supplier/ contractor as per extant guidelines of the company available on <http://www.bhel.com> and/or under applicable legal provisions".

14.0 The Bidder along with its associate/ collaborators/ sub-contractors/ sub-vendors/ consultants/ service providers shall strictly adhere to **BHEL Fraud Prevention Policy** displayed on BHEL website <http://www.bhel.com> and shall immediately bring to the notice of BHEL Management about any fraud or suspected fraud as soon as it comes to their notice.

15.0 **PROVISIONS FOR MICRO AND SMALL ENTERPRISES (MSEs)**

Any Bidder falling under MSE category, shall furnish the following details & submit documentary evidence/ Govt. Certificate etc. in support of the same along with their techno-commercial offer.

**Note: - If the bidder does not furnish the above, offer shall be processed construing that the bidder is not falling under MSE category.**

- a) MSE suppliers can avail the intended benefits only if they submit along with the offer, attested copies of either Udyog Aadhaar or EM-II certificate having deemed validity (five years from the date of issue of acknowledgement in EM-II) or valid NSIC certificate or EM-II certificate along with attested copy of a CA certificate (format enclosed as **Annexure-A 8**) where deemed validity of EM-II certificate of five years has expired applicable for the last audited financial year. Date to be reckoned for determining the deemed validity will be the last date of Bid submission. Non-submission of such documents will lead to consideration of their bids at par with other bidders. No benefits shall be applicable for this enquiry if the above required documents are not submitted along with offer. If the tender is to be submitted through e-procurement/tendering portal, then the above required documents are to be uploaded on the portal.
- b) **MSEs shall be exempted from payment of earnest money at the time of tender submission. However, there is no exemption of security deposit submission.**
- c) Participating MSEs quoting price within price band of L1+15 % shall be considered for award of complete scope of work by bringing down their price to L1 price in a situation where L1 price is from someone other than a MSE. In case of more than one such MSE, MSE with lowest price shall be given the first option to match the L1 price. However, MSEs owned by the Scheduled Caste or the Scheduled Tribe entrepreneurs shall be given the preference for matching the L1 price irrespective of their standing in comparative statement of MSE bidders within price band of L1+15 %.
- d) However, credentials of all MSE suppliers will be verified before considering the intended benefits for MSE suppliers at the time of tender evaluation.
- 16.0 RISK & COST:** This clause, in line with other Conditions of Contract will be invoked in any of the following cases. In any of the following cases, the Contractor shall pay the complete / excess cost to be incurred for the completion of the Contract.
- 16.1.1** Contractor/ supplier's poor progress of the work vis-à-vis execution timeline as stipulated in the Contract, backlog attributable to contractor/ supplier including unexecuted portion of work/ supply does not appear to be executable within balance available period (#) considering its performance of execution.
- 16.1.2** Withdrawal from or abandonment of the work by contractor before completion of the work as per contract.
- 16.1.3** Non-completion of work/ Non-supply by the Contractor/ supplier within scheduled completion/delivery period as per Contract or as extended from time to time, for the reasons attributable to the contractor/ supplier.
- 16.1.4** Termination of Contract on account of any other reason (s) attributable to Contractor/ Supplier.

**16.1.5** Assignment, transfer, subletting of Contract without BHEL's written permission resulting in termination of Contract or part thereof by BHEL.

**16.1.6** Non-compliance to any contractual condition or any other default attributable to Contractor/ Supplier.

*#In-case inputs from BHEL are likely to be delayed or are actually delayed, this delay may also be taken into account while considering balance period available for execution of Contract.*

**17.0** The Tender submitted by a techno commercially qualified bidder shall become the property of BHEL who shall be under no obligation to return the same to the bidder. However unopened price bids and late tenders shall be returned to the bidders.

**18.0** Unsolicited discount received after the due date and time of Bid Submission shall not be considered for evaluation. However, if the party who has submitted the unsolicited discount/rebate becomes the L-1 party, then the awarded price i.e. contract value shall be worked out after considering the discount so offered.

**19.0** BHEL shall not be liable for any expenses incurred by the bidder in the preparation of the tender irrespective of whether the tender is accepted or not.

**20.0** The tender schedule and the tender shall be deemed to form an integral part of the contract to be entered into for this work.

**21.0 SUBLETING:** The successful bidder should not sub-contract part or complete work detailed in the tender specification undertaken by him without written permission of BHEL. The bidder is solely responsible to BHEL for the work awarded to him.

**22.0 TERMINATION OF CONTRACT ON DEATH:** Without prejudice to any of the rights or remedies under this contract, if the contractor dies, the accepting officer shall have the option of terminating the contract without compensation to the contractor's authorized survivors.

**23.0 RECOVERY FROM CONTRACTOR:** Whenever under the contract, any sum of money shall be recoverable from or payable by the contractor, the same may be deducted from any sum then due or which at any time thereafter may become due to the contractor under the contract or under any other contract with BHEL or from his security deposit, or the contractor shall pay the claim on demand without any terms & conditions.

**24.0** Lowest prices/service charge received against Tender need not be the acceptable to BHEL and in that case BHEL would not be considered the same for award of Contract. BHEL would negotiate or re-float the Tender opened if L1 price is not the lowest acceptable price to them inter-alia other reasons. In the event of the final L1 prices are not reasonable / acceptable to BHEL, BHEL also may resort to short closure of this Tender.

**25.0 JURISDICTION:** Notwithstanding any other court or courts having jurisdiction to decide the question(s) forming the subject matter of the reference if the same had been the subject matter of a suit, any and all actions and proceedings arising out of or relative to the contract shall lie only in the court of competent civil jurisdiction in this behalf at **DELHI** (where this Contract has been signed on behalf of the CONTRACTOR) and only the said Court(s) shall have jurisdiction to entertain and try any such action(s) and/or proceeding(s) to the exclusion of all other Courts.

**26.0 ARBITRATION:**

**26.1.1** Both the Company and Contractor hereby agree that In the event of any dispute or difference arising out of the execution of the Order/Contract or the respective rights and liabilities of the parties or in relation to interpretation of any provision between BHEL & Service Provider/ Contractor in any manner touching upon the Order/Contract, such dispute or difference shall (except as to any matters, the decision of which is specifically provided for therein) be referred to the arbitration of the person appointed by the competent authority of BHEL. The venue of arbitration shall be in **DELHI** and the Arbitrator's decision shall be final and binding on both the parties.

Subject as aforesaid, the provisions of Arbitration and Conciliation Act, 1996 (India) or statutory modifications or re-enactments thereof and the rules made thereunder and for the time being in force shall apply to the arbitration proceedings under this clause. The venue of arbitration shall be at New Delhi.

**26.1.2** In case of order/contract on Public Sector Enterprises (PSE) or a Govt. Deptt., the following clause shall be applicable: -

In the event of any dispute or difference relating to the interpretation and application of the provisions of the Order/Contract, such dispute or difference shall be referred to by either party to the arbitration of one of the arbitrators in the department of public enterprises. The award of the arbitrator shall be binding upon the parties to the dispute, provided, however, any party aggrieved by such award may make a further reference for setting aside or revision of the award to the Law secretary, Deptt. of Legal Affairs, Ministry of Law & Justice, Government of India. Upon such reference the dispute shall be decided by the Law Secretary or the Special Secretary or Additional Secretary when so authorized by the Law Secretary, whose decision shall bind the parties hereto finally and conclusively. The parties in the dispute will bear equally the cost of arbitration as intimated by the arbitrator.

a. If the Service Provider / Contractor fails to provide the required services as per the Contract / fails to deliver the goods or materials or any instalment thereof within the period(s) fixed for such delivery or delivers goods or materials not of the contracted quality and failing to adhere to the contract specifications or at any time repudiates or otherwise abandons the contract before expiry of such period or refuses or is unable to supply / provide goods / services or materials covered by the Order/Contract either in whole or in part or otherwise fails to perform the Order/Contract or commits any breach of the Order/Contract not herein specifically provided for or in the event of the death or insanity or if the Seller/Contractor being an individual or if a firm on a partnership thereof, shall at any time, be adjudged insolvent or shall have a receiving order for administration of his estate made against him or shall take any proceeding for composition under any Insolvency Act for the time being in force or make any

assignment of the Order/Contract or enter into any arrangement or composition with his creditors or suspend payment or if the firm dissolved under the Partnership Act or if the Seller/Contractor (Service Provider) being a company is wound up voluntarily or by order of a Court or a Receiver, Liquidator or Manager on behalf of the debenture holders and creditors is appointed or circumstances shall have arisen which entitles the Court of debenture holder and creditors to appoint a receiver, liquidator or manager, the purchaser without prejudice to his right to recover any expenses, losses or damages to which the purchaser may be put to incur or sustain by reason of the Seller/Contractor's default or breach of Order/Contract shall be entitled to cancel the Order/Contract either in whole or portion thereof without compensation to the Seller/Contractor (Service Provider) and if the purchaser so desires, he may procure upon such terms and in such manner as he deems appropriate, stores not so delivered or others of a similar description where stores exactly complying with particulars are not, in the opinion of the purchaser, which shall be final, readily procurable, at the risk and cost of the Seller/Contractor (Service Provider) and the Seller/Contractor (Service Provider) shall be liable to the purchaser for any excess costs provided that the Seller/Contractor (Service Provider) shall continue the performance of the Order/Contract to the extent not cancelled under the provisions of this clause. If this order or any portion thereof is terminated under Force Majeure conditions, the Contractor shall be liable to the COMPANY for any damages, losses or liabilities as result thereof.
