HYDRO CHLORIC ACID - TECHNICAL

1 GENERAL

This specification governs the quality requirements of Hydrochloric acid, technical grade.

2 APPLICATION

For use in laboratory.

3 COMPLIANCE WITH NATIONAL STANDARDS

The acid shall comply with the requirements of the following National standard and also meet the requirements of this specification:

IS 265-1993: Hydrochloric acid

4 TEST SAMPLES

As per IS 265

- 4.1 To draw a representative sample, the contents of the container selected for sampling shall be mixed as thoroughly as possible by shaking or stirring or both or by rolling, so as to bring all portions into uniform distribution.
- 4.2 The samples shall be taken in a suitable, clean, dry air-tight glass bottle of one litre capacity. It should be almost but not completely filled by the sample.
- 4.3 In case of failure of first sample, two samples shall be drawn from other two drums of the same consignment at random and failure of the second sample in complying with the specification will lead to the rejection of the whole consignment.

5 VISUAL INSPECTION

The material shall be a clear, colourless or light yellow liquid free from dirt and other visible impurities.

6 CHEMICAL PROPERTIES

When tested as per the relevant clauses of IS 264, the acid shall show the following properties:

i) Total acidity (as HCl)	:	30%, min. by mass
ii) Residue on ignition	:	0.1%, max. by mass
iii) Sulphates (as H ₂ SO ₄)	:	0.1%, max. by mass
iv) Iron (as Fe)	:	0.005%, max. by mass
