#### **Terms & Conditions**

### A. PRE QUALIFYING REQUIREMENTS (PQR):

1) EMD of Rs.3,080/- (Rupees Three Thousand Eighty only) to be submitted by way of either banker's cheque or demand draft drawn in favour of "BHEL" payable at Jaipur. Tender not accompanied with EMD will not be accepted and shall not be considered for further evaluation.

## No interest shall be payable on EMD amount.

The EMD shall be forfeited in case of:

- Withdrawal of bid or increase in rates or change in bid conditions after opening of the tender.
- ii) Refusal to enter into a contract after the award of contract.
- iii) If operations of the contract are not commenced from the date indicated in the award of contract.
- 2) The bidder should have PAN and Service Tax Registration No.
- 3) The bidder's average annual financial turnover during the last three financial years ending 31st March'16 should be at least Rs. 45,000 /- .
- 4) The experience of having successfully completed similar Job/ services during last 7 years ending on 30.11.2016 should be either of the following:
  - a) Three similar completed jobs / services with value not less than Rs.60,000/- each.

Or

b) Two similar completed jobs / services with value not less than Rs. 75,000/- each.

Or

c) One similar completed job / service with value not less than Rs.1. 2 Lacs.

"Similar Job / service" refers to "Providing of taxis on Daily basis for local and outstation duties".

Only work orders and supporting work completion certificates from the clients shall be submitted as proof against S.No.4 of PQR. For example: If you are qualifying as per SNo.4(b), only work orders and work completion certificates of 2 clients each costing not less than Rs. 75,000/- shall be furnished.

The work completion certificate shall be specific to the work order submitted i.e. the specific contract, value of the job, duration of contract / job and declaration of satisfactory performance shall be indicated in the work completion certificate from the client. The certificates shall be issued by competent authority with his / her contact details mentioned, for verification purpose. BHEL reserves the right to verify the correctness of the certificates of the clients.

#### B. DOCUMENTS REQUIRED IN SUPPORT OF PRE-QUALIFYING REQUIREMENT:

- a) EMD of Rs. 3,080/- (Rupees Three Thousand Eighty Only) in the form of Pay Order or Demand Draft in favour of BHEL, payable at Jaipur, must be submitted in a separate envelope.
- Copy of PAN Card & Service Tax Registration Certificate Form duly signed and stamped by the bidder.
- c) Certified copy of Balance Sheet and profits & loss Account statements of last three financial years i.e. FY 2013-14, 2014-15 & 2015-16 (AY 2014-15, 2015-16 & 2016-17). In case of unavailability of Balance Sheet & Profit & Loss statement for FY 2014-15, CA certificate for the same shall be furnished.
- d) Copy of acknowledgements of IT return of last three financial years i.e. FY 2013-14, 2014-15 & 2015-16 (AY 2014-15, 2015-16 & 2016-17).
- e) Copies of Work Orders/ award letters indicating the duration of contract, Quantum of business done along with certificates of successful completion in support of proof of experience for the jobs/ services executed by the bidders during last 7 years ending on 30.09.2016 as against SNo.4 of Pre-Qualifying Criteria. BHEL reserves the right to verify the correctness of the documents submitted against fulfilling the PQR criteria.



## **Technical Terms & Conditions / Specifications**

#### SCOPE OF WORK

 The Service Provider shall provide AC Commercial Taxi cars of Model January 2013 or later.

The cars shall be provided at our office premises at BHEL, Nehru Place, Tonk Road, Jaipur or at any other place intimated to the Contractor for travel within or outside Jaipur 'as and when required'.

BHEL expects that the empanelled operator shall have all types of vehicles for which they are quoting in ready/working condition for providing of services.

The anticipated business volume during the contract period of one year towards hiring of vehicles shall be approx. Rs. 1.54 lakhs in respect of BHEL ROD Unit at Jaipur.

The above figure (Rs.1.54 lakhs) is indicative for tender purposes only & does not guarantee the business volumes for the contract period of one year. This may increase or decrease depending upon BHELs actual requirements.

- 2. The Contractor shall provide drivers with at least 3 years' experience, adequate knowledge of reading, writing and spoken English / Hindi and in proper uniform having knowledge of different routes as well as minor repair of cars and holding valid driving license. The drivers deputed for duty should be polite and must possess positive attitude in discharging their duty. The reporting time, place, address etc. should be strictly followed by Contractor.
- 3. **UNIFORM:** Drivers should be neatly dressed with shoes.
- CONDUCT: The Drivers should be polite and well behaved. Chewing of tobacco, smoking and drinking while on duty will not be tolerated and will be treated as misconduct.
- 5. The vehicle provided by the contractor must be in excellent condition and must have proper and complete documents. The vehicles should comply strictly with the provision of pollution control in line with the directions of Supreme Court from time to time and should also comply with statutory regulations issued by State Transport Authorities / Central Govt. BHEL shall in no way be responsible for any liability arising due to non-compliance of statutory requirements/regulations w.r.t the vehicle as well as the driver. The contractor must also provide a mobile phone to the driver of the vehicle sent for duty.

- In case of non-availability of requisitioned car, it will be the responsibility of the Contractor to provide higher segment cars (model not older than January, 2014) at the same rates.
- 7. The Contractor shall maintain the duty slip (for vehicles deployed, on Daily basis) as per Performa enclosed (Refer Annexure-VI). The duty slip should be got signed by the driver from the user at the end of each journey which would indicate the details such as opening and the closing meter reading, point of starting / ending the journey, Places visited, date and time of release of vehicle by the user.
- In case of breakdown / servicing / repair, the contractor shall provide alternate vehicle
  of same make and model within two hours failing which the vehicle shall be hired from
  other sources at the risk and cost of the contractor.
- At times, when the hiring of the vehicle is for top management official of BHEL/VIP customer, BHEL reserves the right to inspect the vehicle prior to confirming the booking.
- 10. BHEL intends to engage the contractor located in the vicinity of BHEL, Nehru Place, Tonk Road, Jaipur up to 8 KMs.

Charges on the principle of "Garage-to-garage" basis as per actual distance will be permissible in respect of the journeys starting from places, other than BHEL Jaipur.

However, for journeys starting from and up to BHEL Jaipur, garage-to-garage KMs for each side would be restricted to maximum of 4 KMs or the actual distance between BHEL, Jaipur and the garage of the contractor, whichever is lower.

- 11. In respect of hiring of vehicle on daily basis, the computation of duty hours shall be from the time of reporting and the time of its release, duly signed by the user. This requirement is mandatory for processing the bill for payment.
- 12. In case of any accident, BHEL will not be legally responsible for any such liabilities accruing out of the same.
- 13. Details of payment on account of extra hours & extra usage charges are given in the price bid format (Annexure-XI).



#### **Commercial Terms & Conditions**

#### 1. RATE & PRICE VARIATION

In case of award of contract, the hiring charges shall remain firm for a <u>period of one year</u> i.e. the ENTIRE PERIOD OF CONTRACT. However, price variation due to increase / decrease in the price of fuel (normal diesel as available at Petrol Pumps in Jaipur) shall be effective from the date of variation in the price of diesel as per formula given below. BHEL would allow price variation due to increase / decrease in diesel rates (60% component) as per below mentioned formula:

% Increase / decrease in hiring charges

[Revised rate of diesel - base rate of diesel on the date of original tender submission] x 0.60 x 100

Base rate of diesel on the date of original tender

Base rate of diesel on the date of original tender submission

#### 2. VALIDITY OF OFFERS

The offers submitted by the parties shall be valid for 60 days from the date of opening of Part-I bid. Price bid opening shall be limited to techno-commercially acceptable bidders only. Further, BHEL reserves the right to reject the offer of bidder(s) without assigning any reason.

#### 3. VALIDITY OF CONTRACT

The contract will be valid for a period of one year. The same may however be extended further for a period of one year/part thereof with mutual agreement, in writing, on the same Rates, Terms and Conditions.

#### 4. TERMINATION OF CONTRACT

If at any time the contractor defaults in proceeding with the work with due diligence and continues to do so or commit any default in complying any of the tender terms and conditions even after the notice in writing is given, BHEL may, without prejudice to any other right to remedy which shall have accrued or shall accrue thereafter to BHEL, to terminate the contract by giving 15 days' notice in writing. The notice will be deemed to have been served as and when sent to the address given in the tender.

#### 5. SECURITY DEPOSIT

Security deposit shall be Rs. 7,500/- till the date of validity of contract. The Security Deposit shall not carry any interest. EMD of successful tenderer can be converted and adjusted against the security deposit.

EMD for unsuccessful bidders will be returned.

## 6. TERMS OF PAYMENTS

In case of award of the work, the payment will generally be made on a monthly basis within 15 days after receipt of the computerized/manual bill in duplicate and verification by user and certification by Officer-In-Charge. No advance money will be paid under any circumstances. Also no interest shall be paid due to delay in making the payment.

The bills in duplicate along with duty slips duly signed by the user of the vehicle or his representative should be sent to BHEL for its payment. It should be ensured that there is no overwriting in the duty slip. Duty slip without signature of the user at the specified places shall not be accepted for payment.

- 7. The maintenance cost, charges of fuel, road tax, challans, salary of the driver, the overtime of driver etc. <u>are the responsibility of the contractor and will be borne by the Contractor</u>. BHEL will, however, reimburse State levies / taxes for outstation journeys (for single entry only) at actual on submission of receipts in original along with the bill.
- Parking charges, Toll tax, Service Tax and DND payments, as applicable from time to time shall be extra and borne as per actuals by BHEL on submission of original receipt along with the bill.
- INSURANCE: The vehicle provided must be fully and comprehensively insured (latest copy of insurance cover to be enclosed.)
- 10. <u>BUSINESS DISTRIBUTION:</u> BHEL intends to distribute the work load to max. 02 contractors / agencies with larger share to the lowest bidder, viz., the L1 bidder will be apportioned 60% of the business volume and the remaining 01 successful bidders agreeing to match the L1 rates would share the balance business equally (i.e. 40% of the total business). No objection to such distribution by contractor / agency, if any, shall be entertained. However, this shall further be subject to availability of the required vehicles, reliability of Services, dependability of the operator in providing the required services.
- 11. The cars sent to our office on our requisition shall have all relevant documents like registration Book / Driving License / Insurance / Road Tax Receipt / Border Tax etc. The vehicle should be licensed and shall conform to all Govt. Rules including pollution norms and any other regulation being in force from time to time.

#### 12. PAYMENTS FOR LOCAL JOURNEYS

The payment for local journeys will be regulated on the following basis:

- a) For journeys up to 40 KMs & 4 hrs (Item No. 1 of Price Bid). : The payment will be regulated on the itemized rates finalized for S.No.2 of the Price Bid.
- b) For journeys beyond 40 KMs and up to 80 KMs & beyond 4 hrs and up to 8 hrs. (Item No.2 of Price Bid). : The payment for the journeys beyond 40 KMs and up to 80 KMs and beyond 4 hrs and up to 8 hrs. will be regulated on the itemized rates finalized for S.No.2 of the Price Bid. In addition, the amount payable for extra KM charges (S. No. 3 of Price

Bid) & extra hour charges (S. No.4 of Price Bid) will be calculated and payment will be made.

- For journeys beyond 80 KMs & 8 hrs (Item No.1 of Price Bid). : For the journeys beyond 80 KMs & 8 hrs. the payment will be regulated on the itemized rates finalized for S. No. 1 of the Price Bid. In addition, the amount payable for extra KM charges (S.No.3 of Price Bid) & extra hour charges (S. No. 4) will be calculated and payment will be made.
- 13. PAYMENT FOR OUTSTATION JOURNEYS: For outstation journeys payment will be restricted to actual KM traveled with minimum of 200 KMs per day. The per KM rate & night charges finalized for S. No. 5, 6 & 7 of the Price Bid will also be applicable for payment of outstation journeys.
- 14. Night halt charges will be made for outstation journeys only.
- 15. Contractor shall be solely responsible for payment of wages / salaries and allowances to his personnel that might become applicable under any act or order of Govt. from time to time during the validity of the contract. BHEL shall have no liability whatsoever on this account (i.e. Statutory compliance with regard to vehicle and also the driver deployed including the wages, allowances, and extra hours charges etc. of the driver deployed).
- 16. BHEL reserves the right to reject any or all quotations without assigning any reason whatsoever.
- 17. TAX DEDUCTION AT SOURCE: Tax shall be deducted at source from the running bill as per applicable Income Tax Rules and other statutory requirements.
- 18. <u>DEVIATION</u>: The Contractor must comply with the tender specification and all terms and conditions of contract. No deviation shall normally be entertained. Deviation if any should be given in Annex. VII by mentioning the related/affected clause number etc.

#### 19. EVALUATION CRITERIA

- a) The techno-commercial bids i.e. Part-I submitted by all the bidders will be evaluated first. After techno-commercial evaluation, only the price bids of the bidders who qualify the techno-commercial evaluation will be opened on a subsequent date. The date of opening of price bids shall be intimated to the concerned bidders.
- b) Bidders are requested to read the "Notes" provided in Price Bid very carefully before filling up the price bid format. Offer containing incomplete price bid shall be rejected and will not be considered for further evaluation.
- c) The bidders are required to quote item rate for each segment of vehicles in the space provided in the Price Bid Format.
- d) The ranking of the bidders shall be made on the basis of item rates quoted by them. For identification of overall L1, L2, L3 bidders, the evaluation will be done on the basis of the following formula:

Status = 0.4\*A+ 0.03\*B+ 0.06\*C+ 0.06\*D+ 0.05\*E+ 0.4\*F

- A- Rate of Indigo for 80 KMs in 8 Hours
- B- Rate of Qualis for 80 KMs in 8 Hours
- C- Rate of Honda City for 80 KMs in 8 Hours

D- Rate of Corolla for 80 KMs in 8 Hours

E- Rate of Toyota Camry for 80 KMs in 8 Hours

F- Rate of Innova for 80 KMs in 8 Hours

The value of status will be considered up to two decimal places to arrive at distinct statuses of all bidders.

e) However, overall L1 bidder have to accept the lowest rates ( in any category/ any type of vehicle) of other bidder whose rates are lowest for that category/ vehicle.

#### 20. PENALTY CLAUSE

a) Generally, a prior notice of two hours will be given to the contractors for providing / arranging the vehicle. In case of non-reporting / refusal to provide the requisite car, the same may be hired from any other source(s) at the risk and cost of the contractor. The difference, if any, between the agreed hiring rates with the contractor and the amount payable by BHEL in the event of not providing the vehicle will be recovered from the contractor from the running bills.



#### **General Terms & Conditions**

#### 1. ARBITRATION

a) In the event of any dispute or difference arising out of the execution of the Order/Contract or the respective rights and liabilities of the parties or in relation to interpretation of any provision between BHEL & Service Provider in any manner touching upon the Order/Contract, such dispute or difference shall (except as to any matters, the decision of which is specifically provided for therein) be referred to the arbitration of the person appointed by the competent authority of BHEL.

Subject as aforesaid, the provisions of Arbitration and Conciliation Act, 1996 (India) or statutory modifications or re-enactments thereof and the rules made there under and for the time being in force shall apply to the arbitration proceedings under this clause. The venue of arbitration shall be at Jaipur.

b) In case of order/contract on Public Sector Enterprises (PSE) or a Govt. Deptt., the following clause shall be applicable:-

In the event of any dispute or difference relating to the interpretation and application of the provisions of the Order/Contract, such dispute or difference shall be referred to by either party to the arbitration of one of the arbitrators in the department of public enterprises. The award of the arbitrator shall be binding upon the parties to the dispute, provided, however, any party aggrieved by such award may make a further reference for setting aside or revision of the award to the Law secretary, Deptt. of Legal Affairs, Ministry of Law & Justice, Government of India. Upon such reference the dispute shall be decided by the Law Secretary or the Special Secretary or Additional Secretary when so authorized by the Law Secretary, whose decision shall bind the parties hereto finally and conclusively. The parties in the dispute will bear equally the cost of arbitration as intimated by the arbitrator.

#### 2. LAWS GOVERNING THE CONTRACT

The Order/Contract shall be executed and governed by the laws of India and the courts of India alone shall have jurisdiction in respect of any matter arising under or in connection with the Order/Contract.

#### 3. JURISDICTION OF COURT

Courts at Jaipur shall have exclusive jurisdiction to decide the dispute, if any, arising out of or in respect of the contract(s) to which these conditions are applicable.



## 4. DEFAULT/ BREACH OF CONTRACT, INSOLVENCY AND RISK PURCHASE

- If the Service Provider / Contractor fails to provide the required services as per the Contract and a) failing to adhere to the contract specifications or at any time repudiates or otherwise abandons the contract before expiry of such period or refuses or is unable to / provide services covered by the Order/Contract either in whole or in part or otherwise fails to perform the Order/Contract or commits any breach of the Order/Contract not herein specifically provided for or in the event of the death or insanity or if the Contractor being an individual or if a firm on a partnership thereof, shall at any time, be adjudged insolvent or shall have a receiving order for administration of his estate made against him or shall take any proceeding for composition under any Insolvency Act for the time being in force or make any assignment of the Order/Contract or enter into any arrangement or composition with his creditors or suspend payment or if the firm dissolved under the Partnership Act or if the Contractor (Service Provider) being a company is wound up voluntarily or by order of a Court or a Receiver, Liquidator or Manager on behalf of the debenture holders and creditors is appointed or circumstances shall have arisen which entitles the Court of debenture holder and creditors to appoint a receiver, liquidator or manager, the purchaser without prejudice to his right to recover any expenses, losses or damages to which the BHEL may be put to incur or sustain by reason of the Contractor's default or breach of Order/Contract shall be entitled to cancel the Order/Contract either in whole or portion thereof without compensation to the Contractor (Service Provider) and if BHEL so desires, may hire such services and in such manner as it deems appropriate, at the risk and cost of the Contractor (Service Provider) and the Contractor (Service Provider) shall be liable to the BHEL for any excess costs provided that the Contractor (Service Provider) shall continue the performance of the Order/Contract to the extent not cancelled under the provisions of this clause. The Contractor (Service Provider) shall on no account be entitled to any gain on such services..
- b) Cost of the service made by the BHEL/Service taker at the risk and cost of the contractor (Service Provider) shall be worked out after levying 30% overheads as departmental charges on the cost of services so hired.
