3.2 Part 'A' must be duly completed and sealed along with the Earnest money deposit (EMD) of **Rs. 17596.00 or Rs.5 lakhs (one time EMD)** in an envelope super scribed as:-

- 3.5 Part 'B' Price bid will be opened only of those bidders who are qualified in Techno- Commercial Bid.
- 3.6 Before making the offer the bidders are advised to carefully go through the terms and conditions, which form part of the tender document and agreement. Before submitting the bids the bidder can visit the work place, obtain desired clarification to have clear understanding of scope of work and all terms and conditions of contract.

No claim or clarification will be provided after opening of bid and decision of BHEL IP on any matter arising due to non-understanding of any term by bidder will be final and binding to bidder.
No request of bidder shall be consider after opening of techno-commercial bid.

- 3.7 BHEL reserves the right to reject any bid/all bids, which is Techno-commercial ly unacceptable and unworkable. **BHEL** reserves the right to accept or reject any of the bid/all bids or cancel/withdraw the invitation for bid without assigning any reason whatsoever and in such case no bidder/intending bidders shall have any claim arising out of such action by BHEL. The opinion / decision of BHEL regarding the bid shall be final and conclusive.
- 3.8 The company has no obligation to accept the lowest tender and have **right to re-float the tender, if L1 price is not the acceptable price to BHEL inter-alia other reasons.** Offer of the Bidder if prima-facie found not comparable with the quantum of work envisaged but an efforts to be L1, then the offer is liable to be rejected. BHEL's decision in this regard shall be final and binding.
- 3.9 BHEL reserves the right to award the contract to one or more bidders simultaneously as deemed fit at the initial stage or during the contract period **at the L1 price to BHEL. BHEL reserves the right to negotiate the L1 rate.**
- 3.10** BHEL reserves the right to cancel the contract at the initial stage or during the contract period without assigning any reason to the bidder.

3.11 For deployment of manpower the following shall be adhered by bidder:

- 1) **The maximum no of gate passes: 06 Nos Unskilled (USW), NIL Nos Semi skilled (SSW) and NIL Nos. Skilled manpower against this contract will be permitted by BHEL.**
- 2) The bidder shall engage sufficient number of competent labor for executing the agreed work. The Bidder shall have full control over his labor including determining service conditions, discharge, dismiss, or otherwise terminate their services at any time.
- 3) The bidder shall be solely responsible for any claim (including statutory payment) arising out of deployment or termination of his labors.
- 4) **In case of more work which can't be executed by present manpower, the work shall be completed through deployment of additional manpower for which temporary gate pass shall be issued.**

3.12 BHEL can reduce/increase quantum of work without assigning any reasons thereof. Quantity given in BOQ are tentative and can increase or decrease as per requirement of BHEL IP. In case of quantity variation, BHEL will not be liable for any claim arising thereof.

3.13 **PERIOD OF CONTRACT:** The period of contract will be for 1 (one) year only. The contract may be extended further on the same rates, terms and conditions if mutually agreed upon.

3.15 PRICE BID

The per piece rate for all items at Sl. No. 1 to 31 of Price bid shall be quoted by bidder. Rates for both material and labor inclusive of profit margin on both (i.e. Labour and material cost) shall be quoted by bidder.

ITEM RATE QUOTE GUIDELINES

A. Profit margin will be inclusive in the rates for items at Sl no 1 to 31 (i.e. Total A). For piece rate inclusive of profit margin (price bid column -b) bidder to quote rates by considering the minimum wage.

B. Profit margin will not be admissible on other items (i.e. Additional Payment, PF, ESI, Bonus, Holiday, Leave, CA/TA, Admin. Charges, EDLI etc.) as these are being reimbursed.

3.16 **PRICE VARIATION CLAUSE:** In the event of revision of minimum wages by State Government (UP) notification, the rates in the contract for the labour portion only will be revised as per the notifications based on the formula given below. The applicable rates would be payable by the bidder to the labour and other statutory authorities, as per rules, from the effective dates will be applicable.

3.17 **EVALUATION OF PRICE BID:** bidders should quote required information/rates as indicated in slno. 1 to 31 of price bid format. In case bidder does not quote rates for all activities, BHEL reserves the right to reject such offer.

Evaluation of the L1 (Lowest bid) offer shall be computed on overall basis (i.e. Grand Total Price for all the items at Sl no ix of price bid format) for all the activities in the tender. For evaluation of L1 bidder value up to two decimal place will be consider for calculation, value beyond the second place of decimal will not be considered for evaluation and all terms beyond second place of decimal will be ignored in calculation for overall L1.

NOTE:- In the event of two or more bidders appear as L1 bidder the selection of the bidder will be on the basis of Lottery to be held in presence of representatives of L1 bidders.

3.18 TERMS OF PAYMENT

3.18.1 Payment shall be made, on the Nos. of Measurement units, successfully executed, by the Bidder. The bidder shall submit their clear & legible bills (in duplicate) on Monthly basis, duly verified by concerned BHEL Executive. Each bill must be enclosed with work/ activity completion report duly signed by bidder & and BHEL representative (s).

3.18.2 All payments shall be released through electronic-pay mode only.

3.18.3 BHEL shall be releasing payments against the work order after deduction of income tax at source (TDS) as per requirement of income tax rules and BHEL will issue appropriate certificates in this regard. All statutory deduction as applicable, will be deducted from bills. Bidder shall inform his PAN to BHEL.

3.18.4 GST, as applicable, shall be paid, as per Govt. rules, to the bidder against running actual, on documentary evidence. The GST shall be paid extra and over the quoted rate. The Bidder shall be required to deposit GST as applicable, before due date as per Act, if same is applicable as per rules in force from time to time. The amounts so spent can be claimed from BHEL after submitting the proof of the same.

3.18.5 All the terms & conditions of the contract with respect to Taxes & Duties are subject to the new taxation laws introduced from time to time (e.g., GST- Amendments etc.). The terms & conditions will be modified in accordance with the provisions of new laws (e.g., GST- Amendments etc.).

3.18.6 No interest shall be payable by BHEL on Earnest Money, Security Deposit or on any money due to the firm by BHEL.

3.18.7 Bidder shall arrange his own finance for smooth execution of contract, wages payment, other statutory payments to his employees and all other agreed conditions.

3.18.8 Normally, payment shall be made within 45 days of receipt of bill at BHEL.

3.18.9 The Bidder shall produce to the Company, the documentary proof of payment of the said statutory dues. Non-observance of the provisions will be construed as default by the Bidder in making such payment, and payment of his bill will be deferred.

3.18.10 The bidder will have to extend paid National Holidays and Festival Holidays to their workers as per the provisions of Act and the Rules thereof. However, if due to exigencies of work he engages his workmen on National Holidays or Festival Holidays he shall pay wages as prescribed under the provisions of the Act. However same shall be reimbursed by BHEL.

3.18.11 In case of any extra work executed by the bidder, the bidder will paid on pro-rata basis.

3.18.12 BHEL Management shall have a right to deduct any sum from the bill of the bidder for making good the loss suffered by a worker or workers by reason of non-fulfillment of the conditions

- iii. Cleaning and upkeep of machine and machine parts after the completion of the shift work will be the responsibility of the bidder.
- iv. Bidder has to ensure extreme care in handling of the product at all stages of processes by their workmen.
- v. The bidder shall extend help to BHEL in recording the daily attendance & movement of their manpower from their designated workplace through the system provided by BHEL IP, Jagdishpur time to time.

7. Attendance of worker should be get verified from BHEL representatives daily for both morning and afternoon session and it is responsibility of contactor to ensure the appropriate maintenance of data, BHEL will not be responsible for any delay in billing due to non-submission of necessary document by contactor. Contractor should deploy sufficient manpower daily to ensure smooth working.
8. IMPORTANT POINTS TO BE NOTED:-
 1. The quantum of work indicated in Price Bid are approximate and tentative on yearly basis. Actual quantum of work may vary against different items depending on BHEL requirement. However, the day to day work as is to be carried out as per requirement of BHEL on instruction from section in charge.
