Sub: Specifications for hiring of Electric Vehicle on lease basis

BHEL R&D calls for bids for hiring of one no of Electric Vehicle (EV) without driver for 12 months duration on 24 x 7 basis for an average run of 2000 km/month for exclusive usage of BHEL R&D official purpose.

General terms and conditions:

- 1. Maintenance and comprehensive insurance of the vehicle will be in the scope of the vendor.
- 2. Charging of the vehicle is in BHEL scope. Electric vehicle shall support DC fast charging (CCS 2) protocol.
- 3. The vehicle shall be able to be charged with the CCS compatible DC Fast Charger (ARAI certified one) installed in Corp R&D, BHEL premises.
- 4. The vehicle shall be available in BHEL R&D campus on 24 x7 basis except on days for regular services as recommended by OEM with prior intimation to BHEL. For regular service vehicle will be given to vendor for 1 day. If the requirement of the vehicle for service is more than 1day, then BHEL will decide on case to case basis with the feedback from the authorized dealer of the OEM.
- 5. The vehicle shall have valid registration.
- 6. The vehicle shall be in excellent working condition.
- 7. Interstate travel is not applicable.
- 8. The bidder must have a Permanent Account Number (PAN). If applicable, the bidder must have registration for Goods Service Tax (GST).
- 9. All relevant documents (RC, PUC, Insurance, taxes paid etc.) shall be available and copy to be submitted for the running year to BHEL R&D.
- 10. Vendor shall arrange an alternate vehicle of same capacity, in case of breakdown of the vehicle. If the vehicle is not replaced with an equivalent or superior vehicle within 3 days, penalty of Rs.1000/ per day will be imposed in addition to the pro-rata deduction of rental in the monthly bill.
- 11. In case the BHEL is not satisfied with the quality/condition of the vehicle, the contractor shall change the vehicle / make necessary repairs to the satisfaction of the BHEL.
- 12. The courts of RR district, Telangana shall have sole jurisdiction on any legal dispute arising out of this contract.
- 13. The contract shall be valid for 12 months from date of the start of contract.
- 14. BHEL reserves the rights to cancel the work order by giving one week advance notice thereby if- (a) The bidder fails to comply with any of the terms of the work order. (b) The bidder becomes bankrupt or goes in to liquidation.
- 15. Once the contract is finalized, the car shall be at the disposal of BHEL R&D during the entire period of contract as per bid terms.
- 16. If the transport contractor is not able to provide his car continuously, alternate arrangement will be made by bhel R&D and the extra cost incurred will be recovered from the transport contractors pending bill in BHEL R&D or any of its sister units/RODs/Sectors.
- 17. BHEL reserved its right to cancel the tender altogether without assigning any reason whatsoever.



- 18. BHEL reserves its rights to reject any quotation without assigning any reason whatsoever.
- 19. The contractor/ bidder will have full liability under sections of Motor Vehicles Act 1968 and IPC causing death or permanent disability developed by the vehicle supplied by the Contractor. The hiring authority shall have no responsibility and will not entertain any claim in this regard in any circumstances. The contractor shall indemnify the hirer from such incidences.

Payment terms:

100% basic payment will be made monthly within 30days of submission of the correct bills with supporting documents if any. GST payment will be made after submission of GST returns & reflection in GST portal.
