#### 1. GENERAL:

This specification governs the quality requirements of Aluminium Notched Bars and Shots for use in steel melting shops.

## 2. APPLICATION:

Used as a deoxidiser of steel, in steel melting shops.

## CONDITION OF DELIVERY:

## 3.1 Notched Bars:

When supplied as notched bars, the weight of each bar shall be 1 to 1.5 kg or mutually agreed upon by BHEL and supplier.

## 3.2 Shots:

When supplied as shots, the grain size of each shot shall be 3 to  $8~\mathrm{mm}$ .

# 4. COMPLIANCE WITH NATIONAL STANDARDS:

There is no National Standard covering this type of material.

# 5. FREEDOM FROM DEFECTS:

The material shall be free from dress, slag and other harmful contaminations. The surface of the material shall be free from heavy oxidised coating.
