1. Submit the tender in two parts i.e.

Part-I Techno- Commercial Bid
Part-II Price Bid

Technical / Commercial (part one) & Price Bid (part two) should be put in separate sealed envelopes. Both envelopes should be superscribed with **Tender Number, Date of Opening & Technical / Commercial Bid** and **Price Bid** respectively along with **name of firm**.

Both the envelopes i.e. containing Technical / Commercial Bid and Price Bid should again be kept in one envelope super scribed again with Tender No. and Date of Opening and the name of firm submitting the tender.

Part-I Envelopes super scribed with Techno-Commercial Bid must contain all information especially:-


