Vendor to quote lump sum erection & commissioning charges / unit separately in column provided in EPS - PRICE BID, based on quoted value total E&C commissioning charges for all units ie (10 units) will be calculated.

f) All project requirements are to be considered as a single package for evaluation purpose and L1 finalization. L1 finalization will be done based on total cost BHEL basis including lump sum erection & commissioning charges quoted for all units, after all loadings as applicable wherever deviations are observed.
