PART 'A' - TECHNO- COMMERCIAL BID

A. INSTRUCTIONS FOR THE BIDDERS:

- 1. The offer shall be submitted as per the instructions of tender document. Only one set of tender document duly signed & stamped on each page shall be submitted as detailed further. Tenderer should note specifically that all pages of tender document, including the NIT page for this particular tender shall be submitted by them (after signing/ stamping on each page) as a part of their offer. Price shall not be mentioned by them anywhere in the techno-commercial portion of offer, except in the relevant price bid and submitted in separate sealed envelope. In case of any clarification, bidder may contact this office.
- 2. Tender documents are also available on BHEL web site (www.bhel.com) & on CPP Portal (http://eprocure.gov.in/cppp/) which can be downloaded and used as tender document for submitting the bid.
- 3. Bid should be free from correction, overwriting, using corrective fluid, etc. any interlineation, cutting, erasure or overwriting shall be valid only if they are attested under full signature (s) of person (s) signing the bid else bid shall be liable for rejection.
- 4. Tender must be submitted in two parts, i.e., (i) Techno-Commercial Bid along with un-price bid (Annexure-I) and (ii) Price Bid. The tenderer must submit their tenders in three separate sealed envelopes prominently super scribed as 'EMD Deposit', Part A 'Techno- commercial bid' and Part-B 'Price Bid' along with NIT No. & due date written on each of the envelope. These three separate envelopes shall together be kept in fourth envelop super scribed with name of Work, NIT No. & due date of opening.
- 5. Techno-commercial bid should contain all the documents in proof of Pre- qualifying criteria, signed tender document having NIT page, Instructions for tenderer, general conditions, Special Conditions, Contractor's Obligations, un-price bid, all the annexure duly filled & signed by the tenderer and the envelope containing EMD.
- 6. Bid without requisite Earnest Money (EMD) will not be considered, except for MSE Suppliers who have submitted valid NSIC certificate along with tender's Techno-commercial Part I- Bid.
- 7. The tenderer shall submit the Bank details along with a cancelled cheque for payment through NEFT/RTGS.
- 8. Price Bid should contain only the "Part-B, Price Bid Format" after quoting the rates as specified in the Price bid format.
- 9. Rate shall be quoted for each item inclusive of all taxes but exclusive of Goods and Service tax (GST) which shall be quoted separately in same price bid format. Rates must be quoted in figures as well as in words.
- 10. On the date of opening of tender, only Techno-Commercial Bid shall alone be opened.
- 11. BHEL may finalize successful tenderer by opening of sealed price bid. Date of opening of sealed Price Bid will be intimated by phone, by post or e-mail separately to the Tenderers who qualify in the Techno-Commercial bid.
- 12. BHEL reserves the right to accept or reject any or all offers without assigning any reason thereof. Also BHEL shall not entertain any correspondence from bidders in this matter (except for the refund of EMD).
- 13. In case any typing error/other clerical errors is noticed by the tenderer, in the tender documents, the same must be pointed out and got clarified before submission of offer, or else, BHEL's interpretation shall prevail & shall be binding on the tenderer.
- 14. The Tenderer should accept all terms & conditions of the tender unconditionally. Tenders with deviations from terms and conditions are likely to be rejected.
- 15. Tenderers are requested to go through the scope of work, visit the site/location etc. and get fully acquainted with the work place and prevailing working conditions to get all their doubts clarified

16. The tenderers or their representative may attend the opening of techno-commercial bid (Part-A) and the technically qualified tenderers or their representative may attend the opening of Price bid (i.e. Part B.

B. PRE QUALIFYING CRITERIA:

- 1. The Earnest Money Deposit (EMD) of Rs 7,431.00 (Rupees Seven Thousands Four Hundred Eighty One Only) in the following forms in favour of BHEL, payable at New Delhi, must be submitted in a separate envelope:
 - a. Cash deposit as permissible under the extant Income Tax Act (before tender opening)
 - b. Electronic Fund Transfer credited in BHEL account (before tender opening)
 - c. Banker's cheque/ Pay order/ Demand draft, in favour of BHEL (along with offer)
 - d. Fixed Deposit Receipt (FDR) issued by Scheduled Banks/ Public Financial Institutions as defined in the Companies Act (FDR should be in the name of the Bidder, a/c BHEL)

Tender not accompanied with EMD will not be accepted, except for MSE Suppliers who have submitted valid NSIC certificate along with tender's Techno-commercial Part I- Bid.

2. The bidder shall submit the complete tender document in all respects duly signed & stamped on each and every page as a token of acceptance of all the terms and conditions of tender.

- 3. Self-attested copies of Work Orders/ Award letters/ Contract Agreement/ Completion Certificate in support of proof of experience for the works executed by the bidders during last 7 years ending on 30.04.2019. The Work Orders/ Award Letters/ Contract Agreement/ Completion Certificate of similar Work (Similar completed Works shall mean Providing Cable TV Services) shall only be acceptable. The value of work experience should be as follows:
 - a. Three similar completed Works costing not less than Rs. 1.48 Lakhs each.

a. Or

b. Two similar completed Works costing not less than Rs. 1.85 Lakhs each.

a. Or

c. One similar completed Works costing not less than Rs. 2.97 Lakhs.

4. The Bidder Must Submit Un-Price Bid (enclosed at Annexure –I)

5. The Bidder Must Submit a Declaration (enclosed at Annexure -II), that no case is pending with the police/ court against the proprietor/ firm/ partner or the company (Agency). As well as the bidder has not been suspended / blacklisted by any organization.

6. No deviation certificate as per Annexure –III (enclosed) must be signed and stamped.

7. Bidder must submit the bidder's details in the enclosed format (Annexure-IV).

8. The Bidder Must Submit List of Channels (enclosed at Annexure –V)

C. SPECIAL CONDITIONS:

1. All 48 connections are to be provided in Transit Flats in BHEL Township, Sector-17, Noida.

2. Bidder is required to provide minimum channels as per Annexure-'V' and no extra payment will be

payable for providing any additional channels.

- 3. If necessary bidder may inspect the premises to access the quantum of materials required for the entire scope of work/services and quote accordingly. In case of submission of the tender, it will be presumed that the bidder has understood the entire scope and quoted accordingly. Nothing extra will be payable on any account whatsoever later on.
- 4. Installation of all the equipment, internal cabling in the building and external cable TV connectivity cabling from service provider to BHEL Township is in the bidder's scope. In case any equipment/cable is found to be defective during the contract period, the same shall be replaced immediately at no extra cost to ensure uninterrupted services during the contract period.

5. Providing Set-top box along with remote shall remain in the scope of BHEL.



- 6. The bidder will make sure that there are no loose cables hanging in the township which may affect the aesthetics of the premises. If any dead cable is hanging, it should immediately be removed.
- 7. BHEL looks forward to get excellent services from the bidder.

D. GENERAL TERMS & CONDITIONS: -

- 1) Tenders received late /in open condition/without EMD/ not meeting the tender condition / incomplete in any respect are likely to be rejected.
- 2) BHEL will not be responsible for the postal delay under any circumstances for non-receipt of Tenders by due date & time.
- 3) BHEL has the right to reject all or any of the tenders and accept any tender(s) irrespective of its / their being the lowest / highest.
- 4) If any information/ documents submitted by the tenderer are found false/fake at any stage, the tender will be cancelled and Earnest Money deposited (EMD) shall be forfeited.
- 5) The offer of the bidders who are on the banned list as also the offer of the bidders, who engage the services of the banned firms, shall be rejected. The list of the banned firms is available on BHEL web site www.bhel.in
- 6) The Tenderers are required to quote for the complete scope of work. Tenders for part of the work or incomplete in any respect are liable to be rejected.
- 7) Rates quoted by the bidder will be firm for the contract period. No price variation and escalation due to increase in labour / material cost will be allowed.
- 8) The rates quoted by the bidder are deemed to be inclusive of all and any other incidental works required to complete the work and inclusive of all the taxes but excluding Goods and Service Tax (GST). GST shall be quoted extra in the same price bid format.
- 9) The rate should be indicated both in words and figures. All entries in the Tenders must be written in ink or typewritten. Over-writing should be avoided. Corrections, if any, should be attested with signature by the bidder.
- 10) **VALIDITY OF RATES:** Validity of rates will be **90 days** from the date of opening of the technocommercial bid.
- 11) Any statutory changes as and when made applicable by the Government/ Telecom Regulatory Authority of India (TRAI) shall become applicable against documentary evidence.
- 12) For Part A' of Price Bid format, MRP Rates have been disclosed in the tender documents and percentage rate tenders are invited. Bidders have to quote a single overall percentage, (+) above, (-) below or at par with the tender rates at S. No. 3 of Price Bid format.
- 13) **EVALUTION CRITERIA**: The criteria of evaluation of techno-commercial bids shall be on the basis of documents submitted by the tenderers. BHEL may finalize successful tenderer by opening of sealed price bid. Date of opening of sealed Price Bid will be intimated, by post or e-mail separately to the tenderers who qualify in the Techno-Commercial bid. The decision of BHEL will be final in this regard. The evaluation of price bid will be on total cost to 'BHEL' (i.e. amount mentioned at Sl. No. 9 of Price Bid). Evaluation of Price Bid will be done on overall L-1 rate inclusive all including Goods and Service Tax (GST).
- 14) **CORRECTION OF ARITHMETIC ERRORS**: Provided that the bid is substantially responsive, BHEL shall correct arithmetical errors on the following basis:
 - i) If there is a discrepancy between the unit price and the total price that is obtained by multiplying the unit price and quantity, the unit price shall prevail and the total price shall be corrected, unless in the opinion of the BHEL there is an obvious misplacement of the decimal point in the unit price, in which case the total price as quoted shall govern and the unit price shall be corrected.
 - ii) If there is an error in a total corresponding to the addition or subtraction of subtotals, the subtotals shall prevail and the total shall be corrected.

- iii) If there is a discrepancy between words and figures, the amount in words shall prevail, unless the amount expressed in words is related to an arithmetic error, in which case the amount in figures shall prevail subject to (a) and (b) above.
- iv) If any bidder does not accept the correction of errors, their bids are liable to be disqualified.
- 15) <u>COMPLETION PERIOD:</u> The total work completion period will be for **One Year (12 months)** from the dated of placement of Work Order.
- 16) **QUANTITY VARIATION:** The nos. / Quantity of Cable TV connections may vary ± 5 % during the contract period as per the direction of Engineer-in-charge. However, these connections are for Transitory Flats which are located in BHEL Township, Sector-17, Noida where approx. 500 nos of Household Flats exists, if your rates are cheaper, then they might take these services on same rates, terms & conditions.
- 17) L. D. Clause: In case of failure to provide cable TV connectivity, the Contractor has to attend the complaint within two hours. The duration for rectification will be within 24 hours and in case it exceeds the same, penalty will be imposed @ 20.00 per connection per day.

18) TAXES AND DUTIES:

- a) As Goods and Services Tax (GST) has been introduced by Govt. of India in place of earlier taxes, the same shall be payable after submission of GST compliant tax invoices.
- b) The bidder must quote his rates considering benefits of GST including Input Tax credit in the quoted price.
- c) Contractor shall submit GST compliant Tax invoice containing all the particulars as stipulated under Invoice Rules of GST Law. Such invoice shall be submitted within prescribed time limit in the name of respective BHEL Unit/Office/Region as instructed by BHEL.
- d) The contractor has to submit their GST registration certificate to respective BHEL Unit/Office/Region. GSTIN of BHEL will be provided to the contractor by respective office of BHEL.
- e) Any statutory changes as and when made applicable by the Government shall become applicable against documentary evidence.
- f) Payment to the contractor will be subjected to TDS as per rules in force from time to time. The Tax Deduction at Source (TDS) shall be done as per the provisions of Income Tax Act and GST as applicable, as amended from time to time and a certificate to this effect shall be provided to the contractor by BHEL.
- g) Contractor shall have to ensure compliance under GST law for time being force and in case any loss occurs to BHEL due to non-compliance, it shall be to contractor's account.

19) PAYMENT TERMS:

- a) The monthly bills of Part A' of Price Bid which is for Cable TV Services shall be paid within 15 days by NEFT from the date of receipt of bill without any discrepancies, subject to conditions mentioned at Sl. No. 18 (i.e. Taxes & Duties). However, disconnection of services due to delayed payment shall not be permissible. No late fee & advance payment shall be paid by BHEL. There is provision of ordering extra channels upto MRP of Rs 50/- at any time during the contract, which shall be payable as per Price format along with monthly bills.
- b) For Part B' of Price Bid, the total amount inclusive of GST shall be paid against the delivery of items within 15 days by NEFT from the date of receipt of bill without any discrepancies.
- c) No advance payment or the payment for mobilization of work will be made to the contractor.
- d) The contractor shall not be entitled to any interest with respect to any money which may be due to him from BHEL.
- 20) **SUBLETING:** The Contractor shall not sublet, transfer or assign the full work or any part thereof to any other person/company/organization. In case it is found that the work has been subletted, the contract shall be terminated immediately & Security Deposit shall be forfeited.

- 21) No excuses like hindrance because of extreme weather conditions, non-availability of labour and material etc. will be entertained for not providing the services in time.
- 22) All necessary precautions with respect to safety at site and environmental aspects and their impacts shall have to be taken by the contractor for activities performed by his workers.
- 23) In case of any dispute, the decision taken by BHEL Management will be final and binding on the contractor.
- 24) No party shall be permitted to tender for work in BHEL in which any of their near relatives is an employee connected with the award and execution of the contract. They shall also intimate the names of persons who are working with them in any capacity or subsequently employed by them and who are near relatives of any employee of the BHEL. Any violation of this condition which comes to the Notice of the BHEL after the contract is awarded will entitle the BHEL to treat the contractors as having committed a breach of contract and to exercise all the rights and remedies available to the BHEL on account thereof.

25) EARNEST MONEY DEPOSIT (EMD):

- i. The Earnest Money Deposit (EMD) of **Rs 7,431.00** (Rupees Seven Thousands Four Hundred Eighty-One Only) only in the following forms in favour of BHEL, payable at New Delhi, must be submitted in a separate envelope:
 - a. Cash deposit as permissible under the extant Income Tax Act (before tender opening)
 - b. Electronic Fund Transfer credited in BHEL account (before tender opening)
 - c. Banker's cheque/ Pay order/ Demand draft, in favour of BHEL (along with offer)
 - d. Fixed Deposit Receipt (FDR) issued by Scheduled Banks/ Public Financial Institutions as defined in the Companies Act (FDR should be in the name of the Bidder, a/c BHEL)

- ii. Earnest Money is to be paid by each tenderer to ensure the tenderer does not refuse to execute the Job/ services after it is awarded to him.
- iii.EMD of the tenderer will be forfeited if:
 - a) After opening the tender and within the offer validity period, the tenderer revokes his tender or makes any modification in his tender which is not acceptable to BHEL.
 - b) The Contractor fails to deposit the required Security deposit or commence the work within the period as per LOI/ Contract.
 - c) EMD by the tenderer shall be withheld in case any action on the tenderer is envisaged under the provisions of extant "Guidelines on Suspension of business dealings with suppliers/contractors" and forfeited/released based on the action as determined under these guidelines.
- iv.EMD given by all unsuccessful tenderer shall be refunded normally within 15 days of acceptance of award of work by the successful tenderer.
- v.EMD shall not carry any interest.
- vi.EMD of successful tenderer will be retained as part of Security Deposit.

26) MICRO AND SMALL ENTERPRISES (MSE):-

Any bidder falling under MSE category, shall furnish the following details & submit documentary evidence/ Govt. Certificate etc, in support of the same along with their techno-commercial offer.

<u>Note:-</u> If the bidder does not furnish the above, offer shall be processed construing that the bidder is not falling under MSE category.

a) MSE Supplier can avail the intended benefits only if they submit along with offer, attested copies of either Udyog Aadhar or EM-II certificate having deemed validity (five years from the date of

- issue of acknowledgement in EM-II) or the valid NSIC certificate or EM-II certificate along with attested copy of a CA Certificate (format enclosed as Annexure- VI) where deemed validity of EM-II certificate of five years has expired applicable for the last audited financial year. Date to be reckoned for determining the deemed validity will be the date of bid opening. Non submission of such documents will lead to consideration of their bid at par with other bidders. No benefit shall be applicable for this enquiry if any deficiency in the above required documents are not submitted before price bid opening.
- b) Participating MSEs quoting price within price band of L1 + 15 % shall be considered for award of complete scope of work by bringing down their price to L1 price in a situation where L1 price is from someone other than a MSE. In case of more than one such MSE, MSE with lowest price shall be given the first option to match the L1 price. However, MSEs owned by the Scheduled Caste or the Scheduled Tribe entrepreneurs shall be given the preference for matching the L1 price irrespective of their standing in comparative statement of MSE bidders within price band of L1 + 15%.
- 27) Bidder along with its associate/ collaborators/ sub-contractors/ sub-vendors/ consultants/Service providers shall strictly adhere to BHEL Fraud Prevention Policy displayed on BHEL website http://www.bhel.com and shall immediately bring to the notice of BHEL Management about any fraud or suspected fraud as soon as it comes to their notice.
- 28) **TERMINATION OF CONTRACT:** The BHEL may terminate the contract by giving not less than thirty day's written notice of termination to the successful tenderer. If the successful tenderer do not remedy a failure in performance of their obligation under the contract, within thirty days after being notified.
- 29) **TERMINATION OF CONTRACT ON DEATH:** Without prejudice to any of the rights or remedies under this contract, if the contractor dies, the accepting officer shall have the option of terminating the contract without compensation to the contractor's authorized survivors.
- 30) **RECOVERY FROM CONTRACTOR**: Whenever under the contract, any sum of money shall be recoverable from or payable by the contractor, the same may be deducted from any sum then due or which at any time thereafter may become due to the contractor under the contract or under any other contract with BHEL or from his security deposit, or the contractor shall pay the claim on demand without any terms & conditions.
- 31) **POST TECHNICAL AUDIT OF WORK AND BILLS:** BHEL reserves the right to carry out a post payment audit and technical examination of the work and final bill including all supporting vouchers, abstracts etc. and to enforce recovery of any sums becoming due as a result thereof in the manner provided into the proceeding sub-paragraph provided however, that no such recovery shall be enforced after three years of passing the final bill.

32) ARBITRATION / CONCILIATION:

In the event of any dispute arising between the parties hereafter referred as BHEL and Contractor in respect of or connected with this contract, General & Special terms & conditions of tender, then the same shall be referred to Arbitration and Arbitrator will be nominated by the Head of Administration of BHEL Corp. Office, New Delhi, whose decision shall be final and binding on both the parties. However, any differences or doubt pertaining to meaning/ interpretation of any phrase word used in terms or in the schedule of services, their nature and manner of rendering of such services shall be the excepted matter and be referred to the Head of Administration of BHEL Corp. Office, New Delhi, whose decision shall be the final and binding. The provisions of Arbitration and Conciliation Act, 1996 or any statutory modification and re-enactment thereof will apply to such arbitration provided however, in all matters the venue of proceedings will be Delhi and only Delhi or appropriate Courts will have jurisdiction over the same.

33) **RISK CLAUSE**: In case the contractor do not accept the work awarded to him or do not turn up after the award of work, BHEL shall have the right without any prejudice to get the work done through any other alternate agency at the risk and cost of Contractor. The additional cost including loss, if any incurred by BHEL will be recovered from the Contractor.

E. CONTRACTOR'S OBLIGATIONS:

- 1. Contractor shall supervise the work allotted to him and to be carried out by his employees.
- 2. Contractor to ensure that the employees deployed in the premises of BHEL are physically and mentally fit and do not have any criminal record. Such employees should possess requisite skill, proficiency, qualification, experience etc.
- 3. Contractor to maintain appropriate records of his employees deployed to carry out the job(s).
- 4. Contractor to provide employment card/identity card with photograph duly verified and attested by the contractor to his employees. Contractor to indicate the name of the proprietary /partnership firm/company, place of work, contact number and duration of validity of card.
- 5. Contractor will be responsible for the good conduct of his employees. In case of any misconduct/misbehavior by any employee, the contractor will replace such employee (s) immediately.
- 6. Contractor will ensure that the job is executed through his employees on his rolls and shall not sub-contract the job.
- 7. Contractor will keep watch on his employees and he will be liable for any pilferage/loss to BHEL due to acts of omission and commission by his employees. Similarly, liability for any compensation to outsiders on account of any act of omission and commission by the employees deployed by the contractor shall lie exclusively with him.
- 8. Contractor shall follow all rules and regulations pertaining to Environment safety as laid down by the Government from time to time.
- 9. Contractor to get all his employees insured against all type of risks at his own cost.
- 10. Contractor to ensure that all precautions are taken for safety of himself, his employees and equipment.
- 11. In the event of termination of contract for any reason whatsoever, the contractor shall withdraw all his employees from the establishment of BHEL.
- 12. Contractor shall comply with all statutory requirements, rules, regulations, EPF & ESI, notifications in relation to employment of his employees issued from time to time by the concerned authorities.
- 13. In case the contractor fails to make payment of wages to his employees or remittance of contribution to the concerned authorities, BHEL would not be responsible for that, in any case.
- 14. Contractor shall provide to his employees all tools, tackles and equipments and maintain the same to carry out the job under the contract at his cost.
- 15. Contractor shall provide safety appliances and maintain the same at his own cost which may be required under the statute or otherwise.
- 16. During the work if any damage occurred to BHEL property, the Contractor would restore it to the original condition or the cost will be recovered from the Contractor including administrative charges.
