3. The vehicle(s) may be required to go outside Jhansi. Permit charges/Toll tax of other States shall be reimbursed against documentary proof.
4. Driver should have valid driving license for light Motor vehicles. Driver without license shall not be permitted.
5. The Vehicle will have to be properly maintained as per RTO norms, dust proof and in good running condition, which includes at least the following:
 - i.Upholstery in good condition including washed and ironed white seat covers;

 - iii.BHEL may inspect the vehicle for above parameters and reserves the right to call replacement, if the vehicle is not found satisfying the above conditions, LD/Penalty shall be levied as mentioned on price bid.
