## SPECIAL CONDITIONS OF CONTRACT FOR WORK

1. Location of Site – BHEL Jhansi Township The contractor is advised to visit the site and meet the officials of TCX department for any clarifications before quoting their rates for the work.
2. Time allowed for completion of work – 3 months
3. Defect Liability period – nil
4. Payment Terms – Measurement of completed work to be done monthly and bill to submitted by Contractor to department by 8<sup>th</sup> of next month. Payment will be done as per GTC Clause (X) (6).
5. Penalty for delayed work –
  - Milestone 1- 1<sup>st</sup> month end- 40% of Total area.  
Milestone 2-2<sup>nd</sup> Month end – balance 40% of Total area.  
Milestone 3- 3<sup>rd</sup> Month end- balance 20% of Total area
  - If contractor fails to ensure above condition, the penalty will be imposed on contractor as per GTC clause no.(X)-4
6. PVC & ORC - Not applicable
7. Taxes & Duties - The contractor shall submit their offer inclusive of all duties, royalty, entry tax etc except GST. If GST is applicable for the work, the contractor shall claim GST extra as per actual over the quoted price of the work. However the contractor must make payment of GST before claiming the same from BHEL
8. **Award of work** –The work will be awarded to overall lowest bidder who has submitted the lowest total price for the work
9. **The contractor shall obtain registration from Zila Panchayat registration certificate for every financial year for which the contract is in effect and successful tenderer will submit to department within 15 days of award of work.**
10. Work Inspection shall be done by BHEL representative and payment shall be made on the basis of measurement only as per unit given in schedule. The contractor or his supervisor /authorized person will maintain a register and record the work / measurement immediately and get verified the satisfactory completion of work by BHEL personnel.
11. The contractor will be fully responsible for the preparation of bill and submission **to Engineer-in-charge.**
12. *The measurements of completed works and preparation of bill's related procedure will be govern by as per CPWD norms and guidelines. Contractor will comply with all CPWD's Norms, specifications, and guidelines related to work execution and billing.*
13. Final bill shall be prepared within 3 months after successful completion of work in the Performa prescribed for the purpose, based on the certificate issued by the Engineer that the entire work as stipulated in the tender Specifications has been completed in all respect to the entire satisfaction of BHEL. The Contractor shall give unqualified 'No claim' and 'no demand' certificate. The abstract of final quantities and financial values



shall also be entered in the measurement book and signed by both the parties. The final bill shall be paid within a reasonable time after completion of the work. After the payment of final bill, only the guarantee obligation percentage value (Security deposit) shall remain unpaid, which will be released after completion of defect liability period on submission of no-dues certificate.

**NOTE: - Normally it takes approximately 60 days for the payments to be released by BHEL after recording the measurements.**

14. The BHEL General Conditions of contract shall form an integral part of this contract. (The BHEL General condition of contract may be seen in civil Office).
15. The Special Conditions of Contract (SCC) shall have overriding priority over General Conditions of Contract (GCC). Whenever there is any contradiction between the GCC and SCC, the SCC shall be treated as final.
16. The contractor shall take necessary precautions for the safety of his workmen and provide them with all safety equipment like gloves, gum-boots etc as per requirement. BHEL shall not be liable to pay any additional amount on account of any safety equipment / PPE.
17. The contractor shall take proper care to avoid any damage to BHEL property. If any damage does take place, the contractor will be fully responsible for the same. The decision of Engineer in charge in such case shall be final and binding on contractor.
18. The contractor will follow all safety rules required in connection with execution of such type of works.
19. The contractor will provide the all safety equipment i.e. safety shoes, safety belt, goggle and all other equipment which are direct related to work execution at own his cost.
20. The workers should be trained enough for the work.
21. No minor worker will be allowed to work.
22. The contractor shall be wholly responsible for the behavior of his workmen with the official staff.
23. All tools & tackles, ladder & machinery required for the work execution shall be arranged by contractor on his cost.
24. The contractor will be fully responsible to follow the instruction related to works, given and recorded by department in "Site order Book" and will be signature by him daily against recorded instructions in "Site Order Book" at department.
25. Electric power at site will be provided free of cost for concrete work and lighting by BHEL at the written request of the contractor at one point subject to the observance of rules and regulations of Electric board / company free of cost. If it is observed that power is being wasted, BHEL shall have the right to recover cost of such consumption including arrears. Power will **not** be allowed for **cooking and room (air) heating** in winter season: For this purpose, on written application chargeable power can be allowed. The rates shall be the rates applicable for industrial consumption in U.P.
