SL.NO.	DESCRIPTION
1.0	Financial Criteria:
A.	Average annual financial turnover of bidder, during the last three financial years (ending on 31-03-2019 or latest closing date of financial year) should not be less than Rs. 0.6 lakhs (or) equivalent in foreign currency. The bidder has to submit audited financial accounts for last three years in support of meeting the above criteria.
B.	In case audited financial statements are not available for latest financial year, then the applicable audited statements of preceding three financial years shall be considered.
C.	Other income shall not be considered for arriving at annual financial turnover/sales.
D.	Bidder has to submit copies GSTIN registration, PAN card, Income tax returns etc as applicable.
E.	In case of foreign bidders, in addition to documents in support of above (as applicable), they shall also provide business information report / credit rating report incorporating the rating of the company by international credit rating agencies viz Dun & Bradstreet etc. along with technical offer. Such ratings reports shall not be older than 1 year from the date of submission of offer. Agency agreement needs to be submitted by foreign bidder in case of associating with an Indian entity.
2.0	TECHNICAL CRITERIA : Only manufacturers of NACE certified Gate Valves (documentary evidence to be provided), qualified as per the Pre-qualification criteria laid down below, are allowed to bid. Authorised Dealers, Agents, Stockists and Traders are not allowed to bid. The bid evaluation shall be on Overall L1 basis. Bidder has to quote for all the items. Partial offers will not be considered for evaluation. Qualification Criteria of the Bidder: The Bidders shall meet the Pre-Qualification Criteria (listed below). Non-compliance to any of the criteria listed below will lead to disqualification of bidder for the subject tender. The bidder should be an established Manufacturer of NACE certified Gate Valves and should have successfully completed Manufacture, Testing and Supply of NACE certified Gate Valves, according to the design/manufacturing standard MR0103, API-602 & API-598. The Bidder should have successfully completed supply of NACE certified Gate Valves (according to the requirements of BHEL Specification PY52239) of any size of cumulative quantity not less 26 no.s through a single Purchase Order or multiple Purchase Orders in the last 5 years ending on original due date of this tender, with at least one order executed after 01.01.2018. Detailed BOQ of the NACE certified Gate Valves supplied, satisfying the criteria laid down above, shall be provided in the format enclosed as Annexure-1, with details like Project & Customer, Description & Quantity of Items supplied, PO details etc. as a minimum for assessing pre-qualification. PO Copies, Inspection Reports and Dispatch documents shall be enclosed for the references provided. a. The bidder should not have been under suspension for business / blacklisted by any of the BHEL units.
3.0	GENERAL REQUIREMENTS:
A.	Bidder shall submit requisite documents, to comply with aforesaid criteria, properly indexed, along with offer.
