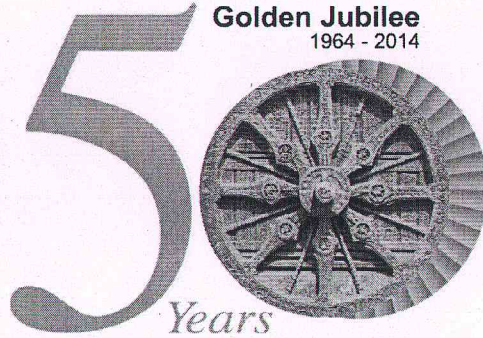

- The work in all respect must be completed within 05 days of receiving of order.
- No inferior quality of material/work would be accepted.
- L.D. for delay in completion of work:** Extension of time for completion of work may be granted by BHEL where delay is not attributable to the contractor. In case of the work is not completed within the scheduled date of completion, a penalty of ½% per week of delay subjected to maximum of 10% of order value will be deducted as L.D.
- L.D. for bad quality of work:** if the quality of work is not satisfactory the L.D. of up to 10% of work order value may be imposed. The total LD for delay as well as for quality is to be considered in TOTO i.e. Total LD shall be 20% of the Work Order value.
- The work of gas charging will remain under warranty for a period of 90 days and the warranty for the parts replaced shall be for 30 days. You shall charge the gas in the ACs in case of any leakage within a period of 90 days and shall replace the defective parts (replaced by you) within 30 days from the date of actual work done, with no extra cost to BHEL.
- Payment:** The payment shall be made for the actual work done/spares replaced. 100% payment would be made within 15 days' time of work completion and submission of indiscrepant bills to our office.
