10	Booth structures and blower cleaning Cleaning of paint deposited on blower Impellers booth structures. SCOPE OF WORK: 1.All the filters have to be removed from the paint booth. 2.Paint deposited on the booth wall (rear side) to be scrubbed out properly. 3.Impellers of two no are to be thoroughly cleaned. If required impellers are to be dismantled from the motor assembly separately to ensure proper cleaning. 4.Scuff holdings has to be prepared for safe dismantling of the blower impeller. 5.After cleaning of fan blowers and paint booth wall, filters are to be assembled back in position. 6.After completion of work area to be cleaned with kerosene. 7.The dismantling and assembling of blower assembly and filters should be done safely. GENERAL TERMS AND CONDITIONS FOR M&S MECHANICAL CONTRACTS

- 1) The workmen of contractor should be covered under PF/ESI, etc as per labor laws.
- 2) Safety precautions have to be ensured by the Contractor Depending on the work nature. Necessary work permit system and personal protective equipment's (PPE) such as electrical resistance rubber gloves, helmet, spectacle goggles, safety shoes, safety belt etc. as applicable to Mechanical works should be adhered while carrying out the work.
- 3) PPES for appropriate trade job has to be ensured by the contractor at the job site at all times.
- 4) The contractors may visit the area to assess the quantum of work before quoting.
- 5) The contractor should mention the point to point confirmation.
- 6) Contractor should commit for Terms and Conditions of the enquiry otherwise the offer shall be liable for rejection.
- 7) **SINGLE PART BID SYSTEM:** Contractor should send their offer for single part bid system as below

GST:

1. Response to Tenders for Contractor will be entertained only if the vendor has a valid GST registration no which should be clearly mentioned in the offer. If any specific exemption is available, a declaration with due supporting documents need to be furnished for considering the offer.
2. Contractor shall mention their GSTN registration number in all their invoices and invoices shall be in the format as specified/prescribed under GST laws. Invoices shall necessarily contain Invoice number (in case of multiple numbering system is being followed for billing like SAP invoice no, commercial invoice no etc., then the Invoice No which is linked/uploaded in GSTN network shall be clearly indicated), item description as per PO, Quantity, Rate, Value, applicable taxes with nomenclature (like IGST, SGST, CGST & UTGST) separately, HSN/ SAC Code, etc.
