## SPECIAL CONDITIONS OF CONTRACT FOR WORK (SCC)

1. Contractor will ensure the model of tractor (with Hydraulic Trolley) which should not be less than 40 B.H.P & not older than year 2014 and minimum capacity of 4.5 m<sup>3</sup> Hydraulic Trolley.
2. Contractor will deployed 1 skilled Tractor operator and submit his Xerox copy of valid driving license along with original (only for checking & verification) to the TCX Department with Min. 2 labour for work execution.
3. The work will be carried out as per Direction of Engineer-in- Charge.
4. Contractor will submit the Xerox copy of tractor registration & insurance paper along with original registration & insurance paper (only for checking & verification) before commencement of work.
5. Contractor will ensure that the garbage filled trolley will be covered by polyethylene sheet or trampoline sheet to ensure adequate hygiene of township otherwise flat recovery may be made from contractor bill as below-
6. Recovery amount = Total trip (work Executed without above said condition sl 20.5) x contractor quoted rates x 10%.
7. The contractor will be fully responsible to execute the work according to schedule of tender and as per satisfaction of Engineer –in– charge.
8. If Contractor fails to execute the work daily according to Schedule of tender & as per scope of work or not executed the work during the BHEL working day, the adequate Recovery may be made from contractor's bill as below-
9. Recovery amount = 2x(5 x Nos. of days (work not executed) x Contractors quoted rates.)
10. Each and every trip of work (fully filled trolley from garbage) will be checked in Township Civil office by Asst. Engineer or appropriate civil official and contractor will ensure and maintain a log book in specific format as below and get it verified from Engineer in-charge daily.

11. In case of defective work such as loose filled garbage in trolley and any other case BHEL have full right to reduce the rates / amount of such items proportionately as decided by BHEL and contractor shall have no right to claims over such type of defective work.
12. All type of wear & Tear operation cost including fuel, maintenance of tractor – trolley and required Tools & Plants etc. Will be arranged by contractor.
13. In view of scope of work and their sensitivity, contractor shall have no right to
14. any type of extra claim on above conditions.
15. In-case of emergency i.e. dispose of dead animals, any other hygiene activities as per departmental instructions, contractor will take immediate action to short out the emergency work other than Schedule
16. Contractor will submit the photocopy of log book along with their raised bill for the respective period.
17. The contractor will be fully responsible to follow the instruction related to works, given & recorded by department in "Site order Book" and will be signature by him daily against recorded instructions in "Site Order Book" at department.
18. In-case of under capacity of trolley the proportional amount will be reduce from the contractor's bill as below-

19. Reduce Amount = contractor quoted rates - (Nos. of trips x Volume of trolley x contractor quoted rates / 4.5)
20. Contractor will be fully responsible for the preparation of bills and submission to Engineer-in-charge.
21. Location of Site – BHEL Jhansi Township. The contractor is advised to visit the site and meet the officials of TCX department for any clarifications before quoting their rates for the work.
22. Time allowed for completion of work – 7 months.
23. Defect Liability period –Nil.
24. Payment Terms – Measurement of completed work to be done monthly and bill to submitted by Contractor to department by 8th of next month. Payment will be done as per GTC Clause (X) (6).
25. Penalty for delayed work – As the work is of regular garbage collection on daily basis, every “Scheduled Day “will be a milestone.
26. The contractor will have to complete work at any site/ building given to them as per schedule “A” (C/05).
27. If contractor fails to ensure above condition, the penalty will be imposed on contractor as below-
28. Penalty amount =2 x ( 5 x No. of days of work not executed as per schedule x Contractor quoted rates)
29. PVC & ORC - Not applicable
30. Taxes & Duties - The contractor shall submit their offer inclusive of all duties, royalty, entry tax etc except GST. If GST is applicable for the work, the contractor shall claim GST extra as per actual over the quoted price of the work. However the contractor must make payment of GST before claiming the same from BHEL
31. Award of work – The bidder must quote the total package price for the work and the work will be awarded to overall lowest bidder who has submitted the lowest total price for the work.
32. **The contractor shall obtain registration from Zila Panchayat registration certificate for every financial year for which the contract is in effect and successful tenderer will submit to department within 15 days of award of work.**
33. Work Inspection shall be done by BHEL representative and payment shall be made on the basis of measurement only as per unit given in schedule. The contractor or his supervisor /authorized person will maintain a register and record the work / measurement immediately and get verified the satisfactory completion of work by BHEL personnel.
34. **The contractor will be fully responsible for the preparation of bill and submission to Engineer-in-charge.**
35. *The measurements of completed works and preparation of bill's related procedure will be govern by as per CPWD norms and guidelines. Contractor will comply with all CPWD's Norms, specifications, and guidelines related to work execution and billing.*
36. Final bill shall be prepared within 3 months after successful completion of work in the Performa prescribed for the purpose, based on the certificate issued by the Engineer that the entire work as stipulated in the tender Specifications has been completed in all respect to the entire satisfaction of BHEL. The Contractor shall give unqualified 'No claim' and 'no demand' certificate. The abstract of final quantities and financial values shall also be entered in the measurement book and signed by both the parties. The final bill shall be paid within a reasonable time after completion of the work. After the payment of final bill, only the guarantee obligation percentage value (Security deposit) shall remain unpaid, which will be released after completion of defect liability period on submission of no-dues certificate.
