1.2) If all balance sheets are not available for all three years than the average shall be calculated by dividing the sum of turnover of submitted balance sheets by three.

2. Experience of having successfully completed similar work (**means rewinding of Motors**) during last 7 years ending last day of month previous to the one in which applications are invited should be either of the following: -

- Three similar completed works contracts each costing not less than the amount equal to Rs.0.14 Lakh.
Or
- Two similar completed works each costing not less than the amount equal to Rs. 0.18 Lakh.
Or
- One similar completed work costing not less than the amount equal to Rs. 0.29 Lakh
