- 2. The vendors shall prepare Part-A and Part-B in two different sealed envelopes duly super-scribing Enquiry No. and Part No. of the bid. These two parts of the bid shall be kept together in a third envelope super-scribing Enquiry No., due date and time of opening as indicated in the tender enquiry. This envelope containing Part-A & Part-B shall be submitted to BHEL.
- 3. Part-A of the bid alone shall be opened on the due date in presence of the bidders in the first instance. This part of the bid shall be examined in detail. Part B of the bid shall be opened only for such of the bidders whose Techno-Commercial offers are found acceptable by BHEL. Such bidders shall be advised the date and time of opening of Part B i.e. price part of their bids / alternatively if BHEL decides to go for Reverse Auction, only those vendors whose techno commercial bids are found acceptable and have accepted to participate in Reverse Auction will be allowed to take part in Reverse Auction. - The scope of work covered in this enquiry is fabrication of Dry Type Transformer Enclosure as per BHEL Drawings: 44731550201 (This is only for reference, separate required drawing will be send with their purchase order) on fully finish basis using own material in all respects. The Dry Type Transformer Enclosure Assembly shall be supplied in duly shot blasted & painted condition. The Dry Type Transformer Enclosure Assembly shall be inspected leading. BHEL / Third party / Customer as per requirement.
- 1.2 All material, consumables, facilities shall be arranged by the supplier. Paint film thickness test and any other test called in BHEL Drg. shall be carried out by vendor. Hardware's, temporary fixtures, blanking plates, C- clamps, helical inserts, gaskets etc. shall not be supplied by BHEL.

Pre-machining of the items / components as per drawing is in supplier's scope.

- Supplier should ensure that the supplies are as per latest Drawings, DCAs, MIDs, QA Plans and other documents. The supplier should also ensure that latest revisions of these documents are collected by them from BHEL from time to time. They should obtain necessary certification about the latest revisions of drawings from our TRE / TRP/CMM division before commencing the work and also just before dispatch. Efforts will be made to supply all possible documents by BHEL along with purchase order or in sequence from after issue of LOI / PO.

COMMERCIAL TERMS & CONDITIONS

- 1. The rate contract shall be valid for ordering for <u>Two year</u> from the date of finalization and Supply up to 3 months thereafter.
- 2. The following Price Variation Claim shall be allowed over the quoted basic fabrication Rate quoted in schedule –VI based on schedule X.
 - a) For every 1 Rupee per Kg increase / decrease in JPC (Joint Plant Committee, Constituted by Govt. of India) price excluding GST of H. R. Coils 2 MM (HRC Steel Sheet) for Delhi, the basic fabrication rate will increase / decrease by Rs 1.20 per kg.
 - b) The basic fabrication rate quoted in Schedule VI shall be based on the JPC steel retail price of Rs 44.38 per kg (excluding GST) for H. R. Coils 2 MM (HRC Steel Sheet) derived from the price declared in beginning OCT-2020 for Delhi. For detail calculation to derive JPC steel retail price excluding GST, refer Schedule –X.
 - c) JPC declares steel prices bi-monthly including GST. JPC retail price declared in beginning of the month for Delhi shall be considered for one full month for the purpose of calculating PVC. BHEL will derive the JPC retail price excluding GST as per calculation placed at Schedule X and the same shall be considered for full one month for calculating PVC.
 - d) JPC steel retail basic rate excluding GST of Delhi (derived from the declared price in beginning of the month by JPC for Delhi) as applicable one month prior to contractual delivery or actual delivery whichever is lower, will be taken for the purpose of calculating price variation. For example, if material is supplied in the month of DEC-2021 & PO delivery is NOV- 2021, rate applicable for the month of NOV-2021 or OCT -2021 respectively whichever is lower shall be taken for PVC Claim.
- 3. The rates quoted shall be on FOR BHEL Jhansi basis on per Kg basis only on fully finish basis including one coat (50 micron) Zinc rich primer & with Neoprene gasket only without final painting. Extra painting charge will be paid as per specification JS0674198 Rev-03 & JS 0674199 Rev-03 as per BHEL requirement. Freight & insurance from suppliers' works to BHEL Jhansi works shall be in the scope of the bidder.
- 4. Range of weight for finish Enclosure Assy. is 200 kg to 2000 kg. Area 2.00 square meter to 8.00 square meter per Enclosure Assy.
- 5. Perforated steel sheet shall be 2.00 mm thick and perforated hole sheet diameter may vary from 2.0 to 10.00mm. Enclosure are required with perforated round hole or with louvers & S.S. wire mesh.

- 10. Payment Terms: 100% payment after 90 days of receipt and acceptance of material at BHEL works. The suppliers who are availing HDFC / SIDBI bill discounting facility (pay by BHEL in about 90th days from the date of invoice) with us will continue to get this facility. However, due to funds problems, this cannot be extended to other suppliers. For such suppliers standard payment terms shall be applicable for deciding tender. The bidders who are covered under MSMED Act- 2006 & quoted 45 days of payment after acceptance of material will also be treated as standard terms of payment. Note: The quantity distribution under rate contract shall be generally as per quantities allocated to the bidder, but limited to the capacity quoted by the bidder. The loading will also be subject to factors like (a) customer approval of vendors in specific projects, (b) facilities at Supplier works, (c) Suppliers delivery and quality performance during execution of rate contract, (d) Pendency of orders on the supplier and (e) responsiveness in addressing post order completion issues at BHEL. In case of new potential suppliers who are techno commercially acceptable in the tender, the loading shall be gradual to establish their performance in terms of quality and delivery. Once proven, they shall be allotted their quantity requirement accordingly. In view of above factors the loading during execution of rate contract may vary with respect to allocated quantity.

- 12. Purchase Order Acknowledgement must reach the concerned Officer of MM Deptt., BHEL, Jhansi within 2 weeks of issue of PO. Failure to do so within stipulated period will be deemed to mean that the order has been accepted by the supplier.
- 13. <u>GUARANTEE</u>:-All goods shall be free from any defects due to faulty material and workmanship and it will be guaranteed for a period of 18 months from the date of commissioning of the goods at customer's site or 24 months from the date of dispatch whichever is earlier. However, for any "LATENT DEFECTS" supplier will be responsible even after 24 months, if failure occurs due to the same.

14. REJECTION:-

- (i)-If any goods are rejected, BHEL shall be at liberty to take action as per following at the risk and cost of supplier:-
 - (a)-Allow the supplier, wherever mutually agreed, to rectify the rejected goods at BHEL's works within reasonable time as fixed by BHEL.
 - (b)-Allow the supplier to make free replacement within a specified period, rejected goods can be lifted by the supplier thereafter.

Allow the supplier to refund the full amount paid to him by BHEL by a Demand Draft before lifting the rejected goods. Fresh replacement shall be regularized as per terms & conditions of the original purchase order.

OR

Take alternative procurement action from elsewhere and recover the difference in cost, if any incurred by BHEL in this regard from the supplier. The supplier shall not be entitled to any gain on purchase.

(c)-Terminate the contract either in part or in whole at the discretion of BHEL and recover the loss, if any, from the supplier.

(ii)

- (a)- If manufacturing defect is noticed in Dry Type Transformer EnclosurAssy. at the time of use in BHEL. BHEL shall Intimate to vendor by email.
- (b)- Vendor shall depute their team for rectification within 02 days of intimation (excluding date of intimation).
- (c)- BHEL shall at its discretion and on advise of its quality department deduct Rs. 250 per day for the period taken by vender's team for rectification at BHEL (this period shall exclude 02 days as mentioned at (b) above). This deduction is solely for the delay incurred in progress of work in BHEL on account of defect / rectification Dry Type Transformer Enclosure Assy. (defect attributed to vendor).

b. All claims for injury or damage caused by the supplier's negligence or the negligence of supplier's employees or arising from any defect in the goods supplied or on the work carried out by the supplier.

All claims for injury to the supplier's employees or agents employees whilst on BHEL's premises.

16. LD/PENALTY:-If the material is not supplied within stipulated time, BHEL shall be within their right free to cancel the contract and purchase the material through any other source at the risk and cost of the supplier. 

When proxy bid amount is reached, the bidder (who has submitted the proxy bid) has an option to start participating in the bidding process.



- If any claim is made / lodged during this time, the same shall be binding and continue to be valid 9.2 despite the lapse of this pact as specified as above, unless it is discharged/ determined by the CMD, BHEL.

Section 10 - Other Provisions

- 10.1 This agreement is subject to Indian Laws and jurisdiction shall be registered office of the Principal, i.e. New Delhi.
- 10.2 Changes and supplements as well as termination notices need to be made in writing. Side agreements have not been made.
- 10.3 If the Contractor is a partnership or a consortium, this agreement must be signed by all partners or
- consortium members.
- 10.4 Should one or several provisions of this agreement turn out to be invalid, the remainder of this agreement remains valid. In this case, the parties will strive to come to an agreement to their original intentions.
- 10.5 Only those bidders / contractors who have entered into this agreement with the Principal would be competent to participate in the bidding. In other words, entering into this agreement would be a preliminary qualification.
