

## **IMPORTANT TERMS FOR PRICE BID & RATE BASIS:**

- 1. There is requirement of total three no. 40 feet trailers and 2 no. 70 feet trailers for working in different areas as described in tender.
- 2. Vendor has to quote the rate per day per vehicle in above format for either one or both schedules as per their choice.
- 3. Vendor can supply one or two or three nos. 40 feet trailer and one or two nos. 70 feet trailer.
- 4. L1 will be decided based on the evaluation of offers for each rate schedule individually.
- 5. If L1 can't supply three no. of 40 feet trailers and 2 nos. of 70 feet trailers, then L2 will be counter offered to supply the balance no. of the trailer at the rate of L1 and if L2 also does not fulfil the requirement or does not accept L1 rate then L3 shall be counter offered the rate of L1 and so on.
- 6. Rate is to be quoted per day per trailer (for only one trailer) in the above format.
- 7. Refer conditions for contract finalization of techno-commercial bid (Part-I).

- 8. The quoted rate should be excluding GST and inclusive of any taxes and duties levied or to be levied both by Central and State Government authorities from time to time. Such levies should be borne by the Contractor. GST will be paid extra on submission of documentary evidence.

- 10. Evaluation of the offer shall be done on the basis of delivered cost (i.e. "Total Cost to BHEL").
- 11. The quoted rate will be inclusive of the charges for the Vehicle along with One Driver and One Helper, fuel, lubricants, tool, spares and personal protective equipment's, PF, ESI, Bonus etc., covering all statutory requirements.
