SCOPE OF WORK:

WORK SPECIFICATION:

Hiring of 12 MT Pick & Carry Crane with one Operator

A 12 MT Pick & Carry Crane (with operator) is required for Loading / Unloading of material likes loose accessories, Oil drums, HVR, Instrument transformers, N₂ Fire extinguisher, Electronic Controllers, Radiators etc. where EOT crane is not available inside the factory area. If required, the service of crane may be used outside the factory also (within 5 Km).

Specification of 12 MT Pick & Carry Crane (with operator) required is as follows-

Max Capacity of Crane - 12 MT

At least 36 feet long Expandable Boom (minimum 1.5 MT capacity at the farthest end)

1. Shift duration - 10 Hrs (9 AM to 7 PM including 1 hr. lunch break)
2. The payment for extra time / Sundays / holidays shall be paid on pro-rata basis.
3. Diesel shall be provided by BHEL free of cost.
4. The crane shall remain in the BHEL premises for the entire Contract period. It may be allowed to go outside for major maintenance work which cannot be done inside.
5. Maintenance of the crane shall be in the scope of the contractor.
6. Log book to record daily work, to be maintained by the contractor.
7. **LD/Penalty:** The party (i.e. Contractor) has to provide 12 MT pick & carry Crane along with one operator for 10 hrs. (From 9 AM to 7 PM, 1 hr. lunch break) in all working days. Due to contingency, the contractor should have a stand by operator so that there shall not be any break in crane operation. In the event of break in operation due to non-availability of operator or breakdown in crane, LD @ 2 % per week or part there off subject to maximum 10 % of bill of that month will be deducted from the running bills of contractor. This will be based on the certification /approval of CDC department not below the rank of Sr. Manager (CDC).
8. **Taxes and Duties:** GST shall be applicable @18% of the Total contract value. In case of credit is not available as denied by GST portal due to improper documentation **OR** wrong uploading of data by bidder, the same will be recovered from the bidder along with interest, if any.

1. Bidder must have a 12 MT Pick & Carry Crane (with at least 36 feet long expandable boom and minimum 1.5 MT capacity at the farthest end). Crane should be registered in name of bidder or leased or hired by bidder. Documentary proof of ownership/leased/hired agreement is to be enclosed along with techno-commercial bid.
2. Crane should not be older than 10 years as on date of opening of tender from the date of first registration. Valid RTO Registration certificate and fitness certificate is to be enclosed along with techno-commercial bid.
3. Bidder should have Copy of Comprehensive Insurance & valid pollution certificate of Crane.
4. Bidder should have valid crane operating license of Crane operator.
5. **FINANCIAL STRENGTH & EXPERIENCE:**

i) **Turnover** - Average Annual financial turnover during the last 3 years, ending 31st March 2018 should be at least **Rs 1.73 Lakhs**.

Duly Audited Financial statement certified by CA **OR** CA certificate of last 03 years is to be submitted as a supporting document. If turnover details of all three years are not available then average shall be calculated by dividing the available year's turnover by 3.

ii) **Experience** of having successfully completed works contract (Crane hiring) during last 7 years ending on 30.04.2019 should be either of the following:-

- a. Three similar completed works each costing not less than **Rs. 2.31 Lakhs**.
Or
- b. Two similar completed works each costing not less than **Rs. 2.89 Lakhs**.
Or
- c. One similar completed work, each costing not less than **Rs. 4.62 Lakhs**.

***For Experience in Govt. /Public Sector:**

Documentary proof (Copy of WO/PO/LOI & work completion certificate) in support of above eligibility criteria shall be submitted along with techno-commercial bid.

***For Experience in Private Sector**

Documentary proof (Copy of WO/PO/LOI, work completion certificate & TDS certificate/ Form 16A-Traces) in support of above eligibility criteria shall be submitted along with techno-commercial bid.
