

- 2. Tenderer must quote for all category of work (Sl. No. 1 to 4). Partial offer will be rejected.
- 3. The quoted rate should be **excluding GST**, and **inclusive of any taxes and duties levied**, **or to be levied**, both by Central, and State Government authorities from time to time. Such levies should be borne by the Contractor. GST will be paid extra on submission of documentary evidence.
- 4. The quoted rate shall be firm throughout the currency of the contract.
- 5. **CLARIFICATION REGARDING GST:** In case any changes in taxes and duties as per Govt. Notification (including GST), the same shall be applicable from time to time.
- 6. Bid should be free from correction, overwriting, using corrective fluid, etc. Any interlineation, cutting, erasure, or overwriting shall be valid only if they are attested under full signature(s) of person(s) signing the bid, else bid shall be liable for rejection.
