2. SCOPE OF WORK

- (1) Party have to carry out 04 Nos. quarterly visits during total contract period, including:
 - 1.1 Visual Check of all cranes.
 - 1.2 Suggest remedial actions to be taken up to minor repairs from becoming major and expensive repairs.
 - 1.3 Complete electrical inspection of each machines.
 - 1.4 Checking and carry out all necessary field adjustments as recommended.
 - 1.5 Servicing of each cranes as required and indicated in the crane log book or recommended by Engineer In-charge.
 - 1.6 Detailed service reports of each visited crane shall be furnished by service engineer duly verified by BHEL-Engineer In-charge.
 - 1.7 Normal tools shall be provided by BHEL during the visit however special tools like pressure kit, SLI calibration kit etc shall be carry-out by TIL service engineer as and when requirement basis.
- (2) Manpower and visit schedule:

Party have to deploy expert service engineer for the AMC visit at BHEL. There shall be 04 quarterly visits of minimum 03 days and 08 hours per day.

In case of breakdown TIL shall depute engineer within 03 days from the receipt of complaint over phone or mail.
- (3) Location of Cranes: All cranes are working in BHEL-Factory
